DOJ files charges vs. online child sellers in Cavite

MANILA-The Department of Justice (DOJ) on Monday said it has filed qualified trafficking and child exploitation charges against members of a criminal syndicate selling babies online.

In its five-page resolution, the DOJ Task Force on Women and Children and

Against Trafficking in Persons said the charges were filed against Arjay Malabanan and Ma. Chariza Dizon before the Manila Regional Trial Court.

LTO issues show cause order vs. car owner in fatal road rage

MANILA – The Land Transportation Office (LTO) has issued a show cause order against the registered owner of the black Mercedes-Benz involved in a road rage in Makati City that resulted in the shooting and killing of a 65-year-old motorist on Tuesday.

It requested the car owner from Las Piñas City to appear before the LTO-National Capital Region office with a notarized affidavit explaining the incident.

"Malakas ang koordinasyon ng invong LTO at ng PNP [Philippine National Police | especially sa mga ganitong uri ng krimen. Upon the request ng PNP ay tumulong po tayo sa isinasagawang imbestigasyon ng (The LTO and the PNP has strong coordination especially in crimes like this. Upon the PNP's request, we help on the investigation conducted but the) PNP and on our part, we issued an SCO against the registered owner," LTO chief, Assistant Secretary Vigor Mendoza II said in a statement Wednesday.

Two violations were cited -- reckless driving and improper person to operate a motor vehicle.

The black Mercedes-

Benz will be placed under alarm pending investigation.

The PNP is investigating both cases separately.

According to a police report, the black Mercedes-Benz and a white Toyota Innova were travelling along the southbound lane of the Ayala Avenue-EDSA tunnel.

At around 2:30 p.m., the driver of the black Mercedes-Benz identified as Gerrard Yu, 34, and the family driver of the white Toyota Innova had a heated confrontation that escalated into violence.

The family driver, who was accompanied by a female passenger and a minor, was driving from Bonifacio Global City in Taguig when Yu allegedly fired a shot.

The victim managed to drive the vehicle to the side, despite being wounded, before losing control and crashing into two motorcycles.

PBBM: Killing a Filipino in WPS, 'very close to an act of war'

MANILA – The killing of a Filipino in the West Philippine Sea (WPS) amid escalating tensions would be very close to an "act of war," President Ferdinand R. Marcos Jr. said.

During the questionand-answer portion of the 21st International Institute for Strategic Studies (IISS) Shangri-La Dialogue in Singapore on Friday, Marcos said the Philippine government would act accordingly if tensions in the disputed waters and China's aggressive actions, such as the use of water cannons, result in the death of a Filipino citizen.

"What would happen if there was an incident that ended up killing a Filipino serviceman, be it a Coast Guard or in the military and part of the Navy. Well, that would be – that would certainly increase the level of response and if by a willful act on a Filipino, not only serviceman but even a Filipino citizen. If a Filipino citizen is killed by a willful act, that is I think a very, very close to what we define as an act of war and, therefore, we will respond accordingly," he said.

Lawmaker dares Guo to take DNA test with alleged mother

MANILA – Senator Sherwin Gatchalian on Friday urged Bamban, Tarlac Mayor Alice Guo to take a DNA test with Lin Wen Yi, her alleged biological mother, following information from the former's sources in Valenzuela City who have worked with the Guo family.

"Importante at dapat mag-DNA test silang dalawa para malaman natin ang totoo kung sila ay related o hindi. Dahil base sa mga

nakakausap ko dito sa Valenzuela dahil nagrenta sila ng warehouse dito, may mga nagtrabaho sa kanila. Yung iba doon ay nakausap ko, yung iba nagkwento at lumalabas ipinakilala na nanay niya si Lin Wen Yi (It is important and necessary for them to undergo a DNA test so that we will know the truth if they are related or not. Because according to the people I talked to here in Valenzuela, because they rented a warehouse here, people worked for them. The others said Lin

Wen Yi was introduced as her mother)," Gatchalian said in a radio interview.

The sources, he said, know Guo's mother as "Winnie" which can possibly be a nickname for "Wen Yi."

"Ang kanyang English name o Filipino name is Winnie kaya hindi din malayo to sa Wen Yi dahil yan naman ang ginagawa normally ng mga Chinese (Her English name or Filipino name is Winnie so it's not far from Wen Yi because that's what

DTI says more firms commit to price freeze for basic commodities

MANILA – More major manufacturers of basic necessities and prime commodities have committed to implementing a voluntary price freeze in support of Filipino consumers amid rising prices of goods and the ill effects of the El Niño phenomenon, the Department of Trade and Industry announced on Saturday.

In a statement, the DTI said several firms, including Monde Nissin, Alaska Milk Corporation, Nestlé, NutriAsia, Inc., and San Miguel Food, voluntarily issued price freeze orders

for Filipino businesses and consumers."

Among the confiscated brands were 2,428 units of RELX worth PHP534,190, and 158 units of Waka by RELX worth PHP35,440.

In March, the DTI suspended the sale and distribution of the vape brand Flava due to repeated violations of RA 11900.

Additionally, a joint operation with the Philippine National Police in April yielded PHP24.8 million worth of illegal Flava vapes from an establishment located

20 meters from an elementary school in Parañaque City.

The DTI pointed out that this is a clear violation of the law prohibiting the sale of vapes within 100 meters of areas frequented by minors.

Pascual said the DTI has been intensifying its monitoring and enforcement efforts through the creation of Task Force Kalasag, which aims to crack down on uncertified consumer products.

"With the launch of Task Force Kalasag this year, we are intensifying consumer protection efforts nationwide. This crackdown on violations of the Vape Law and fair-trade laws and regulations assures the public of the DTI's commitment to a safe and fair marketplace," he said.

Since the implementation of the Vape Law in 2022, the DTI has seized 67,010 vape units from various brands, amounting to PHP31,328,027.

The department urged the public to report any illegal sale, manufacturing, and distribution of illicit vape products through podrs.gov.ph and or via consumercare@dti.gov.ph. (PNA)

on specified stock-keeping units (SKUs) of canned meat, processed milk, and bottled water.

The number of participating manufacturers rose to eight, with the price freeze now covering a wider range of 31 SKUs.

"The DTI greatly appreciates the efforts of manufacturers to freeze their prices. This collaborative initiative is vital in ensuring that consumers, especially those in areas not under price control, have continued access to basic goods at affordable prices," Trade Secretary Alfredo Pascual said.

A d d i t i o n a l commitments cover SKUs across six product categories: processed milk, processed canned meat or beef, bottled water, instant noodles, condiments, and coffee.

Notable brands included in the freeze are: Lucky Me! Instant Mami, Liberty Condensada, Alaska Classic Sweetened Condensed Milk, Bear Brand Fortified Powdered Milk Drink, Nestle Carnation Condensada, Datu Puti Soy Sauce, Datu Puti Vinegar, San Mig Coffee 3-in-1 Original, Purefoods Chinese Style Luncheon Meat, and Star Corned Beef.

Prior to this initiative, automatic price freeze

mechanisms were already in effect in various provinces and municipalities severely impacted by El Niño.

An automatic price control freezes the prices of basic necessities for 60 days in areas placed under a state of calamity or emergency as stated in Republic Act No. 7581 or the Price Act, as amended.

Complementing government-mandated price freezes during calamities and emergencies, the DTI-led voluntary price freeze initiated by manufacturers to freeze prices of select basic necessities and prime commodities (BNPCs) under DTI's jurisdiction will last until 10 July 2024, unless otherwise specified in the price guide.

The trade chief urged other manufacturers to join the initiative and called for collective action to ensure that every Filipino can access affordable basic goods.

"While the DTI proactively enforces existing price freezes in calamity-stricken areas, we are actively expanding support for Filipino consumers nationwide. We encourage more manufacturers to join the initiative and contribute to mitigating the impact of rising prices on Filipino consumers," he said. (PNA)

Ukraine and has consistently supported Kyiv's sovereignty, independence, and territorial integrity.

The two leaders' meeting follows their participation in the Shangri-La Dialogue in Singapore, Asia's premier defense summit.

For his part, Marcos welcomed Zelenskyy, who is visiting Manila for the first time since being elected in 2019.

Bilateral relations between the two countries began in 1992.

Neither country has a resident ambassador, with Ukraine being represented in the Philippines by its nonresident ambassador in Kuala Lumpur, Malaysia, while Manila is represented by its embassy in Warsaw, Poland. (PNA)

DMW assures all-out support for 2 convicted OFWs on Brunei death row

MANILA – The Department of Migrant Workers (DMW) assured two overseas Filipino workers (OFWs) on death row in Brunei of the government's continuing support.

DMW Secretary Hans Leo Cacdac visited OFWs Edgar Puzon and Cyrile Tagapan at the Maraburong Prison Facility 1 in Keriam, Tutong District, Brunei Darussalam last Wednesday.

"I conveyed the message of the President to our two kababayans (compatriots) of his support and continuing prayers for them. Both expressed their deepest thanks to the President," he said in a statement.

Puzon was convicted for the murder of a fellow OFW in 2005, while Tagapan

have fourteen corporations, seven of which have Wen Yi as an incorporator. In family businesses, that's normal. Here in Valenzuela, almost all family businesses have that kind of setup)," he said.

Gatchalian, however, said the committee cannot force Guo and Wen Yi to undergo a DNA test.

But he said if the test came out negative, Guo can also justify her claim to be a "love child" of her father and his housekeeper.

Guo is being investigated by the Senate after being linked to a Philippine Offshore Gaming Operator raided for alleged human trafficking, and other illegal activities in Bamban, Tarlac. (PNA)

Marcos made the remark when asked what actions would trigger the Philippine government to invoke the decades-old Mutual Defense Treaty with the United States.

He noted that such incidents would increase the level of response not only from the Philippine government but also from its "treaty partners."

"We already have suffered injury, but thank God, we have not yet gotten to the point where any of our participants, civilian or otherwise, have been killed," the President said.

"But once we get to that point, that is certainly we would have crossed the Rubicon and certainly crossed the Rubicon. Is that a red line? Almost certainly it's going to be a red line."

PH boosting military capability for defense, peace

When asked about his vision for the force posture of the Philippines by the end of his term, Marcos said the Philippines would build its defense capabilities to protect its sovereignty and territory against any aggression from

another country.

Marcos said the country is in the process of finding suppliers for its modernization program called Horizon 3.

"We are hoping that these acts are just a deterrence to work for peace. It has been going on for many years now – this long-term plan of increasing the capabilities of our military and civilians, such as the Coast Guard in the Philippines," he said.

Marcos, however, emphasized in his keynote address that the country would continue to invest in diplomacy.

"The Philippines remains committed to the cause of peace, upon which our constitutional order is premised. We are committed to addressing and managing difficult issues through dialogue and through diplomacy," he said.

Marcos made history as the first Philippine leader to deliver a keynote address before the IISS Shangri-La Dialogue, the leading defense and security conference in the Asia-Pacific region.

In his speech, he

has been serving his sentence since 2016 for the murder of a Bruneian national, arson and theft. However, his sentence was commuted to life imprisonment.

Puzon has expressed hope to be granted early release as he turns 70 next year, according to Cacdac.

The DMW provided financial assistance to the agency's Agarang Kalinga at Saklolo para sa mga OFW na Nangangailangan, (AKSYON) Fund for legal expenses.

Lawyer Czar
Calabazaron, who
accompanied Cacdac, said
the pleas for clemency have
been filed before the Attorney

General's Chambers and the Privy Council of the Prime Minister's Office.

The DMW likewise helped fund Puzon's daughter's compassionate visit in February and assured to support future visits.

DMW is already facilitating a similar compassionate visit anytime this month for Tagapan's sister and two minor children.

At the same time, Cacdac has instructed the Migrant Workers Office and Overseas Workers Welfare Administration to continue assisting the two OFWs, including regular visits.

"This is the time when

they need us most, when we should be by their side," he added.

The DMW Secretary also expressed his gratitude to the Brunei Ministry of Foreign Affairs, Acting Director of Brunei Prisons, Prime Minister's Office, Deputy Permanent Secretary for Security and Welfare, and the Management of Maraburong Prison Facility for making his visit possible despite short notice.

Malabanan and Dizon, based on the information reported by the National Authority for Child Care regarding a "black market" in social media groups/communities where aspiring parents seek to illegally adopt children.

An entrapment operation conducted by the PNP-WCPC at the Immaculate Conception Church in Dasmariñas City, Cavite on May 15 yielded "Kuy's Jay," who later turned out to be Malabanan, offering to sell a newborn for PHP90,000 to undercover law enforcers.

local government.

Dizon, a resident of Tondo, Manila, is the mother of the rescued male 8-day-old.

"Evidence adduced sufficiently established the crime of qualified trafficking; respondents facilitated the adoption of the newborn baby; facilitation of the adoption was for a consideration of ninety thousand pesos (PHP90,000.00); purpose was to facilitate illegal adoption; the trafficked victim is a child; and the act of trafficking was committed by or through the use of ICT or any computer system, the transaction having been done through Facebook messenger platform," the DOJ

resolution stated.

"The act of respondents in selling the newborn child is an act of exploitation," it added.

In a statement, DOJ Secretary Jesus Crispin Remulla assured justice will be served.

"Children are the most precious treasures of society meant to be fully protected by law. They are the best investments of today for a better tomorrow. We will never allow anyone to exploit them in any way," Remulla said.

"Let us be the defenders of this vulnerable sector and innocents who desperately need us." (PNA)

reiterated that he will not give up a single inch of the nation's sovereign rights and jurisdiction over the WPS as it is the lifeblood of every Filipino.

"In this solid footing and through our clear moral ascendancy, we find the strength to do whatever it takes to protect our sovereign home – to the last square inch, to the last square millimeter. The life-giving waters of the West Philippine Sea flow in the blood of every Filipino," Marcos said.

"We cannot allow anyone to detach it from the totality of the maritime domain that renders our nation whole. As President, I have sworn to this solemn commitment from the very first day that I took office. I do not intend to yield. Filipinos do not yield."

The President also emphasized that any action in the South China Sea must conform to international-based order.

"Finally, any effort to resolve maritime differences in the East China Sea and the South China Sea must be anchored on international law, particularly UNCLOS, we must accord due regard to the legitimate interest of all parties, and respect legally-settled rights," he said.

Marcos was referring

to the 1982 United Nations Convention on the Law of the Sea (UNCLOS), or "The Law of the Sea Convention," which serves as the basis of the Philippines in the implementation of laws of the sea as far as the WPS is concerned.

The dialogue was attended by Singapore's officials, among them President Tharman Shanmugaratnam, Prime Minister Lawrence Wong, and Senior Minister Lee Hsien Loong; IISS Executive Chairman British Sir John Chipman; and government officials of the Philippines and other countries around the world. "TECHNOLOGIES that will confuse voters and even candidates will not be allowed.

The Commission on Elections (Comelec) is in a bind on the onslaught of technology and its effects on voting particularly without a law to regulate the online presence of those seeking public office.

While there are good and bad forms of artificial intelligence (AI), Comelec chairperson George Garcia said the focus now is stopping deep fakes. Deep fakes replicate an individual's image and even voice to make them talk and act based on programmed instructions or scripts.

He said that technologies that will confuse voters and even candidates will not be allowed. Comelec enters the labyrinth of new technology in implementing the ban since it cannot impose it without coordinating with global technology giants.

"If we are going to ban certain AI or deep fakes, social media platforms like Facebook and X must be fully aware that these forms of AI are prohibited under Philippine settings," the poll chief

"The Comelec will have to be proactive because the new technologies may pose danger to our democracy," according to Garcia. "We do not need to make representations and plead for a certain post to be taken down because it violated elections laws and it will take long before it is removed."

Garcia worried over a situation where the Comelec is regulating the elections but it will have to plead to the online platforms to remove irregular posts.

"Suppose there is a policy and a prohibition. In that case, we can say to the platforms, 'You have to implement these policies or we will go after you like what we did in the barangay and Sangguniang Kabataan elections when we talked to e-wallet operators if they are used for vote buying, then we will have to go after them," he explained.

In the Philippines, social media posts mostly fall under the freedom of expression guaranteed under the Constitution, tempered only by libel and similar laws. Unfortunately, social media's leap has made it necessary for the government to have a say.

"We regulate television, radio and newspapers during the campaigns, and media outfits would have to make a report to the Comelec," Garcia said.

In social media, however, we cannot impose limits. Even the expenditures of a candidate in social media are beyond the Comelec's control. The contents cannot be regulated. A law might be needed to regulate social media during the campaign period, which will cover only the candidates.

Garcia said the Comelec is issuing the ban on AI early on so that it can be challenged before the Supreme Court and have it resolved before the campaign period.

"I do not subscribe to the usual excuse of politicians that they are not responsible for most of the social media posts but what we wanted is that those whose face and name appear in the post should be made responsible."

"In the absence of a law regulating social media during the election period, all we can do right now is to require candidates to submit all their online sites," he explained. In such a scenario, Comelec then becomes powerless in the absence of a law because its hands are tied thus raising the question of how penalties can be imposed

In the law's absence, he said Comelec could require all social media posts of a candidate to be limited to the sites or addresses that will be submitted to the poll body. Then there's the question of social media influencers who are on the payroll of candidates beyond the reach of the Comelec.

"We are calling out to Congress, Comelec badly needs a law to regulate social media just to equalize everything. The situation is very inequitable to those who can't pay for their social media presence."

The problem of the Comelec on social media concerns the content and time that candidates can use because the platform is unregulated. AI will defy regulation since the technology will be hard to stop with whatever form of restrictions the government can think of.

The best step for Comelec is to turn to an intense education of the public on how to spot deceptive posts and not vote for candidates who benefit from these.

PAGASA declares onset of rainy season agencies to take precautionary

By Ma. Cristina Arayata

MANILA - The Philippine Geophysical Atmospheric, and Astronomical Services Administration (PAGASA) announced on Wednesday the start of rainy season.

"The occurrence of scattered rainshowers, frequent thunderstorms, the the public and concerned

passage of Typhoon Aghon, and the southwest monsoon (habagat) over the past few days have brought significant rains over the western sections of Luzon and Visayas signifies the start of the rainy season in the country," the weather bureau said in a new release.

PAGASA urged measures against the adverse impacts of the rainy season, habagat, and the impending La Niña. Risks include floods and rain-induced landslides.

"The high chance of La Niña conditions to develop by the July-August-September period increases the likelihood of above-normal rainfall conditions in some areas of the country, especially towards the end of the year," PAGASA Administrator Servando said.

Meanwhile, PAGASA monsoon breaks or reduced rainfall could extend over a few days or weeks.

2 flights cancelled

Meanwhile. two Philippine Airlines (PAL) flights bound for Japan were canceled as of 5 Wednesday due to p.m. "unfavorable weather condition at origin".

The Manila International Airport Authority said those flights are PR 432 bound for Narita, and PR 408 bound for

Nathaniel Kansai via the Ninoy Aquino International Airport.

> Typhoon Aghon is now outside the Philippine Responsibility, and was last tracked 1,225 kilometers east northeast of extreme Northern Luzon.

> Based on the weather bureau's 5 p.m. bulletin, Metro Manila is not included in areas that could experience rains and gusty winds caused by the southwesterly windflow partially influenced by Aghon.

> However, typhoon is forecast to head northeastward over the sea area south of Japan. (PNA)



Zelenskyy thanks Marcos for PH support in Ukraine's sovereignty

MANILA Ukrainian President Volodymyr Zelenskyy has thanked President Ferdinand Marcos Jr. for the Philippines' support and recognition of Ukraine's sovereignty as Kyiv continues to deal with the Russian invasion.

Zelenskyy conveyed his gratitude to Marcos during their meeting at the Malacañan Palace in Manila on Monday morning, particularly for the Philippines' role in the United Nations (UN) resolution condemning Russia's invasion of Ukraine.

"We are very thankful

to be in your country which supports Ukraine (and) our territorial integrity sovereignty," Zelenskyy told Marcos.

"Thank you so much of your big word, and clear position about us, about this Russian occupation of our territories, and thank you on your support on the, in (the United) Nations, with your resolutions," he added.

Ever since the war between Moscow and Kyiv broke out over two years ago, Manila has voted in favor of the six resolutions of the UN General Assembly Emergency Special Session on Continued on page 2...

PBBM: Brunei, **Singapore** trips to advance PH economic, P25-M worth of illegal vapes security agenda

MANILA President Ferdinand R. Marcos Jr. vowed on Saturday to build on the gains of his successful trips to Brunei Darussalam and Singapore to advance the country's economic and security agenda.

Marcos made the the Villamor Airbase in Pasay City at 3:58 a.m. on Saturday.

"My promise to all Filipinos, we will use every opportunity and continue to build bridges that will ensure a long-lasting peace and stability in our region," he said in his arrival speech.

President The embarked on his first state visit to the Sultanate state while he made history by being the first Philippine president to deliver a keynote message at the International Institute for Strategic Studies (IISS) Shangri-La Dialogue in Singapore.

In his two-day state visit to Brunei, Marcos said he met with His Majesty Sultan Haki Hassanal Bolkiah

Mu'izzaddin Waddaulah and discussed strengthening the 40-year-old bilateral ties between their countries.

"This year marks 40 years of diplomatic relations between our two countries and our conversation covered many facets of our relations, from defense and security, maritime cooperation, commitment after arriving at economic cooperation, and people-to-people exchanges," he said.

> The Philippines and Brunei forged three memoranda of understanding (MOUs) tourism on International cooperation, Convention on Standards of Training, Certification and Watchkeeping for Seafarers (STCW), and maritime cooperation.

seized Jan-May – DTI

MANILA – The government has confiscated more than PHP25 million worth of illegal vape products in the first five months of the year, the Department of Trade and Industry (DTI) reported on Saturday.

The DTI seized PHP25,874,175 worth of illegal vape products, surpassing the agency's total illegal vape seizure for the entire 2023, amounting to PHP5,453,852.

> Trade Secretary

Alfredo Pascual attributed these results to the department's heightened enforcement of Republic Act (RA) 11900, or the Vaporized Nicotine and Non-Nicotine Products Regulation Act, also known as the Vape Law.

majority The confiscated vape products violated Rule 6, Section 1(j), which strongly prohibits the sale of vape products that are packaged, labeled, presented, and marketed with flavor descriptors or cartoon characters that appeal to

"Nearly halfway through the year, significant rise in confiscated illegal vapes demonstrates our unwavering commitment to safeguard Filipino consumers, especially our youth. These showcase intensified efforts and we will not stop here," Pascual said in a statement.

"We will continue to pursue these illegal activities, working closely with other agencies and stakeholders. Our aim is nothing less than the complete eradication of the illegal vape trade, fostering healthier environment Continued on page 2...
