PBBM okays processing of NCR ecozone applications with PEZA clearance

MANILA – President Ferdinand R. Marcos Jr. has granted a second chance to applicants with "Pre-Qualification Clearances" from the Philippine Economic Zone Authority (PEZA) to create new economic zones in Metro Manila.

Marcos signed Administrative Order (AO) 11 on Nov. 24, amending AO 18 issued in 2019, which imposes a moratorium on the processing and evaluation of applications for the establishment of special economic zones in Metro Manila.

AO 18 issued by former president Rodrigo Duterte orders PEZA to no longer accept, process, or evaluate ap-

plications for the creation of Metro Manila ecozones "to promote rural development, ensure inclusive growth in the countryside, and create robust economic activity and wealth generation" in areas outside the country's metropolis.

Under AO 11, which was made public on Saturday, applications that have already obtained "Pre-Qualification Clearances" from the PEZA Board under the Implementing Rules and Regulations (IRR) of Republic Act (RA) 7916 before the moratorium's effectivity under AO 18 should be allowed to resubmit their application with certain conditions.

"Within a non-extendible period of ten (10) working

days from the effectivity of this Order, the PEZA shall submit to the Office of the President (OP), through the Office of the Executive Secretary, a Board Resolution certifying the Masterlist of covered applications under the immediately preceding paragraph," the new AO read.

"For this purpose, the PEZA shall submit, along with the said Board Resolution and Masterlist, certified true copies of the pertinent Pre-Qualification Clearances issued by the PEZA Board to the developers/proiect proponents concerned and the minutes of the meeting when the same were approved by the Board."

MANILA – The Cavite Spartans defeated the Manila Indio Bravos, 14.5-6.5, to reach the Northern Division semifinals of the Professional Chess Association of the Philippines (PCAP) online tournament played on Chess.com on Wednesday night.

The Spartans scored 4.5 points in the blitz game coming from the victories of Grandmaster Aleksey Sorokin (Board 2), Woman International Master Bernadette Galas (Board 3), Alexis Emil Maribao (Board 5), and Ricky Batcho (Board 6), and a draw by FIDE Master Carlos Edgar-

New CALAX section to Tagaytay doubles daily vehicular traffic target

TRECE MARTIRES CITY (PIA) -- The 4-kilometer Silang (Aguinaldo) section of the Cavite-Laguna Expressway (CALAX) has already served double its target daily traffic of 5,000 vehicles since it opened on Nov 8, 2023.

Toll operator, MPCA-LA Holdings Inc. (MHI), announced that CALAX has recorded its highest daily traffic at 11,000 vehicles in less than a month.

Raul Ignacio, MHI President and General Manager, said the CALAX expansion will benefit motorists and boost the local economy.

"By providing a quicker and more convenient route to popular destinations in Cavite, we're creating opportunities for businesses to thrive and for families to make the most of their time together," Ignacio said.

Anne Valdez, who recently used the expressway during the long weekend to travel to Tagaytay, shared her positive experience. She found the travel from Metro Manila convenient and less hassle

compared to traversing the busy roads of Santa Rosa City in Laguna.

"Travel was fast and continuous compared to passing through Santa Rosa or Silang (in Cavite), as we used to. Going to Tagaytay would now be easier and more convenient for us," she said.

Currently, motorists will only be charged up to the Silang East Interchange until further notice.

This segment of CA-LAX, which connects to Aguinaldo Highway, provides a seamless and alternate route to tourist destinations in Cavite, including Tagaytay, Silang, and Dasmariñas including nearby cities and municipali-

ties.

Meanwhile, construction of the remaining portion of the CALAX Cavite Segment is in full swing. The next interchange will be a 7.9km 2x2 lane expressway, extending from the Silang (Aguinaldo) Interchange to Governor's Drive in General Trias.

"Governor's Drive will be the second-longest

segment of CALAX, spanning almost 8 km. in length. We target to open it to the motoring public before the end of 2024. Through this interchange, we aspire to revolutionize our motorist travel experience, by connecting communities and helping improve the economy of the region," shared Ignacio. Phivolcs lays out modernization plans before Senate panel

MANILA – The Philippine Institute of Volcanology and Seismology (Phivolcs) brought its modernization plans to the Senate Committee on Science and Technology on Friday.

Four Phivolcs modernization bills have been filed by Senate President Juan Miguel Zubiri, Senate Majority Leader Joel Villanueva, and Senators Francis Escudero, Jinggoy Estrada, Ramon Revilla Jr., and Francis Tolentino.

Phivolcs Director Teresito Bacolcol said the modernization aims to install 300 earthquake monitoring stations; 82 sea monitoring stations; complete monitoring systems for eight volcanoes with minimum monitoring instrument for 16 volcanoes; complete geologic hazard maps; capacitated additional staff; and a new Phivolcs building with state-of-the-art facilities like central data receiving center, researches, trainings, (information **ICT** communications technology) server room, facility tools and archives.

"In order for us to continue populating these platforms, as well as continue with our mapping efforts, we need to have more technical staff," Bacolcol said, noting that half of Phivolcs staff are under contract of service or temporary status.

Under Zubiri's version, PHP5 billion will be taken from the share of the national government in the gross income of the Bases Conversion and Development Authority as initial fund the modernization.

In the next two years, Phivolcs will be given PHP2.5 billion per year to be used exclusively for capital outlay, which shall be administered by its Executive Director in accordance with existing government budgeting, accounting and auditing rules and regulations.

Panel chair Senator Alan Peter suggested to utilize in the modernization budget the official development assitance from foreign countries, as well as revenuegenerating measures to make the budgeting more feasible.

"I just don't want that we pass a specific five-year plan then we don't give you the money," he said, while asking economic managers to make sure that the modernization will be funded regularly once it is passed into law. (PNA)

On the other hand, the SLH is a 577-km., 33-station railway from Metro Manila, passing through Batangas, all the way to Bicol.

The SLH will reduce travel time from Manila to Legazpi in Albay from the present 14 hours to 18 hours by road to a six-hour ride by regular commuter trains or a 4.5-hour commute by express trains.

Comelec to destroy nearly 4M defective ballots, other poll forms

MANILA – The Commission on Elections (Comelec) on Tuesday said it will destroy close to 4 million election forms, including official ballots from the just concluded Barangay and Sangguniang Kabataan Elections (BSKE).

In an interview, Comelec deputy executive director for administration Helen Flores said the forms that would be destroyed include 3,990,624 unused and defective official ballots and 84,905 defective accountable forms.

"This is customary on the part of the Comelec. We do this after every election," she said.

Also set for destruction are 1,371,179 defective ballots due to printer error; 1,483,052 unused ballots from the conversion from municipalities to cities of Baliwag, Bulacan and

Carmona, Cavite and 275,953 unused ballots arising from the transfer of 10 former Makati barangays to Taguig City.

The poll body would also destroy a total of 860,440 excess ballots due to repeated allocation and 84,905 defective accountable forms due to machine error.

Flores noted that they expect to finish the destruction in a month.

She added that the move aims to prevent the unlawful use of the forms.

"We just want to make sure that the rejected ballots will not be used for illegal purposes. As you can see, these are official ballots. We need to destroy these in order to make sure that they are not used," she said.

The destruction of poll paraphernalia will be done through manual tearing followed by shredding by the Comelec's Disposal Committee. (PNA)

Enough time to modernize jeepneys – DOTr exec

MANILA – There is enough time to modernize jeepneys after the consolidation deadline on Dec. 31, assuring drivers and operators of government support, an official of the Department of Transportation (DOTr) said on Friday.

DOTr Undersecretary Timothy John Batan said the actual deadline for PUV modernization is in 27 months or two years and three months after Dec. 31, which is the deadline for the consolidation of PUV franchise holders into cooperatives or corporations and not the phaseout of traditional PUVs by yearend.

"Ano po ang mangyayari sa December 31? Ito pong deadline ay para sa isa sa mga components ng PUV modernization (What will happen on December 31? This is the deadline for one of the components of the PUV

modernization)," Batan said.

The 27 months allotted for the PUV modernization program (PUVMP), he said, is part of the revised Omnibus Franchising Guidelines following consultations with drivers, operators and other transportation stakeholders.

"After consolidation, saka sila magkakaroon ng sapat na panahon para magmodernize sila ng jeepneys (After consolidation, that's when they'll have time to modernize their jeepneys)," he said.

In addition, the government has also increased government subsidy for purchasing modern PUVs to PHP280,000 for Class 2, 3, or 4 PUVs and PHP210,000 for Class 1 PUVs.

This is an increase from the previous PHP160,000 subsidy which was also an increase from the original subsidy of PHP80,000.

that only those included in the Masterlist will have the option to resubmit their applications for ecozones, provided they undergo anew the pre-qualification process of the PEZA under the IRR of RA 7916.

According to Marcos' AO, all required national or local licenses, clearances, permits, certifications, or authorizations that have already expired need to be renewed, under pertinent laws, rules, and regulations.

"The Inclusion in the Masterlist or the acceptance, processing, and/or evaluation of applications by PEZA and thereafter, by the OP, shall by no means constitute as a guarantee that such applications shall be approved and subsequently proclaimed as ecozones," AO 11 stated.

AO 11 clarifies that other provisions of AO 18 will remain in effect, including the moratorium on the processing of applications for the establishment of economic zones in Metro Manila.

The new AO was issued to bolster employment in Metro Manila and position

it as the "leading information and communications technology hub" in the country.

"Allowing the processing and evaluation of applications for ecozones in Metro Manila that have been successfully issued a Pre-Qualification Clearance by the PEZA Board prior to the implementation of the moratorium under AO No. 18 will have a positive impact on job creation and will further strengthen Metro Manila's position as a leading information and communications technology hub in the country," the order read.

Based on the government's recent assessment, the services sector, which includes information and communications, continues to be a reliable source of economic activity in the country, with Metro Manila registering the biggest share.

The Marcos administration's 8-Point Socioeconomic agenda aims to bolster employment opportunities for the Filipino people through the promotion of investments that boost productivity.

Clear, present threat

FORMER Land Transportation Office executives were not exaggerating when they described German firm Dermalog's failure to fulfill its commitments under the Land Transportation Management System or LTMS contract with the government as a threat to national security.

Documents filed with the Ombudsman, in a 2022 Dermalog graft complaint, revealed that Dermalog "interfered in and controlled the LTO's printing system of driver's license cards."

Moreover, the Commission on Audit, or CoA, in a 2022 report on the Department of Transportation, said Dermalog, in undertaking the Road Transportation Infrastructure Information Technology Project, which is a P3.19 billion component of the LTMS, has withheld key components of the project.

"The source code of the software and other applications relative to the LTMS was not turned over by the Dermalog joint venture to the LTO due to a contrary interpretation of the former on the terms of the contract and its relevant supporting documents," according to CoA.

State auditors added that "payment to Dermalog Identification System GMBH for maintenance of core applications for the period from October 2019 to October 2020 was made notwithstanding that the 1st acceptance of core applications was only made in December 2020."

In effect, the premature payments "effectively shortened the duration of maintenance services up to October 2024 only, instead of up to December 2025, to the disadvantage of the government."

The report also indicated that "payment to Dermalog Joint Venture for maintenance of core applications and data center aggregating to P13,042,145.54 was considered erroneous due to a mistake in the classification or categorization of items claimed and paid under maintenance of core applications instead of data center; and unnecessary payment of electrical fees."

CoA also found in examining the contract that of the 39 issues and concerns, 33 were of high severity and one was of critical severity.

CoA said the severe concern relates to the "erroneous/incomplete configurations which,

if left uncorrected, will be crucial to the overall functionality of core applications."

"Meanwhile, out of the 33 issues of high severity, 15 pertained to the Drivers' Licensing System, or DLS, and 13 to Motor Vehicle Inspection and Registration System, or MVIS."

Contrary to claims that the LTMS is functional despite Dermalog's shortcomings, the CoA said the deficiencies greatly impact the LTO digital system.

Considering that the LTO is the third biggest revenue earner for the government, the failures of Dermalog should be classified as sabotage.

CoA explained that open issues, concerns, and items for enhancement were affecting the utilization of the new information technology, or IT system, and hence, "should be immediately and sufficiently addressed by the management."

State auditors warned if the deficiencies persist "and continue to cause non or limited utilization of the new IT system, the project will certainly be considered a waste of government funds, and hence the disbursements thereon, which as at audit date already consist of full payment for all core applications and two years maintenance, may be considered as disallowable."


Prolonging the LTMS problems that have plagued the company for four years appears beneficial to Dermalog due to the continuing fees it collects while ownership is not fully transferred to the government.

CoA's review of LTO payments to Dermalog showed that as of 31 December 2022, P385.6 million were paid for the maintenance of core applications, data center, and generator set.

A total of P330.14 million was paid on 9 February 2022. By then, the audit team issued a memo dated 14 January containing an observation that the billing was premature.

Despite the adverse finding, it is stupefying that some LTO and DoTr still shield Dermalog, with one saying that no advance payments were made in defiance of the CoA findings.

The sole solution should be for Dermalog to fully deliver and transfer ownership of the LTMS to the government, nothing less.

Kung wala ang mga ito'y wala rin ang mga bagay na pino at ispiritwal [Hinggil sa Konsepto ng Kasaysayan, 2013]." Sa likhang-sining nila, pinaglilingkod ang "mga bagay na pino at ispiritwal" sa "tunggalian ng mga magagaspang at materyal na bagay." Mahalaga ito dahil, paliwanag ni Michael Lowy, "ang nakataya sa tunggalian ay materyal, pero ang motibasyon ng mga aktor panlipunan ay ispiritwal [Fire Alarm, 2005]" — hustisya, disenteng pangarap na kinabukasan, at iba pa.

"Rehabilitasyon Sa Hindi Phaseout" (2018,graphite on wall), ipinakita ni Renz at mga kasamahan ang paglaban ng mga tsuper ng jeep sa iskemang jeepney phaseout. Hindi tiyak kung nasaan ang hanay ng mga nagpoprotestang drayber: sa kanilang pondohan ba, sa kalsada, sa Mendiola, maliit na protesta ba ito o welgang pantransportasyon. Sa ganito, tinahi ang iba't ibang porma at antas na ng tinahak ng paglaban. Malinaw ang katangian ng mga tsuper: maralita, lalake, may-edad, mas malamang na mga tatay. Sobrang higpit ng ugnayan ng jeepney sa kanilang kabuhayan at representasyon, na ang banta rito ay banta sa kanila mismo.

Sa "Buhay at Kabuhayan" (2020, 12.5 x 19 in medium, color pens and pencils on paper) naman, ipinakita ni Melvin Pollero, kaibigan at kasamahan ni

Renz mula kolehiyo hanggang kilusang paggawa, ang isa pang larawan ng paglaban. Palatandaan ang balat: nasa sentro si Elmer "Tatay Elmer" Cordero, 72-taong gulang na tsuper na noong Hunyo 2020 ay napabilang sa "PISTON 6," mga tsuper na inaresto sa protesta laban sa jeepney phaseout, at naging popular na mukha ng mga jeepney driver at kanilang paglaban. Suot ni Tatay Elmer ang face mask at face shield, mga palatandaan ng isang partikular na panahon, ang pagtama ng pandemyang Covid-19.

Kung ang likha ni Renz ay imahe ng samasamang paglaban sa posibleng mga sentro ng protesta na umpukan ng mga tao, ang likha ni Melvin ay imahe ng nag-iisang tao na napapaligiran ng mga waring inayos na mga imahe. Kung tila larawan o picture ang likha ni Renz, parang "protest selfie" na may graphic design naman ang kay Melvin. Kung itim-at-puti ang likha ni Renz, epekto ng midyum na ginamit at taliwas sa makulay at buhay na buhay na imahe ng mga jeepney, matingkad naman ang mga kulay ng likha ni Melvin, tila angkop sa social media na siyang lagusan. Kung nagsisimula pa sa isyu ng jeepney phaseout ang mga islogan sa likha ni Renz, mas masaklaw na ang mga panawagan sa likha ni Melvin: Paninirahan at karapatan, ipaglaban! Oust! Paglingkuran ang sambayanan!

Makabuluhan ang porma ng mga likha: ipinapakita ang magkaibang

larangan ng tunggalian na pinasok para isulong ang parehong panawagan ng parehong sektor ng lipunan. Kung ihahanay sa panahon at pagpapatuloy, ipinapakita rin ang masalimuot na kumbinasyon ng pagsulong at pag-aangkop na ginawa para sa parehong laban. Nagsisimula pa lang ang laban noong kay Renz, inabot ng pandemya kay Melvin. Pagsulong, sa paglawak at pagtalas ng mga panawagan. Pag-aangkop, sa mahirap na kalagayan ng pagpoprotesta sa gitna ng pandemya at pagmaksimisa ng social media. At dahil nasa social media ang eksibit at pagtatambal na ito, hamon at palaisipan kung paano mapapatagal ang halaga ng mga sining-biswal; sa usaping ito, magkasundo ang pagpapahalaga ng pakikibaka at sining laban sa mabilisang pagtanaw at pagkaligta sa mga imahe sa social media.

"Ang pinakamataas na parangal," madalas sabihin ng mga aktibista patungkol sa mga kapwa-aktibistang pumanaw tulad ni Renz, "ay ang ituloy ang pakikibakang kasamang isinulong ng nabuwal." Sa pagpapatuloy sa pakikibaka, pinaparangalan ng mga artista ng bayan si Renz; at sa pagpaparangal kay Renz, humahango sila sa pagpapatuloy nila — sa isang pakikibaka na nagpapatuloy rin, lagi't laging nag-aangkop, at sumusulong sa kabila ng mga balakid.

Public participation sought for sea turtle protection Pawikan holds the Pawikan Potroller for a Day on immore

In an effort to promote and strengthen turtle conservation efforts in the country, seven Biology students from Polytechnic University of the Philippines (PUP) - Manila launched an environmental conservation organization called, 'One Pawikan'.

Established in April 2021, the group routinely conducts series of webinars and joins online dialogues to stress the importance of environmental and sea turtle conservation in the Philippines.

In an interview with the Philippine Information Agency IV-A, founder Mark David De Guzman said they partner with the Department of Environment and Natural Resources (DENR), local government units and other people's organizations in managing and protecting sea turtle hatcheries in different parts of the country, including Barangay Labac, Naic, Cavite, Barangay La Paz, San Narciso, Zambales, and in Barangay Pag-Asa in Bagac, Bataan.

During the annual turtle nesting season, One

Patroller for a Day, an immersion project participated by youth, students, and professionals who want to experience the work of a 'Pawikan Patroller', and aims to teach them about the biology and proper conservation of sea turtles. "When we catch a nesting sea turtle, we will teach them how to retrieve the turtle eggs, at the same time, we will measure and weigh them and tag them before returning them to the ocean. Early in the morning, we will release the turtle hatchlings," De Guzman explains.

But the work doesn't

end there. According to De Guzman, in 1,000 sea turtles released into the wild, only 1% has the chance to survive and reach their adulthood stage due to ocean pollution and appeals to the public for active involvement in case reporting.

"Therefore, I encourage everyone to stay vigilant, especially in communities near the sea where there are sea turtles, and immediately report to the LGU or nearest DENR Office."

How can the public, especially the youth, contribute to the preservation of sea turtles? De Guzman said that discipline and involvement to the cause are important.

The group's founder said: "The proper disposal of waste in its designated area

is important; the avoidance of single-use plastics which we know contribute to the loss of some of our marine resources, including sea turtles, the support for a zero-waste lifestyle which promotes the use of reusable products to reduce waste generation in our community; and the adherence to environmental laws and ordinances in their respective areas."

Volunteering in various environmental activities such as tree-planting and coastal clean-up events, and donating to environmental groups can also help to amplify and sustain the advocacy for marine ecosystems, De Guzman believes. (CO,CH/PIA-4A)

What NCR's first elected child representatives promised the Philippines a society where children's

Through the engaging workshops and discussions, delegates explored fundamental aspects of the 10 Rights of a Child. This environment, empowering organized by the Regional Committee for the Welfare of Children (RCWC) and the Department of Social Welfare and Development, allowed them to articulate their personal challenges and address pressing issues related to the infringement of their rights.

Wearing their victory with contagious smiles, the air is filled with optimism and the promise of change as these young leaders, having triumphed in the electoral arena, stand ready to embark on a journey that will perhaps shape the destiny of the country's youth.

For these young victors, winning the election is not just a personal achievement; it's a triumph for the dreams and aspirations of every child. Each smiling face becomes a beacon of hope, signaling a future where the voices of the youth are not just heard but actively shape policies and initiatives.

Among the newly-elected child representatives were: Jan Ember S. Bat-On who represented Caloocan City; Andre Jean Salazar and Anne R. Van Tuin who advocated for Muntinlupa City; Charles Sigad who voiced the youth of San Juan City; and Lakan Roderick Alo who stood as the beacon for Valenzuela City.

And as the cheers of victory still echo, the child representatives shared their vision for a more child-friendly environment. From safer streets to vibrant playgrounds, their aspirations paint a colorful picture of a nation where the needs and rights of every child are prioritized. These are their promises for the Philippines:

Promote positive parenting

Lakan Roderick Alo and Jan Ember S. Bat-On highlighted the fundamental need for all Filipino children to have a secure and caring inside environment their homes and communities. They emphasized the value of a safe environment while communicating that every child has a right to a place free from danger, fear, or insecurity.

This includes creating a loving, understanding, disciplined, and guidanceoriented environment. As a result, children may flourish mentally, physically, and emotionally and help create a society where children's views are appreciated. The advocacy of positive parenting ultimately has a ripple effect that fosters the welfare of society as a whole and individual well-being.

Advocate for the rights of children

Andre Jean Baltazar's commitment to national advocacy for these platforms highlights the need to elevate the opinions and concerns of young Filipinos beyond local boundaries. Baltazar wants to increase the influence and reach of child welfare programs by taking their advocacy efforts to a national level.

Raising awareness and shaping laws and initiatives impacting children's lives nationwide is made possible through national advocacy. It entails interacting with national organizations, lawmakers, and government departments to prioritize and address the needs and rights of Filipino children.

Promote youth leadership and equality

The foundation of Charles Sigad's focus on promoting youth leadership and equality is educating young people about their rights so they may take action, regardless of their economic status, color, gender, ethnicity, religion, or disability.

Together, the promises made by these newly-elected child representatives lay the foundation for a future in which children are protected,

heard, and empowered; a future in which each child's potential is realized and their rights are respected, ensuring a better future not only for the National Capital Region, but the entire nation as well.

According to Gladys Rodriguez of the RCWC National Capital Region secretariat, child participation within the Philippine legal framework has a rich historical foundation predating the United Nations Convention on the Rights of the Child (UNCRC).

"As far back as the 1974 Child and Youth Welfare Code, it was established that children are responsible for actively engaging in civic affairs and promoting general welfare," Rodriguez said.

"This legislation mandated the establishment of the Barangay Council for the Protection of Children (BCPC) and emphasized youth representation within it," she added.

Following the Philippines' ratification of the UNCRC in 1990, Rodriguez said child participation was institutionalized through subsequent national legislation.

"The Regional Council for the Welfare of Children (RCWC) manifests this commitment by having children representatives

nominated by their respective child representatives at the local or provincial levels," she said.

"These child representatives, elected during the children's congresses via a voting system, play an important role across various domains such as project planning, research, implementation, emergencies, training, humanitarian response, and local governance," she added.

To ensure that their views are heard at all levels of government, child representatives are involved at both the national and local levels.

Notably, the election process differs between the Sangguniang Kabataan (SK) members, who are elected by individuals aged 15 to 30, and the RCWC child representatives, who are individuals aged 10 to 15, endorsed by their respective Local Councils for the Protection of Children (LCPC) after undergoing a selection and election process.

The UNCRC's definition of children, however, encompassing those aged 10 to 17, allows for the inclusion of individuals between 16 and 17 as nominees for child representation, underscoring the commitment to fostering youth involvement and empowerment. (PIA-NCR)

PBBM seeks support for PH's bid to host 'Loss and Damage Fund'

By Ruth Abbey Gita-Carlos

MANILA - President Ferdinand R. Marcos Jr. on Friday called on world leaders to support the Philippines' bid to host the "Loss and Damage Fund" to ensure the prompt operationalization of the fund to help developing countries cope with the extreme impacts of climate change.

Marcos made the call in a speech delivered by Special Assistant to the President Antonio Ernesto Lagdameo Jr. during the opening of the United Nations Framework Convention on Climate Change (COP28) Philippine Pavilion.

He noted that the Philippines, which has "always been at the forefront of climate issues," is pushing for just transition, as well as loss and damage financing.

Announcing the Philippines' intent to host the Loss and Damage Fund, Marcos emphasized the urgency to confront climate impact, considering reports from the Intergovernmental Panel for Climate Change that it would "severely affect" the vulnerable and poor communities.

"The Philippines calls for the immediate operationalization of this Fund to assist developing and vulnerable countries to respond to droughts, floods, and rising sea levels exacerbated by climate change," he said.

"We urge partners from the private sector, civil society, partner countries, and governments, and developing funding institutions to support the Philippines in this bid. You have been there for meaningful collaboration with our government to tackle the climate crises."

United Arab Emirates' Sultan al-Jaber, president of the ongoing COP28 climate conference in Dubai, committed USD100 million to the fund.

Germany pledged a similar amount, while the United States and Japan also announced contributions to the fund.

The operationalization of the fund, which would compensate for the loss and damage, was approved during the COP28 summit.

World Bank president Ajay Banga, in an event at COP28 in Dubai on Friday, said the international financial institution would play a limited role in managing the day-to-day operations of the fund, adding that donors and recipients would likely control how financial resources are spent.

'Transformative solutions'

Amid all the challenges, Marcos said the Philippine government has put into action transformative solutions to curb the impact of climate change and address biodiversity loss and pollution.

"More than just an environmental issue; for us, it is a matter of survival, of justice, and of protecting the rights of our people. Thus, the Philippine Development Plan sealed the national development priorities on accelerating climate action and establishing sustainable and livable cities," he

The President noted that the government has allotted PHP453.11 billion for climate change adaptation and mitigation for 2023, while PHP889.65 million has been granted to local government units for climate change adaptation programs and projects under the "People's Survival Fund."

He added that aside from ensuring sufficient funds for climate change mitigation efforts, the Philippines is heading for low-carbon development, as it remains to be the third largest geothermal power producer next to the United States and Indonesia.

"We are on track towards achieving a 35-percent renewable energy share in the power generation mix by 2023 through policy reforms that allow more investors for offshore wind and floating solar. We need to protect our forests, our oceans, and our biodiversity," Marcos said.

"The Philippines, being a megadiverse country, is home to 50,000 species of flora and fauna, 50 percent of which can only be found in the country. We are intensifying the protection of natural resources to restore natural ecosystems and maximize ecosystem services that will benefit indigenous peoples and local communities."

Grateful

Marcos also extended his gratitude for the Official Development Assistance (ODA) for PHP164.17 billion worth of various climate change projects.

He also thanked the Asian Development Bank and the British government for their support in the completion of the Philippines' National Adaptation Plan and the Nationally Determined Contribution Implementation Plan.

"The challenges we face are huge, but so are the reasons to be hopeful," Marcos said, adding that the Philippines would continue to rally everyone to draw inspiration from "these signs of progress that everyone in the world has achieved." (PNA)


