## Gatchalian: Inclusive education law for learners with disabilities must be fully enforced

MANILA -- The government must commit to fully and effectively implement the law on inclusive education for learners with disabilities, Senator Win Gatchalian said.

The senator is referring to Republic Act No. 11650 or Instituting a Policy of Inclusion Services for Learners with Disabilities in Support of Inclusive Education Act, which he sponsored during the 18th Congress.

According to 2022 Country Report on Human Rights Practices in the Philippines by the United States Department of State, the law was not effectively enforced and that many barriers remain, including architectural barriers that made attendance difficult for persons with disabilities. Stakeholders and advocates have also lamented the non-issuance of the law's Implementing Rules and Regulations (IRR) after more than a year since it was passed.

Gatchalian emphasized the urgency of issuing the law's IRR since it will provide the minimum services and conditions in the admissions systems and policies of all schools, including the provision of assistive devices, facilities and infrastructure in the admission process, and other forms of

## Police nab killer of La Salle-Dasma student

MANILA - The suspect in the killing of Queen Leanne Daguinsin, a graduating student of De La Salle University-Dasmariñas in Cavite, was arrested on Saturday morning.

Based on the report of Col. Christopher Olazo, Director of the Cavite Police Provincial Office, suspect Angelito Erlano (alias Kulet) was arrested around 10:40 a.m. at Purok 4, Barangay Victory Reyes during a hot pursuit operation.

The Provincial Intelligence Unit conducted

a follow-up operation in the village after a tip from an informant that Erlano was hiding at the house of his friend. When confronted, the suspect tried to attack the responding officer with an improvised pointed weapon, but did not succeed.

Daguinsin, 22, was found lifeless with 14 stab wounds on March 28 inside her dormitory room.

# Cavite diocese urges faithful to attend Sunday Masses in person

MANILA – The Diocese of Cavite urged the faithful to physically attend Masses in churches every Sunday.

In a circular letter, Bishop Reynaldo Evangelista said the public is encouraged to be present and participate in Masses especially on Sunday as the earlier Church order prohibiting them to attend Church activities due to the coronavirus disease 2019 (Covid-19) threat will soon be lifted.

"Please be advised that through this communication, the previous Decree on Dignation from Sunday Obligations of the faithful during the coronavirus 2019 pandemic issued on the 8 of July 2020 will soon be lifted officially. This will take effect on Palm Sunday, the 2 of April 2023," the diocese said in a letter dated March 20 and made public Tuesday.

At the same time, the Catholic prelate reminded the people to continue observing

the minimum health protocols as there are still cases of Covid-19 in the country.

"For this reason, the faithful are enjoined to be physically present and actively participate in all Sunday Eucharistic celebrations, while still observing minimum health protocols," he said.

"This is in view of the weakening of the strain of the coronavirus 2019 (Covid-19), vaccination of the whole population, and the encouragement of the Catholic Bishops' Conference of the Philippines (CBCP) for the faithful to return to Sunday masses in Churches," Evangelista added.

In October 2022, the CBCP has released a circular urging the faithful to physically attend Sunday Masses in churches amid the weakening situation of the coronavirus pandemic.

Likewise, it reminded them to carefully observe health protocols for their protection against the virus. (PNA)

we are also espousing township development that will ensure sustainable co-existence of all elements and players in a housing community," Acuzar said.

Congruently, the 4PH Program pursues innovative strategies to maximize the use of land resources, particularly the vacant, idle, blighted and underutilized government and private-owned lands for housing and mixed-use development.

In addition, it targets to optimize land utilization, especially in highly urbanized and component cities through prioritizing vertical housing and adopting township development models.

"We give weight to the fact that the country's population growth remains as one of the fastest in Asia, yet our spatial legroom remains constant. It literally maintains its original size and shape, prodding us to strategize on its use while protecting everything that inhabits it," Acuzar said.

Statistics from local housing boards indicate approximately 3.7 million ISFs in the country, half a million of whom are in Metro Manila. Living under poor conditions, they occupy blighted areas, within easements, beside railways, waterways, esteros, among other dangerous areas. This poses serious risks to their health and exposes them to hazards and natural disasters.

The 4PH Program, thus, focuses on developing low, mid to high-rise projects near the sources of livelihood of target beneficiaries. Indisputably, most of these areas are found in the metropolis or in the center of urban areas where informal settler families (ISF) persistently thrive.

partnership with LGUs, envisions to transform informal settlements and blighted areas into better residential developments with reasonable open spaces. In aid of this, we must clean and rehabilitate waterways and esteros into parks and walkways, and promote onsite or near-site in-city housing," the housing chief said.

The 4PH's concept on township development is, meanwhile, guided by the very definition of transit-oriented development to maximize the amount of residential, commercial and leisure spaces within walking distance or easy access to public transportation.

Recent projects the 4PH has inaugurated feature housing communities equipped with amenities and infrastructure to facilitate economic and social activities among target beneficiaries.

Facilities and amenities such as schools, livelihood center, administrative offices, central park, basketball court, mini market and hawker area, aquaphonics area, sewage treatment plant and materials recovery facility are also incorporated in the master plan for township development.

"All these are tactically situated in or near city centers to ensure access to mass public transportation systems such as rail, bus rapid transit, intermodal passenger terminals and bus interchanges," Acuzar added.

In the long run, DHSUD eyes the opportunity that mass transportation creates in promoting economic activities, improving environmental quality and achieving social development objectives.

With the right strategies in place, Acuzar is confident to reach the flagship program's target of bridging the country's 6.5 million housing gap moving from ground up toward sustainable development. (dhsud/piancr)

## **Bataan-Cavite Interlink Bridge to** open up economic opportunities

MANILA - President Ferdinand R. Marcos Jr. said Friday the PHP175.6 billion Bataan-Cavite Interlink Bridge (BCIB) project is seen to boost the regional economies of the two provinces through improved connectivity.

During the bridge's ceremony milestone Mariveles, Bataan, Marcos said new economic opportunities would open to Bataan and Cavite and their surrounding provinces because of the easier access that will be made available through the bridge project.

The President noted that the BCIB is projected to reduce the Central Luzon - Calabarzon travel time from 5 hours to just 45 minutes, cutting as much as 86 percent.

"That will be an incredible feat when it happens and would significantly help in decongesting Metro Manila as motorists will be able to travel without passing through the metropolis," he said.

He said the bridge, once completed, would also help bring prices down for goods and services as the transport and logistics costs would decrease, thus generating immense savings all around.

The project will also support the development of seaports in the two provinces, making them potential international shipping gateways of the country, he added.

"As such, I assure you, we will remain committed developing a highly interconnected network

transport (infrastructure) will serve as the backbone and strong driving force of our rapid, inclusive, and sustainable (economic) growth," he said.

Marcos called on the officials and employees of the Department of Public Works and Highways, as well as all the consultants to remain committed to finishing this project on schedule.

"Do your best always to ensure that civil works for this bridge will commence by October this year," he said. "Do your best also to deliver what we have proposed so that our people and their localities may live out the picture we have painted as our goal as soon as possible."

The 32.15-km., fourlane, inter-island bridge will connect Barangay Alas-asin in Mariveles, Bataan and Barangay Timalan Concepcion in Naic, Cavite and once completed, it will be the longest bridge in the Philippines.

The BCIB will have two navigational bridges: the 400-meter North Channel Bridge and the 900-meter South Channel Bridge, which will traverse Corregidor Island. About 80 percent of the structure will be over the sea.

ensure progressive realization of the objectives of RA 11650, the crafting of a multi-year roadmap is required to guide government agencies and private stakeholders. The law provides that the multiyear roadmap should contain the current policy, practices, gaps, and challenges affecting the early and basic education of learners with disabilities. It shall set detailed targets and outcomes for a minimum period of five years.

The law mandates the

establishment of at least one Inclusive Learning Resource Center (ILRC) for Learners with Disabilities in every city and municipality. These ILRCs are mandated to implement inclusive education programs and deliver free support services to learners with disabilities.

While it may take some time before the law is fully implemented, Gatchalian identified some steps that the government can take. For one, he pointed out that under the 2023 national budget, P160 million is allotted under the Department of Education's capital outlay to allow each region to convert at least one Special Education Center (SPED) into a model ILRC. This will steadily expand access to inclusive education programs, Gatchalian said. (PIA-

## Killer of La Salle-Dasma student identified

MANILA - The Philippine National Police (PNP) has identified the suspect in the killing of Queen Leanne Daguinsin, a student of De La Salle University-Dasmariñas in Cavite.

The Special Investigation Task Group (SITG) Daguinsin convened Friday morning to discuss the developments and named the suspect as Angelito Erlano, also known as "Kulet", a resident of Barangay San Nicolas 2, Dasmariñas City.

Follow-up operation by the Dasmariñas City Police Station and Cavite Provincial Intelligence Unit on March 29, the day after the body was found, led to the identification of the suspect and the suspect's house through a review of closed-circuit television camera footages.

The police recovered a black short with a white stripe and a blue t-shirt, believed to have been used by the suspect during the commission of the crime, and a black backpack.

According to police records, the suspect had previous involvement in other robbery

Daguinsin was found dead by her classmates on Tuesday inside her dormitory room in Barangay Santa Fe. They checked on her as she has been absent for days.

investigation showed the computer science student sustained 14 stab wounds to different parts of the body.

The reward money for the capture of the suspect has reached PHP1.1 million as of Thursday, started off by PHP300,000 from Cavite Governor Jonvic Remulla.

PNP tracker teams are still in the area while a case buildup is being undertaken by the Dasmariñas City police.

"We condemn this heinous crime and we will not stop until the perpetrator will be put behind bars. We call on the public to cooperate with the authorities and report any information that may lead to the arrest of the suspect," PNP chief General Rodolfo Azurin Jr. said in a statement.

The PNP also assured the public that it remains committed to maintaining peace and order, observance of human rights, and ensuring justice for Daguinsin and her family. (PNA)

#### construction Actual of Bataan-Cavite bridge may start early 2024

MANILA - The Department of Public Works and Highways (DPWH) is looking to start the construction of the Bataan-Cavite Interlink Bridge (BCIB) within the first quarter of 2024.

32.15-kilometer, The four-lane BCIB will connect Barangay Alas-asin in Mariveles, Bataan to Barangay Timalan Concepcion in Naic, Cavite, reducing travel time from five hours to an estimated 45 minutes.

"Hopefully, we can start packages 1 and 2 this year and we could procure the other packages of this project until next year," said Teresita Bauzon, DPWH project manager, during the Saturday News Forum in Quezon City.

The entire construction may last until mid-2028, she added.

The project will be financed by loans from the Asian Development Bank (ADB) and Asian Infrastructure Investment Bank.

"Right now, all the negotiations

of the National Economic Development Authority and the ADB for funding of the construction are ongoing," Bauzon said. On Friday, President

Ferdinand R. Marcos Jr. led the milestone ceremony for the detailed engineering design of the project at the Maritime Academy of Asia and the Pacific in Mariveles, Bataan.

Marcos asked DPWH employees, consultants to remain committed to finishing the BCIB on schedule.

"Do your best always to ensure that civil works for this bridge will commence by October this year," he said. "Do your best also to deliver what we have proposed so that our people and their localities may live out the picture we have painted as our goal as soon as possible."

The feasibility study for the project started in March 2018, funded by the ADB Infrastructure Preparation and Innovation Facility loan. (PNA)

## **Court of hypocrisy**

The recent decision of the International Criminal Court to issue an arrest warrant against Russian President Vladimir Putin is being hailed globally as a display of the institution's hypocrisy.

The ICC gambit acquired more symbolism as the order came on the 20th anniversary of the United States Desert Storm campaign against Iraq's leader Saddam Hussein.

While pursuing Putin, the ICC is also out for President Rodrigo Duterte's scalp after it denied a Philippine government plea to suspend its investigation into the anti-narcotics campaign.

Solicitor General Menardo Guevarra wanted more time to impress on the conceited tribunal that its interference is not justified since local courts are attending to the so-called extrajudicial killings.

The ICC has accused Putin of committing war crimes during the Russian invasion of Ukraine, which started a year ago. ICC prosecutor Karim Khan KC declared that "there are reasonable grounds to believe that President Putin and (Commissioner for Children's Rights) Ms. Lvova-Belova bear criminal responsibility for the unlawful deportation and transfer of Ukrainian children from occupied areas of Ukraine to the Russian Federation."

Similar to the status of the Philippines where the ICC is insisting on the jurisdiction, neither Russia nor Ukraine is an ICC member.

Kremlin spokesperson Dmitry Peskov pointed out that Russia is not a party to the ICC "and accordingly, any decisions of this kind are null and void for the Russian Federation from the point of view of the law." To resolve the jurisdiction issue, the Ukrainian government, without signing the Rome Statute, gave the ICC the authority to investigate. A clash of hypocrites describes the relationship between the United

States and the ICC.
US President Jose Biden commended the ICC action against Putin but
the US government has long been a staunch critic of the ICC and has

the US government has long been a staunch critic of the ICC and has even passed legislation allowing for military action against it. The US is also not a signatory to the Rome Statute that created the ICC.

In 2002, the US passed a law, called the American Service-Members Protection Act, which went after ICC officials for seeking to prosecute American soldiers stationed globally.

The law allows the use of military force to liberate any American or citizen of a US-allied country being held by the ICC

The law also allows the withdrawal of US military assistance from countries ratifying the ICC treaty and restricts U.S. participation in United Nations peacekeeping unless the United States obtains immunity from prosecution.

In 2020, the US imposed sanctions on former ICC prosecutor Fatou Bensouda for initiating a probe into American military personnel.

She attempted to prosecute US war crimes during the invasion of Afghanistan.

Her bank accounts were closed down, her credit cards canceled, and members of her family even saw their assets seized by banks following sanctions imposed by the US Treasury.

Then-US Secretary of State Mike Pompeo described the ICC as a "renegade, unlawful so-called court."

"The ICC and parties to the Rome Statute must respect the decisions of the United States and other countries not to subject their personnel to the ICC's jurisdiction, consistent with their respective sovereign prerogatives," Pompeo then said.

The ICC backed off in the face of US government pressure and has since not involved itself in looking into the alleged abuses of American troops.

It was then that it decided to shift its attention to the Philippines, Duterte, and the drug war an action which the ICC expects to prop its sinking credibility to no avail.

## Katoliko Sarado

SA interbyu niya sa Buhay Manggagawa tungkol sa kasaysayan ng Araw ng Paggawa, sinabi ni Mandy Felicia, training director ng Ibon Foundation, na pulitikal ang pagdiriwang ng naturang okasyon sa mismong petsang Mayo Uno.

Aniya, ang US, nagdiriwang ng Araw ng Paggawa tuwing Setyembre; mulat na iniwasan ng gobyerno nito ang pagdiriwang sa Mayo Uno. Noong naghari sa mga bansang Germany, Italya at Espanya ang mga pasista, ipinagbawal ang pagdiriwang ng Araw ng Paggawa sa nasabing petsa. Sa Pilipinas mismo, maraming taon munang ipinagdiwang ng mga manggagawa ang okasyon sa Mayo Uno – syempre pa, sa pamamagitan ng mga martsa't demonstrasyon – bago ito kinilala ng gobyerno.

Militante at radikal kasi ang pangyayaring ginugunita sa Mayo Uno, na siyang naging batayan ng pagkilala rito ng mga manggagawa at mamamayan ng daigdig bilang Araw ng Paggawa. Mga partido ng mga manggagawa at partidong sosyalista rin ang nanguna sa pagtulak na Mayo Uno ang ituring na Araw ng Paggawa.

Ginugunita sa Mayo Uno ang pag-aaklas ng mga manggagawa sa US noong 1886, 125 taon na ngayon, para sa panawagang otso-oras na paggawa. Namamayani noon ang hanggang 14 na oras na pagpapatrabaho at literal na pinapatay ang mga manggagawa ng pagtatrabaho. Makikita rito, samakatwid, ang grabeng pagsasamantala ng uring kapitalista sa mga manggagawa — na napaatras lang, kahit bahagya, ng paglaban ng mga manggagawa. At dahil dinahas ang mga manggagawa ng pulisya ng Estado, ipinapakita ng pangyayari ang sabwatan ng mga kapitalista at Estado.

Mahalaga ang Mayo Uno ngayong taon. Magaganap ito sa gitna ng matinding pang-ekonomiyang krisis sa mundo. Taliwas sa mga pahayag ng mga tagapagtanggol ng pandaigdigang sistemang kapitalista, hindi natapos agad ang krisis pagkaputok noong Setyembre 2008; nagpapatuloy ito at nagbabanta pang sumahol.

Mahalaga rin ito dahil simula nang pumutok ang krisis, bumuhos simula noong 2010 ang iba't ibang klase ng protesta ng mga manggagawa at mamamayan ng daigdig laban sa pagpapahirap at pambubusabos na pinaigting ng krisis. Mula sa US, na sentro ng pandaigdigang sistemang kapitalista, hanggang sa pinakamayayaman at pinakamahihirap na bansa sa Europa, at hanggang sa rehiyong Middle East at North Africa na ilang dekadang sinupil ng mga diktadurang tuta ng imperyalismong US — pumutok ang iba't ibang klase ng militanteng pagkilos at protesta.

Sa ganito mailulugar ang anunsyo ni Pope Benedict XVI na ilulunsad

ang beatipikasyon (beatification) ng pinalitan niyang si Pope John Paul II sa papalapit na Mayo Uno. Isang hakbang ang beatipikasyon bago maituring na santo ang isang tao, kaya tiyak na magiging pandaigdigang pagdiriwang ito, lalo na't sinasabing popular si Pope John Paul II sa mga Katoliko sa iba't ibang panig ng mundo.

Mas malamang sa hindi, itinakda ang naturang petsa para tapatan, kung hindi man sapawan, ang pagdiriwang ng Araw ng Paggawa ngayong taon at posibleng sa mga susunod pa. Pinapatampok ng naturang okasyon ng Simbahang Katoliko sa Mayo Uno ang pulitikang kontra-maralita, kontra-Kaliwa, maka-imperyalista at makareaksyunaryo hindi lang ng dominanteng hanay at saray sa Simbahang Katoliko, kundi partikular ng mga Papa na sina John Paul II at Benedict XVI.

Ayon sa isang paglalantad, mahalaga sa pagiging John Paul II at unang Papa na hindi Italyano ni Karol Wojtyla ang pagmumula niya sa Poland — "malamang na pinaka-reaksyunaryong bantayan ng Simbahang Katoliko, puno ng sentimental na pagsamba kay Maria, makabayang simbuyo at malupit na kontra-Komunismo." Kalaban niya sa Poland ang gobyerno ng mga taksil sa sosyalismo na itinuring niyang sosyalista. Kaya noong maging Papa, malinaw siyang kumampi sa mga maka-Kanang personalidad at lider at sinupil ang mga liberal at maka-Kaliwa sa Simbahan.

Ayon naman sa isa pang paglalantad, inalagaan siya para maging Papa ng ultra-reaksyunaryong sektang Opus Dei – na itinatag ni Josemaria Escriva, tagapayo ng pasistang si Hen. Francisco Franco ng Espanya. Noong maging Papa siya, hayag siyang nanawagan ng kalayaan para sa Cuba sa ilalim ng sosyalistang si Fidel Castro pero hindi para sa Chile sa ilalim ng diktador na si Augusto Pinochet. Bagamat nagtalumpati siya tungkol sa mahihirap, hindi niya tinumbok ang ugat ng kahirapan. Mas mga isyu ng mga konserbatibo ang laging dala-dala niya, hindi ng mga maralita.

Katuwang ni John Paul II si Joseph Ratzinger – na magiging Benedict XVI – sa mga hakbanging ito, bilang tagapagtaguyod at tagapaglinaw ng doktrina ng Simbahang Katoliko noong Papa pa ang una. Ayon sa mga ulat, naging miyembro siya ng Hitler Youth noong kabataan niya sa Germany at pumirma siya sa dokumentong nagsasabing sa Simbahang Katoliko lang may "kaligtasang pang-habambuhay."

Ayon naman sa isa pang paglalantad, si Ratzinger ang nangasiwa noon sa pagharap sa mga kasong kasiraan ngayon ng Simbahang Katoliko – ang sekswal na pag-abuso sa mga bata. Sa panahong ito, "sampu-sampung libong

bata ang inaswang, pininsala at binulabog ng mga paring Katoliko habang ang atensyon [ni Ratzinger] ay nakatutok sa mga 'demonyong' homosekswal, makasalanang diborsyado, lumihis na liberation theologians, nagpaplano ng pamilya at nagsusuot ng kondom."

Sa harap ng ganitong mabibigat na tuligsa, napaka-kwestyonable ng editoryal nitong huli ng Philippine Daily Inquirer na may titulong "Agony and ecstasy," na todong pumupuri kina John Paul II at lalo na kay Benedict XVI. Akala mo'y sina Pong Pagong at Kiko Matsing lang ang pinaparangalan — mahal ng lahat, walang bahid ng kahit anong kritisismo. Halata ang tinig ng mga sosyal-demokratiko, na naging makapangyarihan muli sa ilalim ng rehimen ni Noynoy Aquino.

Todo-papuri ito sa tindig ng dalawa: "Kung matagumpay na pinamunuan ni John Paul ang kampanya ng Simbahan laban sa komunismo at sa hindi maka-Diyos na mga aspekto ng modernismo, tila ang pokus ni Benedict ay ang konsolidasyon ng mga pwersa ng Simbahan laban sa pagiging sarado ng mga liberal (liberal intolerance) at ng popular niyang binansagang 'diktadura ng relatibismo'." Pinapalaganap ng editoryal ang pagtatanggol sa dalawa kontra sa mga nabanggit na kritisismo. Pinagtatakpan nito ang maruming rekord ng dalawa para maiwan lang ang kaaya-aya.

Buung-buo ring pinuri ng editoryal ang "kritika [ni Benedict XVI] sa Islam, karahasan at pagiging sarado" – mga salitang walang ingat na pinagtabi-tabi. Lumalabas tuloy na buong pag-endorso ito sa mga pahayag ni Benedict XVI na, ayon sa isang pagsusuri, ay nagsasabing "ang Kristiyanismong Katoliko ay tradisyunal na makatwiran, pilosopikal at mapagmahal sa kapayapaan, habang ang Islam ay naging irasyunal, makaisang-panig sa pananampalataya nang hiwalay sa katwiran, at marahas." Sa ganitong paglalarawan, ang nagpapakilalang bukas ang isip ay lumalabas ding sarado.

Sa huli, ang mga manggagawa at mamamayan ng daigdig ang magpapasya sa magiging lugar ng relihiyosong pananampalataya sa pagsagupa nila sa matinding pang-ekonomiyang krisis at sa kahirapan at pambubusabos na kaakibat nito. Tiyak na marami ang yayakap nang mahigpit sa dominanteng pagdidireksyon nito. Pero tiyak na mas marami ang huhubog sa sarili ng alternatibong relihiyosong pananampalataya na tutugon sa mga pangangailangan at pakikibaka nila.

Hindi rin mapipigilang marami ang madidis-ilusyon sa reaksyunaryong katangian ng mga organisadong relihiyon, makakakuha ng alternatibong kalinawan, at magpapasyang huwag na lang maniwala.

## Raising the Torch for Persons with

HER low grade in mathematics failed her bid for a Cum Laude title when she graduated from Saint Paul University Philippines in Tuguegarao City, Cagayan.

However, with her overall excellence in her academic life, which was coupled with a positive spirit, Venus Ruam Cadabona, 55, managed to overcome the effects of polio and as she strived further to be on top

Cadabona, who hails from Piat, Cagayan, the eldest among the four siblings, started her working stint as a proofreader at the Golden Press publication house and a radio announcer for the DZYT in Tuguegarao City, before migrating to Solano, Nueva Vizcaya. This came after being married to Domingo 'Bingo' Cadabona, a media practitioner.

Becoming a housewife and a caring mother to their three children, Cadabona still struggled to work at Saint Mary's University (SMU) in Bayombong, where she finished her 16-year working period in the private sector.

"My disability is never a hindrance towards my goals and dreams in life. I always anchor my life with the Lord, always grateful for his blessings, and all challenges and hardships are my springboards to success," she said.

While at the SMU, she earned units through the

**Disabilities** Master in Public Administration (MPA) graduate school made (MPA) graduate school, made two years in law studies, earned her Master's Degree in Business Administration (MBA), and earned more units in Doctoral Degree, focusing on Rural Development Studies.

> Cadabona's research paper entitled, "Assessment of the Performance Appraisal System for Non-Teaching Personnel of SMU: Basis for Policy Recommendations for Improved Performance Evaluation Tool", has been lauded with the LIKHA award by the university.

> Her principles revolve around the belief that everybody is born equal, no one is perfect, and nobody monopolizes knowledge, hence people complement each other. This, along with her positive state of mind, became her guiding advocacies in her journey as a Person With Disability (PWD).

> "I want to be a role model to my fellow PWDs, to inspire them to continue their battles," Cadabona said.

> She continued her life journey as a PWD by entering the government sector as an executive assistant of the Governor's Office in Nueva Vizcaya in 2012, then as an administrative officer at the Provincial Engineering Office from 2013 to 2018. Finally, she was designated as a focal person for PWDs since 2019 up to the

> As the head of the Provincial Disability Affairs (PDAO), Office Cadabona serves her fellow PWDs through provincial government's

advocacy programs, projects, and services.

Through her initiative, a database for PWDs in the province had been established, which the PDAO uses for various planning and implementation of programs in support of the PWD sector.

She spearheads the establishment of linkages and partnerships with the national and local governments, and PWD organizations, for the provision of assistive devices and financial assistance among others, to her fellow PWDs in the province.

Last year, Cadabona convened PWD focal persons of the 15 MLGUs in Nueva Vizcava for the availment of free computer desktops, and in threshing out

# President Marcos to launch program in combatting malnutrition, stunting

QUEZON CITY -- The Philippine Multisectoral Nutrition Project (PMNP), which aims to address malnutrition and other nutrition-related issues in the country, will be launched today by President Ferdinand R. Marcos Jr at the Manila Hotel. The project is a multi-agency collaboration that involves the government, NGOs, and other stakeholders.

The Philippines has been struggling with malnutrition for many years. According to the 2021 Global Nutrition Report, the country has the highest prevalence of stunting in Southeast Asia, with 31% of children under the age of five being stunted. Malnutrition affects not only the physical

The PMNP aims to address these issues through a comprehensive approach that involves different sectors. The project has five components: nutrition governance, maternal and child nutrition, adolescent nutrition, food fortification, and behavior change communication.

The nutrition governance component involves the strengthening of policy, coordination, and monitoring mechanisms at the national and local levels. This includes the implementation of the Philippine Plan of Action for Nutrition (PPAN).

## Former rebels denounce violence, human rights violations of CPP

MANILA -- Former communist rebels and supporters gathered at historic Plaza Miranda on Wednesday to denounce the alleged violence and human rights violations of the Communist Party of the Philippines-New People's Army-National Democratic Front (CPP-NPA-NDF).

The rally was organized by the Kilusan ng Pagwawasto sa Kasaysayan (KPK), an anti-communist group, and coincided with the 54th founding anniversary of the New People's Army (NPA).

The KPK lit candles and burned the flags of the CPP-NPA-NDF during the protest, sending a strong message to the organization and its supporters. Hundreds of people, including former rebels, victims of the CPP's violence, and concerned citizens attended the event.

Speaking at the rally, former communist rebels and

supporters shared their stories of how they were deceived by the CPP-NPA-NDF and how the organization has committed countless human rights violations over the years. They also criticized the organization's leaders for living in luxury while their followers suffer.

One of the former rebels who spoke at the rally was Peter "Ka Ramon" Mutuc, the KPK convener and one of the organizers of the First Quarter Storm during the term of former President Ferdinand E. Marcos Sr.
