Israel continues to assist PH in the fight against COVID-19

CALOOCAN CITY -- Israel continues assist to the Philippines in combatting COVID-19.

Just yesterday, the Ministry of Defense of the State of Israel through the Israeli Embassy in Manila, donated 16,000 units of antigen test kits to the Department of National Defense of the Philippines to help its fight against COVID-19.

Israeli diplomats Ambassador Ilan Fluss and Defense Attaché Mr. Raz Shabtay turned over the antigen test kits to Secretary of National Defense Delfin Lorenzana.

"Friends support each other in times of need. Israel is a friend of the Philippines and will continue to assist and share

its expertise in various fields. I am proud to deliver this Israeli assistance today to support the Department of National Defense of the Philippines in keeping this country safe and secure," Ambassador Fluss said.

"The relationship between Israel and the Philippines, particularly the relationship between both defense ministries, is never as strong as it is now," Mr. Shabtay said. "We are delighted to be able to support once more, in the form of contributing 16,000 antigen test kits, to help the Defense Forces of the Philippines in fighting this current Global Pandemic," he added.

"We will continue to work with you and give guidance every step of the way. We know that you are professional and you have that tenacity and passion put up and use up technologies with the best you could. It is very important to have young professionals like you in this program," he added.

Meanwhile, the Urban Greens, an indoor farm founded in 2016 and located in Makati City, aims to revolutionize the food systems by producing cleaner, fresher and smarter greens through the hydroponic system.

With the support of my colleagues in the Senate, we were able to add P529 million for this program in the 2022 budget," Go cited.

Limited F2F classes expands to Grade, High school classes

IMUS CITY, Cavite - Several public schools here commenced their hybrid limited face-to-face classes on February 14.

The schools of Bucandala Elementary School, Alapan 1 and Alapan 2 Elementary School, and the General Castañeda Senior High School welcomed a limited number of their students for the first time in more than a year of distant learning of education brought about by the COVID-19 pandemic.

While the Imus National High School had to cease the holding of the limited F2F classes for a month late last year due to the surge of the COVID cases thus, resumption of the classes today had expanded to classes in Grades 4 to 6.

Mayor Emmanuel L. Maliksi together with School Divisions Office (SDO) Superintendent Dr. Rosemarie Torres came to visit the ongoing class at the Imus National High School to personally witness the safe conduct of the limited faceto-face classes.

Covered pensioners may also submit their compliance within six (6) months before their schedule, which will be considered as early compliance.

Currently, covered pensioners can course their ACOP compliance through the following methods:

-By sending required documents to the corporate email of the nearest SSS branch (if residing in the Philippines) or foreign office (if residing abroad) using "ACOP Compliance" followed by their name as email subject for survivor pensioners, retirement pensioners residing abroad, total disability pensioners residing abroad, dependents, and guardians.

-By sending required documents through mail or courier to the nearest SSS branch (if residing in the Philippines), or foreign office or OFW-Contact Services Section (if residing abroad) – for survivor pensioners, retirement pensioners residing abroad, dependents, and guardians. -By submitting the required documents through drop box at the nearest SSS branch - for survivor pensioners and total disability pensioners residing in the Philippines.

around 20 students per grade level of a total of 80 students from Grades 7 to 10 or the Junior High School will attend the classes which runs on half the day only while eight teachers per year level will teach on campus pursuant to guidelines from the Department of Education (DepEd).

Ten students will alternately attend face-to-face classes while the other 10 students attends the same class on online platform from Monday to Friday.

The Bucandala ES, Alapan 1, and Alapan 2 ES has 120 coed students each for the limited F2F classes, while the General Castañeda SHS has 80 coed students.

"All teachers and students are fully vaccinated which is mandated by the DepED," Rosaroso said.

All students enrolled were issued pocket Wifi and tablets from the city government in aid to their online learning.

The establishment of the said methods is part of the SSS' continuing compliance with the Inter-Agency Task Force Resolution No. 100, which mandates the adoption of alternative modes of validation for senior citizen pensioners in lieu of personal appearances or submission of documents that require personal appearances before a notary public. EDITORYAL Fight for life

IF only everyone could have the quality of life Lola Iska had, then that million pesos could go a long way into rewarding hardworking, loving seniors with the means to give more to the families they will leave behind.

Among the most vulnerable sectors meted with the strictest protocols during this Covid-19 pandemic are senior citizens.

People aged 60 and above suddenly had to cease whatever was keeping them busy outside of their homes to avoid infection of the deadly virus. It happened quite fast — no more visits with family members, no more face-to-face meetings with old buddies or social groups, no more trips anywhere.

For now, they said.

But it has been two years, and we are on to the third.

In one fell swoop, the elderly felt ancient. Some lost their youthful vibe, sinking into loneliness. Even the grumpy lost their growl.

The pandemic shaved off years from everyone, not just senior citizens. The young ones lost the experience of key milestones like graduations with classmates and friends made through the years.

Couples could not have the wedding they imagined they would have with entire clans present to witness the ceremony. Families could not get together anytime they wished, and the toll this took can never be quantified.

What is there to look forward to among seniors who have witnessed many life-altering changes in the world but perhaps never quite like the one brought on by the Covid-19 pandemic?

There is one thing they could aim for now, however: a million pesos. That is if the bill that recently passed muster at the House of Representatives becomes law after its due course at the Senate.

House Bill (HB) 10647, which amends Republic Act 10868 or the Centenarians Act of 2016, seeks to grant additional benefits to Filipino centenarians from the current P100,000.

Under the bill, those who reach the age of 101 years shall receive cash gifts worth P1 million on their birthday, with a note from the President. It was a landslide vote "with 193 affirmative votes, zero negative votes, and no abstention." Everyone approves of incentivizing a desire to live longer — which is one way to look at it.

Representative Miguel Zubiri, one of the authors of the bill, said: "To provide our beloved senior citizens the motivation to live longer, as well as to aid them the means to purchase medicines and other necessities, this bill seeks to expand the coverage of Republic Act 10868 to include those Filipinos who have reached the age of 80 and 90 years old."

If only everyone could have the quality of life Lola Iska had, then that million pesos could go a long way into rewarding hardworking, loving seniors with the means to give more to the families they will leave behind.

Health is wealth, they say, but for many seniors who had spent the best years of their lives working to have a good retirement nest egg, this is not always true.

Perhaps the Senate could work fast enough to give this incentive to the centenarians — before another wrinkle pops out of our skin.

USAID, PBEd open 4,000 training slots for unemployed, out-of-school youth

MANILA -- On February 17, the United States Agency for International Development (USAID) and Philippine Business for Education (PBEd) launched new partnerships provide that will free technical-vocational skills and employability training for nearly 4,000 unemployed, outof-school youth.

USAID Mission Washburn Director Ryan and PBEd Board of Trustees Chairman Ramon del Rosario Jr. formalized the collaboration with seven private sector companies and one university from the Greater Manila Area and Cagayan de Oro. The partnership will contribute more than P42 million worth of support to co-sponsor the training needs of youth aged 18-30 under the YouthWorks PH project.

"The skills that the out-of-school youth learn will develop them into productive employees or entrepreneurs, community change makers, and leaders who will contribute to helping steer the country's economic recovery from the impacts of the pandemic," said Mission Director Washburn. "As the Philippines' enduring friend, partner, and ally, the United States remains committed to Philippine partnering with stakeholders to sustain and accelerate inclusive growth,

especially for the country's youth."

"This partnership launch builds on YouthWorks PH's existing suite of skills training resources in pandemicresilient industries. Importantly, the partnerships we are forging today will also fill gaps in vital and growing sectors, such as the automotive sector and ICT," said del Rosario.

YouthWorks PH is USAID's private sector-driven employability initiative with PBEd and is a technicalvocational training program for youth who are currently not studying, training, or employed. The project provides free skills training,

allowances, and mentoring in sectors such as construction, services and hospitality, retail, manufacturing, and logistics. Youth participants are also placed in on-the-job training slots, with the promise of employment with the partner companies once they complete the program and qualify.

The companies that joined the list of YouthWorks PH partners include Asiapro, a recognized provider of customized managed services solutions for different industries, which will provide Php40 million worth of training support to 3,000 youth in the construction industry. Universidad de Manila also signed on to provide skills training and certification programs to the youth.

Other partners include Blogapalooza, Inc., the Philippines' premier influencer marketing company, which will give 25 youth training slots in marketing and graphic design; Greencars Mindanao Corp. with

"The Workshop on Cybersecurity Network and Resilience Approaches gave an me understanding and consciousness on the information security requirements of the ICT services that the unit I belong, must take heed. To note, one of the practical applications of such understanding and consciousness has been my Crossroads Training Institute, which will offer automotive servicing courses to 50 youth of Cagayan de Oro City; Luljetta's Place, which will open at least 15 slots in kitchen and front desk services, housekeeping, and administrative positions in the Greater Manila Area; Messy Bessy Cleaners and HOUSE (Helping Ourselves Through Enterprises) Sustainable Foundation with 15 slots in social enterprise work; and Alrose Group of Companies, a franchisee of at least 16 Filipino fast food chains in Cagayan de Oro City and Iligan City which will offer at least 30 in-company training slots.

To date, the USAID-PBEd partnership has already reached nearly 4,000 unemployed and out-of-school youths, and has opened up more than 13,000 training positions in different industries nationwide. (U.S. Embassy in the Philippines)





DA inks partnerships with 3 companies for urban and peri urban agriculture

QUEZON CITY -- The Department of Agriculture (DA) entered into a partnership between three private entities to scale up the implementation of the Urban and Peri Urban Agriculture Program in the country. The agreement encourages sustainable crop production, through the establishment of more community gardens; and pushes for safe, available, accessible, and affordable foods to households and communities.

During the virtual ceremony on February 16, Agriculture Secretary William Dar signed a Memorandum of Agreement (MOA) with the Urban Farmers Sustainability Concepts Organization Inc., the Urban Greens, and the International Institute of Rural Reconstruction.

Under the MOA, DA, together with the Bureau of Plant Industry (BPI) will provide starter kits, which include seeds of common

vegetables suited in the area, soil, and Polyethylene bags, as well as technical assistance and urban agriculture module for the individual or household beneficiary and establishment.

DA will also utilize the barangay, community, school, university, and public office gardens as venues for hands-on training to showcase various urban agriculture techniques. These areas will likewise serve as community gene banks to sustain their own production and planting materials for their constituents.

Among the latest partner of DA is the Urban Farmers Sustainability Concepts Organization Inc. of Bel-Air in Makati City, which is currently constructing a community farm right at the heart of the Bonifacio Global City (BGC) to support the poor communities nearby. continue to page 2

SSS: ACOP compliance deadline is on March 31, 2022; regular schedule resumes April 1, 2022

QUEZON CITY -- The Social Security System (SSS) reiterates that the deadline for compliance to the Annual Confirmation of Pensioners' Program or ACOP is on March 31, 2022.

The ACOP, implemented in 2004, is a measure used by the SSS to ensure the continuous payment of benefits to the rightful pensioners in accordance with the Social Security Law.

All pensioners who have not yet complied with the ACOP for the calendar year 2021 are required to do so on or before March 31, 2022.

then resumed the implementation of this program last October 1, 2021, and to make up for the suspension period, we have given all covered pensioners, except those who already complied for CY 2021, a period of six (6) months or until March 31, 2022, to submit their compliance through online and alternative methods that are designed for their safety and convenience," SSS President and CEO Aurora Bong Go vows to support more measures to assist cancer patients as PH marks 3rd anniversary of signing of NICCA

Go then became close to Culiao and the senator even celebrated Culiao's sixth birthday at Philippine Children's Medical Center in 2019.

Retirement pensioners residing in the Philippines, on the other hand, are no longer required to do the ACOP effective October 30, 2017, but they are subject to other verification processes, if applicable.

The ACOP was suspended from March 2020 until September 2021 in view of the pandemic situation in the country.

"For over one and a half years, we have continuously granted our pensioners their respective pensions without the corresponding reporting under the ACOP since they are high-risk individuals to the virus. We have

If the said pensioners fail to comply, the SSS will temporarily suspend their pensions starting with their May 2022 pensions. "Starting April 1, 2022, we will

follow the usual schedule of

compliance for the program, wherein retirement pensioners residing abroad, and total disability pensioners must comply on their birth month; survivor pensioners must comply within the birth month of the deceased member; while dependents and guardians must comply on the birth month of the member or deceased member, whichever is applicable. Non-compliance to this will also lead to the temporary suspension of their pensions," continue to page 2
