All systems go in Cavite for Taal volcanic eruption response operations

Governor Jonvic Remulla convened an emergency meeting of the Provincial Disaster Risk Reduction and Management Council together with the mayors of the different cities and municipalities on January 16, 2020 at The Bayleaf Hotel in the City of Gen. Trias to discuss the impacts of Taal volcanic eruption and the current situation in the

different LGUs with evacuees from the heavily affected municipalities of Batangas.

Alert Level 4 is still in effect based on PHIVOLCS Taal Volcano Bulletin and hazardous eruption is imminent. As of the latest situation report from the Provincial Disaster Risk Reduction and Management Office, at 8:00 AM of January

17, there are currently 19 LGUs in Cavite providing temporary shelter to some 6,472 families totaling to 28,461 individuals and still counting with the continuous waves of evacuees coming in.

Some issues have been identified in the different LGUs which are also affected by the volcanic eruption particularly in Tagaytay City, the municipalities of Alfonso, Amadeo, Silang and Indang including the disruption of water and power supply. Mayor Frederick Vida of Mendez reported that MERALCO has been conducting continuous

Lawrence "Bong" Go joined the launching of the 59th Malasakit Center in the country on Wednesday, January 22 at the General Emilio Aguinaldo Memorial Hospital in Trece Martires City in Cavite, one of the areas affected by the recent eruption of Taal Volcano.

Malasakit Center is a one-stop shop for indigent and financially incapacitated patients who need medical and financial assistance from relevant government agencies, specifically the Philippine Health Insurance Corporation (PhilHealth), Department of Health (DOH),

Department of Social Welfare and Development (DSWD) and Philippine Charity Sweepstakes Office (PCSO).

"Basta Pilipino ka, qualified kang makatanggap ng serbisyo mula sa kahit saang Malasakit Center," Go said.

"Walang politika sa Malasakit Center. Pera niyo po ang ginagamit dito. Inyo po ito," he added.

President Duterte to evacuees: Gov't is behind you

STO. TOMAS, Batangas-President Rodrigo Duterte assured displaced Batangueños that the government will be giving its all-out support throughout the ordeal of the Taal Volcano eruption.

The President headed the distribution of goods to evacuees at the Polytechnic University of the Philippines - Sto. Tomas Campus this January 20 along with Senator Christopher Lawrence "Bong" Go, Department of Agriculture Secretary William Dar, Department of National Defense Secretary, Department of Health Secretary Francisco Duque III, Department of Trade and Industry Secretary Ramon Lopez, Department of Social Welfare and Development Ronaldo Joselito Secretary

Bautista and Department of the Interior and Local Government Secretary Eduardo Año.

Government calamity assistance distributed during the program included family food packs, cash assistance, animal feeds and assorted seedlings for coffee, cacao and mango among others.

The Provincial Government of Marinduque also donated sleeping mats, blankets and t-shirts.

Towards, the latter part of the program, President Duterte expressed his empathy towards Batangueños affected by the Taal Volcano eruption.

He also assured the evacuees that the government has funds to help them and it is only a matter of distribution

foreign investors and restructuring the terms of office of elected officials to the plenary for deliberations.

However, the CORE Movement appealed to Rodriguez and other House leaders to reopen discussions on their proposed amendments and allow a broader set of constitutional reforms that would open up the Charter's social, economic, political, and electoral provisions.

Rodriguez said he has also received another set of constitutional amendments being pushed by Cabinet-level Inter-Agency Task Force on Federalism and Constitutional Reforms (IATF).

"We will set a briefing in the House of the Representative Committee by next week to have the briefing of the DILG on the priority amendments to the 1987 Constitution and also from Constitutional Reform Movement on the Resolution and both of them would like to hear in Congress, so that after which we will be able to have public hearings on these very important provisions,"

Rodriguez said.

For his part, Revil stressed that the CORE Movement would promote constitutional reforms as an urgent public concern that needs to be approved by Congress and submitted to a plebiscite before the 2022 national and local elections.

"We believe that endemic social ills like corruption and the massive poverty in our regions are due to the strong legal and economic provisions in the 1987 Constitution that preserve the control over the electoral system by corrupt politicians and their cooperation with greedy oligarchs who control our economy with their control of our politicians and the justice system," Revil said.

Revil said that to preserve the mandate of voters during elections, Congress should also approve the ban on turncoatism or the switching of political party membership of elected officials after every election.

practice "The turncoatism has kept the political largesse system permanent and established corruption as source of strengthening political power in our country," Revil noted.

He said the CORE Movement would seek lobbying Congress and pass electoral reforms that will prohibit political dynasties and impose stricter rules on political parties by requiring them to ensure they have membership among ordinary voters.

Revil said the CORE Movement would also campaign for the amendment of the Constitution's economic provisions so that more capital for new industries could be sourced by opening specific trades currently limited by the 1987 Constitution to Filipino investments to foreign investments.

"We deserve freedom from oligarchs who keep control of our national and regional economies through limited investments in our industries," Revil said.

"We need more capital and innovation to create more jobs and boost our economy, especially in the regions where most poor Filipinos live," he added. (DILG/PIA-NCR)

recommendation. "Without the cap or the limit set on the number of participating riders as stated under Section 10 of the revised guidelines, the TWG cannot accurately collect data, and as such, compromising the integrity of its study," the TWG added.

In addition, the TWG said the pending cases lodged by ANGKAS before the Quezon City RTC Branch 223 and the Mandaluyong City RTC Branch 212, questionning the study's guidelines, have hampered the implementation of

"The TWG foresees its inability to gather accurate data to enable it to render any recommendation at the end of the pilot project. For this reason, the TWG hereby invokes Section 13 of the revised guidelines and recommends that the pilot implementation be terminated," the TWG said in its recommendation.

The TWG conducted an initial study on the viability of using motorcycles as taxis or as an alternative mode of transportation for six months from June 23, 2019 to December 26, 2019.

Initially participating in the study was the ANGKAS with its 27,000 riders.

Following the months of evaluation, it was recommended that the study be

extended to another three months from December 23, 2019 to March 23, 2020 with a reorganization of

TWG were tasked to review, amend and revise existing guidelines and issue necessary implementing rules and regulations in relation to the operation of motorcycle taxis.

For the extended period of the study, the TWG decided to increase the number of participating riders to 39,000 to assure that more commuters will generate feedback on the study. For the extended run, the TWG also decided to allow more motorcycle transport companies to join.

ANGKAS was then joined in the extended study by JOYRIDE and MOVE-It. A cap on the number of participating riders per transport company was also enforced to assure that there will be no monopoly of commuter experience.

The TWG also decided that the the extended run of the study be conducted only in Metro Manila and Metro Cebu.

Meanwhile, the TWG also lashed at ANGKAS violating key points in the study's implementing guidelines which have gravely affected the conduct of the study. The most glaring of these violations, according to the TWG, was the operation of ANGKAS outside of the identified study areas of Metro Manila and Metro Cebu for economic gains.

This, according the TWG has affected the data gathering process of the study.

According to the TWG, there are validated reports and apprehensions made by the Land Transportation Franchising and Regulatory Board in Cagayan De Oro, various social media accounts, and, admissions made by George Royeca, Head of Regulatory and Public Affairs of Angkas on national television, which confirmed that ANGKAS was operating outside of Metro Manila and Metro Cebu.

"The TWG is mandated to conduct a study on the viability of the motorcycle as an alternative and safe mode of public transportation and not to make a study on job generation for riders. Competition has no place in this study as this is being done to gather data and not to determine the viability for profit or income.

The TWG added that ANGKAS also did not reveal to the riding public that it is not a majorityowned corporation, which is a violation of Philippine laws.

"Angkas also did not disclose to the riding public that DBDOYC, its registered corporation name, is 99 percent foreign-owned, which is in violation of Philippine laws that common carriers should be at-least 60 percent owned by Filipino citizens. Records from the Securities and Exchange Commission have revealed that DBDOYC or Angkas is 99.996 percent owned by Angeline Xiwen Tham, a Singaporean, with P9.8 million in subscribed shares. Tham is also listed at the SEC as president of DBDOYC," the TWG said.

The municipalities of Alfonso, Amadeo, Indang, Mendez, Silang and Tagaytay were identified as priority areas for the inter-agency veterinary mission based on the initial damage report submitted by cities and municipalities. Grasses and forages used as feeds in the said towns were all covered with volcanic ash posing imminent feeds shortage.

Donations in the form of dog food, powder and injectable medicines, veterinary supplies, bottled water and other items already started coming in as early as a day before the meeting was finalized.



The PNP also provided logistical and manpower support at the onset of the eruption deploying personnel in affected areas in Batangas for rescue and evacuation and at strategic locations in Cavite for disaster response operations.

The Senator shared that he wants to spare Filipino patients from having to travel and queue up in different offices, as he observed when President Rodrigo Duterte was still the mayor of Davao City. He said that as the mayor's assistant then, he was tasked to take care of the people who were asking for medical assistance from the City Hall.

"Kaya noong naging pangulo siya, sabi ko, ano ba ang konseptong pwede nating gawin na mapabilis 'yung serbisyo? Sabi ko, pakiusapan natin ang lahat ng ahensiya ng gobyerno na pwedeng tumulong," Go said, recalling the time when he was serving as the Special Assistant to the President.

Upon Go's recommendations, the Office of the President opened the first Malasakit Center in Cebu City in February 2018, and when Go became a Senator, he filed a bill that became the Malasakit Center Act of 2019. The law, signed by the President last December, from page 1

mandates the opening of a Malasakit Center at the Philippine General Hospital and in each of the 73 DOH-run hospitals all over the country.

"Zero balance po ang target ng Malasakit Center, at merong express lane para sa mga senior citizen at person with disabilities," Go also said.

He also expressed his concern for medical professionals. "As chair of Committee on Health sa Senado, ipaglalaban ko ang pagkapanalo ng nurses sa Supreme Court," he said. During the Senate deliberations on the 2020 National Budget, he made sure that there would be enough budget for the implementation of the Supreme Court decision that the salaries of government Nurses 1 and 2 should be at salary grade 15 and 16.

"Sa DOH naman, isaslash sana nila 'yung budget. Ayaw ko pong mawalan ng trabaho ang mga medical workers-mga midwives, nurses, doctors-na mga contractual. Wala pong mawawalan ng trabaho sa DOH. Pinaglaban ko po 'yan," he said, citing the budget increase given to the DOH to improve further the country's healthcare services and ensure the welfare of health workers.

He also encouraged the nurses to serve the country instead of finding employment abroad. "Dito na lang po tayo manilbihan sa ating bansa, sa mga kababayan natin. Alam ko namang hindi mababayaran ang lungkot, kaya lang napakalaki talaga ng diperensiya po ng salary sa ibang bansa. Hindi ko naman po kayo masisisi."

The Senator also thanked the people of Cavite for helping the evacuees from Batangas, where Taal is located, even if they themselves are affected by the eruption of the volcano.

"Salamat sa mga taga-Cavite. Talagang matulungin itong mga Caviteño. Kayo po ang nag-cater sa mga evacuees mula sa mga naging biktima ng Taal. Sana huwag nang pumutok ang Taal na 'yan dahil talagang maraming apektado, paralyzed ang mga negosyo," he said.

EDITORYAL Pasaway

"MILLENNIALS have a term for this kind of belligerent leaders. They call them pasaway.

As the whole nation awaits the fireworks at the stroke of midnight tonight ushering the start of the Chinese New Year, there is an even bigger fireworks brewing down south of Manila.

It concerns the seemingly contradicting positions of the Department of the Interior and Local Government (DILG) and some local officials as regards a lockdown order that prevents people from returning to their homes and tourist-oriented Tagaytay from reopening businesses in the city overlooking the scenic but deadly Taal Volcano.

It also involves the stubborn stand by a few town officials that residents be allowed to go back to their properties following what they claimed as the simmering down of the volcano.

This is, however, far from the truth.

Following its phreatic eruption that broke over four decades of silence, Taal continued to rumble underneath, showing signs of renewed magma activity that has forced the Philippine Institute of Volcanology and Seismology (Phivolcs) to maintain Alert Level 4, meaning a hazardous eruption could occur anytime soon.

This meant the mandatory evacuation of residents at the volcano island and in the outlying towns within a 14-kilometer radius of the volcano. The initial blast, while catching everybody by surprise, did not claim any casualty, but the resulting ashfall affected the surrounding areas and reached as far up north as Metro Manila.

Tagaytay, like most Batangas towns in the vicinity of the active volcano, was not spared by the sulfuric blanket, forcing most establishments to close and tourists from coming over to the city by the ridge. They have become ghost towns.

Affected residents, meantime, were forced to flee in the safety of evacuation centers scattered around the vicinity of Taal. While the evacuees rued being separated from their animals and livelihood, Tagaytay reeled from the lack of activity in the once bustling tourist destination.

Despite a DILG order of a lockdown in nearly 200 villages, residents have sneaked in and returned to their homes while many commercial establishments in Tagaytay have reopened following the go-signal of the city mayor whose brother, now a senator, also once served in the same position. Local authorities also told the same to hotels, restaurants and other tourist spots.

A vice mayor of a Batangas town went on air to defy the order, as he urged his townspeople to go back to their respective homes, even going to the extent of saying that the danger which Phivolcs chief Renato Solidum has been talking about was merely an opinion.

The town official's pronouncements are indeed so sad.

Solidum and his staff are scientists who study and evaluate historical data and know fully well how certain volcanoes behave. Were it not for the timely intervention of then Phivolcs director Dr. Raymundo Punongbayan and his staff, Mt. Pinatubo's cataclysmic eruption in 1991 could have claimed more lives.

Just like Taal, Pinatubo's unrest started two months before with a series of small steam explosions before unleashing its full might on 15 June of that year.

Volcanologists would be the first to admit that forecasting what a volcano will do next is a challenge.


When Taal erupted last 12 January, Phivolcs was criticized for not warning the people in advance. But now that it is waving around its warning that Taal is still under Alert Level 4 and could pose a danger to people's lives, establishments refuse to listen and stubborn town officials disregard the risks of returning prematurely in the wake of the continuing tantrums of the volcano.

Millennials have a term for this kind of belligerent leaders. They call them pasaway, meaning people who don't want to be bound by restrictions or anything that could prevent them from doing what they wish to do.

Here we have authorities trying to keep them away from harm's way and we have as many pasaways in our midst. They have not learned from the lessons of the past.

Tonight, as we await the Chinese New Year fireworks, people around Taal could very well do the same — heed authorities and anticipate a bigger bang from the volcano in our midst.

We all don't want to regret the consequences.

SA sagot niya sa tuligsa ko, nagyabang gaya ng dati ang hindi kilalang kolumnistang si Manuel Buencamino: "Wala sa [K]anan, [K]aliwa o ano pa mang pagpuputol sa political spectrum ang tinatayuan ko. Ang posisyon ko ay doon lang sa tama o mali. Konsyensya at hindi ideolohiya ang gumagabay sa akin." Iyan talaga ang ilusyon niya, na ilusyon din ng marami sa panggitnang uri.

Na para bang hindi nanunuot sa halos lahat ng usapin ang tindig ng Kanan at Kaliwa, at maging ng iba pang bahagi ng pampulitikang hanayan. Na para bang hindi nagmumula ang paghusga ng tama o mali sa mga palagay o paniniwalang mas maka-Kaliwa o mas maka-Kanan. Na para bang ligtas ang konsensya sa ideolohiya at hindi laging nagkukubli ang ideolohiya sa pagwawaksi sa sarili.

Ang usapin, syempre pa, ay ang pagtuligsa niya sa Kaliwa sa pag-endorso nito sa kandidatura ni Manny Villar sa pagkapangulo at, hindi man niya sabihin, ang pagsusulong niya sa kandidatura ni Noynoy Aquino. Kesyo isinuko na ng Kaliwa ang rebolusyon dahil sa ginawa nito — mga ganoong matinding akusasyon mula sa kawalan laban sa Kaliwa para lang sa kandidatura ng isang pulitiko.

Ang totoo, kung babasahin ang mga sulatin ni Buencamino, makikita ang isang makitid na isipang mayabang na humuhusga sa isang napakalaking reyalidad, nang naggigiit sa kanyang kakitiran.

At ito ang partikular na pagpapakahulugan ni Fredric Jameson, Marxistang intelektwal, sa ideolohiya — ang mga estratehiya ng pagkahon (strategies of containment) sa makikitid na katotohanan para hindi maiugnay ang mga ito sa mas malawak na katotohanan ng kasaysayan at lipunan. Sa tulak ng makauring interes, hinaharangan ng ideolohiya ang paglampas ng kaisipan sa mga hangganan nito.

Sabi ni Buencamino, "kakatwa" ang pagbibigay-katwiran ko sa "maling diskarte ng [K]aliwa." Dahil daw "binasted" ni Noynoy ang Kaliwa kaya "sumiping" ito kay Villar. Madayang sumipi si Buencamino, pinutol ang mga isinulat kong batayan ng pakikipag-alyansa ng Kaliwa kay Villar. Pagkatapos, nagtampisaw na siya sa mahalay niyang pananalita, akala mo nakakagulat pa iyun.

Pasimplehin natin ang mga bagay. Nakipagalyansa ang Kaliwa kay Villar dahil siya ang (1) sumalubong sa plataporma ng Kaliwa sa maraming usapin, (2) nagpakita ng kahandaang makipagtulungan dito sa kampanyang elektoral at (3) nakipagkasundong magtutulak ng mga repormang sinasang-ayunan ng Kaliwa sa gobyerno kapag nahalal. Mahirap bang intindihin

Hindi pwedeng awtomatikong suportahan ng Kaliwa si Noynoy. Una, wala siyang malinaw na makabayan at demokratikong rekord bilang pulitiko. Ikalawa, ni hindi siya tampok sa paglaban sa rehimeng US-Arroyo. Ikatlo, kailangang maresolba, kahit sa isang antas, ang usapin sa Hacienda Luisita. Kaya mainam sana kung nakipag-usap at nakipagtulungan siya sa Kaliwa. Kaso, hindi.

Hindi awtomatikong sinuportahan ng Kaliwa si Villar dahil hindi tampok na maganda ang rekord niya sa tatlong ito – bagamat mas tampok siya sa ikalawa kumpara kay Noynoy. Ang inilamang niya kay Noynoy, bukod sa walang malaking isyu sa kanya ang Kaliwa tulad ng

pagsasamantala at masaker sa Hacienda Luisita, nakipag-usap siya sa Kaliwa at nakipagkasundong makikipagtulungan.

Dahil nasabi kong "sekundaryo" lang para sa Kaliwa ang paglahok sa eleksyon, pinipilit na ni Buencamino na palabasing "nilalaro" lang ng Kaliwa ang eleksyon at wala itong kahit "konting respeto" sa mga kababayan nating nagpapahalaga sa eleksyon. Maling-mali ang pakahulugan dahil ayaw umunawa. Binabasa ni Buencamino sa tekstong naisulat ko ang basurang nasa isip niya.

Prinsipyado ang batayan ng Kaliwa sa pakikipag-alyansa kay Villar. Ang ineendorso ng Kaliwa ay iyung may platapormang sumalubong, kahit kaunti, sa makabayan at demokratikong plataporma ng Kaliwa para sa bansa. Bagamat hindi mababago ni Villar o sa pamamagitan ng eleksyon ang bulok na sistema sa bansa, siya na ang pinakamabuti sa mga nangungunang tumatakbong masama sa halalan.

Pero mas ang punto: Hindi patas sa Kaliwa na sabihing inaabandona na nito ang rebolusyon dahil sa tindig nito sa isang porma ng pakikibakang itinuturing nitong sekundarya. Kung ganito ang hatol, dapat mga porma ng pakikibakang itinuturing nitong pangunahin ang maipakitang inaabandona. Hindi ka gagawa ng sarili mong pamantayan nang hindi inaaral ang pamantayan sa sarili ng Kaliwa.

Hindi patas, halimbawa, sa isang tao na masabihang tumatalikod sa pagiging Kristiyano dahil mahalay ang pananamit niya. Parang ganoon ang ginagawa ni Buencamino: sinusukat ang pagiging Kristiyano ng isang tao sa pananamit niya — sinusukat ang pagiging rebolusyunaryo ng Kaliwa sa tindig nito sa eleksyon. Isang bahagi lang ito, at hindi pa nga mayor na bahagi, ng rebolusyon.

LGU Pakil treats Taal evacuees with refreshing swim & tour

The Local Government of Pakil opens their evacuation centers to Taal evacuees offering them a special treat of free swimming and a local tour.

A total of 22 Taal eruption evacuees from Tanauan, Batangas were adopted in the town of Pakil beginning January 17, 2020. Nine of which were housed in the Talavera Evacuation Center located at Brgy. Talavera, while the others

were living with their relatives in Brgy. Rizal.

Aside from the usual assistance given to evacuees, Taal evacuees of this town were in for a treat as Mayor Vincent Soriano allowed them to use the Turumba Spring Resort Facilities for free and toured them to Pakil Church to refresh and free their minds from mental and emotional stressors. "We offered free swimming, local tours, para di sila mainitan at maibsan naman ang kanilang

pag-aala-ala (for them to refresh and somehow help ease their worries). We are doing these to uplift their spirit and support them emotionally," the mayor explained.

He said LGU Pakil is willing to accommodate more evacuees if needed as long as they are able to provide them with a comfortable accommodation, enough food, and emotional and spiritual support programs.

Other assistance continuously being given to all the evacuees are free food, medical checkups, and school supplies for student-evacuees. "We encourage them to attend school classes in Pakil," Mayor Soriano pronounced.

For continuous learning despite their situation, the local government encouraged the student-evacuees to attend classes in their public schools near them.

Ten student-evacuees were given school supplies and are currently attending at the Cornelio Celis Dalena Elem. School (CCDES) and the Kabulusan National High School (KNHS) Extension

Evacuees who were living with their relatives enjoy the same benefits and assistance from the local government.

"Kami ay pinapapunta namin sa evacuation center yung mga nakatira sa mga relatives nila para sa kanilang pagkain. Pagkakain, umuuwi na ulit sila sa relatives nila (We ask them to go to the evacuation for their food. They go back to their relatives' home after having their meals)," he stated.

The Municipal Social Welfare and Development Office (MSWDO) is continuously tracking evacuees staying with their relatives in other barangays.

The MSWDO recently assisted in fetching additional evacuees from an evacuation center in Lipa City to transfer to their relatives in this town.

"We are all Filipinos, whenever we can help, we ought to help. Whatever we can do to help, no ifs no buts, we simply do them to help," he told Philippine Information Agency Calabarzon. (Joy Gabrido/PIA 4A)

LASTING peace in Calabarzon (Cavite, Laguna, Batangas, Rizal, and Quezon) is unquestionably within reach as the Regional Task Force to End Local Communist Armed Conflict (RTF-ELCAC) boosted its efforts in pursuit of President Rodrigo Duterte's Executive Order No. 70 "Institutionalizing the Whole-of Nation Approach in Ending Local Communist Armed Conflict."

With the clear guidance of Department of the Interior and Local Government Secretary and Cabinet Officer for Regional Development and Security (CORDS), Eduardo M. Localized peace talks key to end armed conflict

but they were also provided financial and livelihood assistance to support their living, shelter, and employment.

According to DILG Region 4A, it has disbursed a total of P14.972 million worth of assistance for 116 former rebels that surrendered in the region.

At least 81 firearms, meanwhile, were also turned over back to the government since the implementation of E-CLIP in July 2018, evident of the government's giant feat in its quest to end local communist armed conflict, according to Police Regional Office IV-A.

For Secretary Año, the localized peace talks between local government officials and communist rebels is the ultimate key why more and more rebels are returning to the fold of law.

According to Año, the persevering peace and engagement efforts of local officials and their respective local peace and order councils have shed light to communist rebels to turned back on their twisted ideology and take allegiance with the government.

Collab efforts between people and government

The hands-on supervision of the CORDS also makes the policy clearer and allows the RTF-ELCAC to act with sense of urgency thus, complement the efforts of the National Task Force.

With Secretary Año's guidance and support, the RTF-ELCAC has brought together government agencies and communities in the fight against local communism.

The conduct of CORDS meetings at the actual convergence areas delivers a clear message that the government is sincere and committed to touch base with the community and address the prevailing issues. It also pushed and encouraged the local government units to prioritize the implementation of EO No. 70 in their respective areas of responsibilities.

In 2019, the five provinces comprising CALABARZON have all declared CPP-NPA-NDF (Communist Party of the Philippines-New People's Army-National

Democratic Front) as Persona-Non-Grata. They have also established their respective provincial task forces to complement the efforts of the RTF-ELCAC.





Enough time for constitutional reforms to happen by 2022, says Año

QUEZON CITY--Interior and Local Government Secretary Eduardo Año is confident that the move to amend the 1987 Constitution could pass plenary debate as Congress prepares for deliberations on the committee economic endorsing amendments which were earlier approved by the House Committee on Constitutional Amendment.

The DILG chief said there would be enough time for the Senate and the House of Representatives to let constitutional reforms happen before President Rodrigo Duterte's term ends in 2022.

"We are optimistic that this constitutional reform that we are advocating for will be heard by Congress and the Senate," the DILG chief said. "We still have enough time, although the President's remaining time is about two and a half years, which, for us, are still enough," he added.

Año said he was also confident that with the help of administration allies

in the Senate, the Upper Chamber would also open discussions and eventually approve moves to amend the 1987 Constitution.

On Monday, a movement spearheaded by civil society organizations (CSOs) and proponents of changes to some provisions in the Constitution was launched during a press conference in Camp Crame.

On the same occasion, CORE Movement officials led by former Masbate Gov. Vicente Homer "Vince" Revil turned over to Cagayan de Oro Rep. Rufus Rodriguez, the House committee chair, the group's resolution calling on both houses of Congress to approve a broad package of social, political and economic reforms in the Constitution.

Rodriguez said he would conduct further hearings on the amendments submitted by the CORE Movement through Año and Revil, the CORE Movement national chairperson.

Rodriguez' committee had already voted to put the provisions opening the country's economy to continue to page 3

TWG recommends termination of Motorcycle Taxi Pilot Study

QUEZON CITY--The Inter-Agency Technical Working Group (TWG) on the Motorcycle Taxi Service Program has announced on Monday (Jan 20) that it is terminating the pilot study of the said project.

The TWG opted to terminate the study because of legal impediments subjected to them which hampers the implementation of the progeram, rendering it ineffective to make a thorough evaluation and assessment of the Motorcycle as public transport.

In a statement, the TWG said the consequence of such termination would mean that all Motorcycles engaged in public transport are now considered illegal, as there is still no enabling law which would override or amend existing ones that state the strict prohibition of Motorcycles for public transportation use.

However, in the Senate hearing, several senators and other Motorcycle stakeholders raised their concerns on the impact of the termination, and TWG recognized and appreciated these sentiments.

It is therefore convening soonest, and will also have a consultation meeting with all of the participants in the pilot study, together with resource persons

and experts, to finalize a decision and eventual direction on how best to proceed with the Motorcycle Taxi Service Program.

The Motorcycle Taxi Pilot Study aims to determine the viability and safety of motorcycles as taxis or alternative modes of public transportation.

In its recommendation to Congress, the TWG stressed that the earlier issuance of a 20-day TRO by the Quezon City RTC Branch 223, which temporarily prevented it from implementing Section 10 of the revised guidelines with regards the imposition of the rider cap, had greatly compromised the integrity of the study's data gathering design.

The rider cap of 30,000 riders in Metro Manila and 9,000 riders in Cebu, aimed to divide equally among the three participating motorcycle transport companies in the study - ANGKAS, JOYRIDE and MOVE-It - the number of participating riders to generate a wider field of commuter ride experience input.

"As a result of the 20day TRO, the integrity of the study was compromised as the data gathering design set by the TWG was hampered and allowed the unfettered entry of motorcycle taxis, eschewing continue to page 2
