DILG culminates NEO orientation for local execs, urges them to step up in journey towards good governance

CITY--QUEZON The Department of the Interior and Local Government (DILG) culminated today its newlyelected officials (NEO) orientation program for the country's 81 firsttime and re-elected provincial governors as it challenged them "to step up in the journey towards good local governance."

"We have made great leaps but we will have mountains to hurdle. As the highest level of local government units (LGUs), provinces are demanded to step up in the fight against illegal drugs, insurgency, and corruption," DILG Secretary Eduardo M. Año said during the activity held at Crowne Plaza, Ortigas Center in Quezon City.

for a society that thrives in development, bannered by a government prioritizing local governments," he added.

The NEO program is a continuing intervention of the DILG through the Local Government Academy (LGA) in its commitment to provide a harmonized and holistic capacity development delivery mechanism for local governments all over the country.

The three-day orientation course on Priming Local Leaders for Effective Governance jumpstarted the series of activities under the NEO program where the newlyminted governors crafted their respective First 100 Days Plan and Executive Agenda.

"May this orientation "I urge you to push keep the fire of public service

ablaze in your hearts as you carry your sacred duties dignity,"said DILG with Undersecretary for Local Governance Marivel C. Sacendoncillo.

The NEO orientation course is composed of six modules, namely Local Governance and the Evolving role of Local Building Leaders; Resilient Local Governments; Leadership for Peace and Development; Localizing the Philippine Anti-Illegal Drugs Strategy; Solution-Seeking Sessions on Key Governance Issues; and Setting Your Governance in Motion.

LGA Executive Director Thelma Vecina explained that the NEO program is a complete innovative package aimed to enhance the competencies of the 43 first-timers and 38 reelected governors in carrying out their new tasks as leaders in continue to page 3

Help continues to pour in for **Bacoor fire victims**

BACOOR CITY, Cavite - The City Government here through the City Social Welfare and Development Office and other concerned agencies led in last week's disaster relief efforts for the fire-affected families of Sitio Silangan, Brgy. Talaba.

The recent fire which ravaged hundreds of houses on July 5, left about 290 families homeless while around 162 families still remain in the barangay covered court here as of July 9.

Bacoor City Mayor Lani Revilla personally led the distribution of relief goods on Sunday, July 7, together with Vice Mayor Karen Sarino and several city councilors, with goods such as basic household cooking utensils, canned foods,

noodles and rice to help the family get by.

Meanwhile, Senator Bong Go also visited the evacuation center to give relief goods consisting of clothes, food packs, and financial aid as he promised to help buy uniforms and school supplies for the school children affected by the fire.

Go consoled the affected residents with an assurance of help not only financial support but the possibility of livelihood through the cooperation of concerned government agencies in the region such as the Department of Trade and Industry (DTI). During the event, Año also called on the support of the public to help the government end the 50-year-old communist insurgency in the country by declaring the New People's Army as persona non grata and at the same time, convincing them to lay down their arms and rejoin society.

DTI warns establishments selling substandard productsyear-on-year

QUEZON CITY-The Trade Department of & Industry (DTI) warned business establishments selling substandard products after the nationwide inspection drive conducted by the Fair Trade Enforcement Bureau (FTEB), Bureau of Product Standards (BPS), Philippine Accreditation Bureau (PAB), and DTI Regional Offices.

In one of the inspections conducted in Valenzuela City on July 5, 2019, DTI Secretary Ramon Lopez and Consumer Protection Group Undersecretary Ruth Castelo led an inspection team that caught two stores selling substandard products.

One store was selling substandard or underweight steel bars and wires with no Philippine Standard certification marks (PS marks), while another was found selling PVC pipes and toilet wares without PS marks.

The substandard products were confiscated. Notice of Violation were also issued to the violating stores which they need to answer within 48 hours. They will also be charged a penalty ranging from P17,500 to P35,000.

The team also inspected a steel manufacturing plant in the area and found that they complied with the product standards and testing equipment required by the DTI.

Lopez said that daily inspections by the FTEB have led to the decrease in violators

conducted more than 13,000 surprise drug testing, which led to the dismissal of drug users within the organization.

The President also lauded BJMP awardees for their unwavering passion and dedication to service to ensure the welfare of prisoners.

He reminded BJMP personnel that as they forge stronger linkages and partnerships with local government units, other government agencies, and non-governmental organizations, they should always stay dedicated to their shared responsibility in Metro Manila. The agency is now intensifying monitoring efforts in other regions to stamp out substandard materials in the market.

"Selling substandard products is not good for your business, since you will not establish credibility," Lopez warned hardware owners.

"If you are caught selling them, you will be fined and we will confiscate your products, thus losing your investment. In selling these products, you are deceiving and endangering consumers and the public," Lopez added.

The DTI through Department Administrative Order 18-03:2018 enumerates products monitored by the Agency for appropriate standards. These include home appliances and electronic products, building and construction materials, and chemical products like fire extinguishers and LPG tanks.

Lopez advised consumers to constantly look for PS marks or Import Commodity Clearance (ICC) stickers on the products they buy. If they find stores selling substandard products, they should inform DTI through its Consumer Care Hotline 1-384 (1-DTI) or email to consumercare@dti.gov.ph.

The trade secretary said that intensifying enforcement of product standards is part of President Rodrigo Duterte's Tapang at Malasakit campaign to protect the safety and welfare of the Filipino people. (PIA InfoComm/DTI)

DepEd, TESDA formalize agreements on TVL education

TAGUIGCITY -- The Department of Education (DepEd) and Technical Education and Skills Development Authority (TESDA) on Tuesday signed a Memorandum of Understanding (MOU) establishing a Joint Working Group (JWG) to harmonize technical-vocationallivelihood (TVL) education and skills training in the Philippine basic education system.

Education Secretary Magtolis Briones Leonor recognized the importance of working in synergy with TESDA. "The President himself, during the last Cabinet meeting, recognized the importance and the role of TESDA, especially in our efforts to provide gainful employment for our young people, those who may not necessarily proceed to college or university education," Briones stated. "This signing of the MOU merely formalizes what we have been doing together."

Meanwhile, TESDA Secretary Isidro Lapeña expressed certainty that the partnership with the Department will be very productive: "We look forward to working with DepEd in building the TVL track in Senior High School (SHS) from this year onward. We hope that this continuing partnership will result in positive outcomes and will benefit also the future generations of SHS students."

DepEd and TESDA are creating a JWG on technicalvocational education and

training (TVET), comprising members from each five agency, who will be primarily in charge of recommending policies, decisions, or activities for the harmonization and complementarity of strategies, policies, and programs on TVE and skills training, consistency and quality assurance of training regulations (TRs) and standards, and discussion and resolution of concerns as may be raised by either party concerning TVET.

The group is also expected to have an agreement on common researches and innovation programs and a consolidation of trends and data pertinent to TVET.

DepEd Undersecretary and Chief of Staff Nepomuceno Malaluan likewise cited that the MOU aims to establish a more institutionalized platform for coordination to enable a more responsive provision of TVL education. He added that with this partnership, the quality of graduates would better meet industry needs.

"We need a strong coordination with TESDA on a number of issues. One is on the continuous review of our techvoc offerings to make sure this is what the economy and industry need. We also have to ensure that our graduates and the graduates of TESDA adhere to common quality assurance standards," Malaluan explained. (DepEd)

He said that bruising and other symptoms of hemophilia must be taken seriously and should be consulted immediately to doctors.

of Health (DOH) for the allocation of Factor 8 (F8) concentrate to the Gen. Emilio Aguinaldo Memorial Hospital (GEAMH). Clotting factor concentrate prophylaxis aims to preserve joint function by converting severe hemophilia (factor VIII or IX less than 1%) into a clinically milder form of the disease. This news provided more hope to PWH given the fact that very few hospitals have the capacity to handle patients with bleeding disorders.

On the other hand, PWHs in Cavite gave testimonials on the challenges they face day by day, from pain levels, to hospital bills, transportation, down to stories of being refused by healthcare providers whenever being informed of their case. To assist them, Social Welfare Officer III Brendalvn Salazar of PSWDO discussed the simplified procedure and requirements on seeking financial/medical assistance, as well as on requesting for wheelchairs to the Office of the Provincial Governor. She also pledged that their office will lobby for PWH patients to be included in the special cases like chemotherapy and dialysis patients who are qualified to receive financial assistance from the provincial government on a regular term. The statement uplifted the spirits of hemophilia advocates, patients and their families, knowing that their needs are also being addressed by the government. In closing, PHO's Blood National Program Coordinator Ralph Laurence

Pasaraba urged the governors to further upscale their level of good local governance by passing all the seven areas of the Seal of Good Local Governance.

These include financial management, disaster preparedness, social protection, peace and order, businessfriendliness and competitiveness, environment management, tourism, and culture and arts.

"The robustness of local governments is the robustness of the DILG. We are partners in promoting the excellent performance of local governments," Pasaraba said. (PIA InfoComm)

acknowledged the Figueroa, organizers and participants who made the event possible, underlining the significance of equitable distribution of resources, giving priorities to indigents in the province, since majority of Filipinos with bleeding disorders live below poverty line as per study of HAP. Hemophilia is a geneticallyinherited bleeding disorder in which the person's blood does not clot normally. People with hemophilia can experience spontaneous bleeds with no known cause, internal bleeding and painful swollen joints. Medical scientists have not found a cure yet for what is termed a Royal Disease. Symptoms of hemophilia may include nosebleeds, bruising, bleeding for no reason, blood in urine and stool, nonstop bleeding after a cut, tooth extraction or circumcision or a heavy prolonged menstruation. Understanding hemophilia is a great first leap towards achieving the "Right to Live" campaign of HAP. There are about 10, 000 Filipinos with hemophilia and about a million others with von Willebrand disease and other bleeding disorders in the Philippines, but only about 1,500 have been registered with the Philippine Hemophilia Foundation. In Cavite, as of June 2019, according to HAP-Cavite Chapter there are 28 registered patients in their organization while others are yet to be identified.

EDITORYAL **New breed**

LIKE a whiff of fresh air, the emergence of a new breed of local leaders in the mold of Isko Moreno, Vico Sotto and Francis Zamora is indeed exhilarating.

No less than the Interior and Local Government Secretary, Eduardo Año, praised the young and dynamic mayors in Metro Manila who, right at bat, made drastic changes in their respective cities - Moreno in Manila, Sotto in Pasig and Zamora in San Juan.

The three took over from traditional politicians whom they clobbered in the last midterm elections.

Año said he has high hopes for the young leaders whom he called the faces of change in the political landscape.

Moreno, who toppled a political giant in Joseph Estrada, swept major areas like Divisoria, Blumentrit and Carriedo of sidewalk vendors and slammed sledgehammers on video karera machines and illegally-built barangay barracks, all in his first week in office. He sacked nine police officers from the Manila Police District station 11 over their failure to address illegal vendors in Divisoria.

The new mayor, who rose from the slums, publicly shamed bribers whom he said offered P5 million a day, P150 million a month and P1.8 billion a year in exchange for keeping the vendors on the streets. "If you see the vendors and the chaos back, that means I have accepted the bribe," he was quoted to have said. Sotto, who ended the 27-year hold of the Eusebio clan in Pasig, had for his first official act an order stopping the apprehension of violators of the odd-even scheme, one of the biggest complaints of residents and motorists. The son of comedian Vic Sotto and former actress Coney Reyes also formed a task force that would review the city's overall traffic situation and program. The first executive order of Zamora, who defeated former actress Guia Gomez, mother of former Senator JV Ejercito, aims for more transparency in the city's expenses. The order institutionalizes the local government integrity system to keep tabs on all government transactions.

Matalas na nasapul ng sumikat na hashtag sa social media na #BigasHindiBala ang kawalangkatarungan ng paggamit ng baril laban sa mga magsasakang humihingi lang ng bigas na makakain bilang tulong ng gobyerno sa panahon ng tagtuyot dulot ng El Niño.

Mas malamang, gayunman, na ang ikinabahala ng mga opisyales ng gobyerno ay hindi ang mismong pamamaril at pagpatay sa mga magsasakang nanawagan ng bigas. Mas malamang, ang ikinabahala nila ay ang katotohanang maraming video footages na nagpapakita na mga pwersa ng Estado ang siyang nagsimula at mismong nagsagawa ng karahasan. Dawit samakatwid silang opisyales ng gobyerno na nag-utos ng pandarahas.

Sa harap ng mabigat na krimen at matibay na ebidensya, maaasahan nang hakbangin ng gobyerno-kung gusto nitong bigyangkatwiran ang pandarahas at umiwas sa pananagutan, at malinaw na ganito nga ang gusto nito – ang maglabas ng masasahol na kasinungalingan. Sa takbo ng mga pangyayari, ang napiling kasinungalingan ay: Ginamit ng Kaliwa – militante, Komunista, New People's Army - ang mga magsasaka.

Dahil ang Kaliwa ang gustong idiin ng gobyerno, mahalaga sa paghahasik nito ng kasinungalingan ang mga espesyal na ahente nito laban sa Kaliwa, na mas mapanlinlang dahil nagpapakilalang galing sa Kaliwa: ang Akbayan. Hindi kataka-takang walang kapaguran, halimbawa, ang mag-inang akademikong Akbayan na sina Sylvia Estrada-Claudio at Leloy Claudio sa pagpapalaganap ng naturang kasinungalingan sa Facebook. Siguro'y kumuha sila ng payo kay Gabriel Claudio, bayaw ni Sylvia at tiyuhin ni Leloy, na tagapayo ni Gloria Macapagal-Arrovo noong masaker sa Hacienda Luisita noong Nobyembre 16, 2004: sisihin ang Kaliwa! Kung may magtatyaga lang, madaling ilantad ang pagiging reaksyunaryo at mababaw ng mga sulating "akademiko" nila, at anumang kasikatan nila sa social media ay dahil sa mga loyalista ni Noynoy Aquino at anti-Kaliwa. Sa ganitong konteksto mailulugar ang "Lessons from Kidapawan: The left and the question of accountability," sanaysay ng isang Emman Hizon. Nagpapakilala siya sa artikulo na "research and policy analyst" ng Active Citizenship Foundation na ngayon lang narinig ng marami. Pero noon, nang nantaboy siya ng mga aktibistang nagprotesta sa presscon ng Akbayan, tahasan siyang nagpakilalang opisyal sa propaganda ng grupo.

Para ilusot ang puntong may kasalanan din ang Kaliwa sa nangyari sa Kidapawan, todo ang pagpapanggap ni Hizon. Kesyo ang gobyerno naman talaga ang pangunahing may pananagutan. Kesyo 18 taon na siyang sosyalista, at sinsero at servoso ang kanyang pag-aanalisa sa sanaysay. Kesyo maalam siya sa mga taktika sa militanteng protestang lansangan. Kesyo ang layunin niya ay iabante ang pulitikang maka-Kaliwa sa Pilipinas.

Sa totoo lang, nakakabwisit basahin ang sanaysay ni Hizon. Sa bulok na paraan pa lang ng paglalatag ng argumento, malalaman mong bulok na ang mismong kongklusyong tinutumbok. Puro akusasyon na walang solidong batayan. May mga bahaging hinayhinay na pag-iisip, na rururok naman sa todong kasinungalingan. Pinahaba nang husto na parang may bayad ang bawat salita; dinaan sa Ingles sa halip na sa nilalaman.

Ilan munang sekundaryang punto na naglalantad sa kung anong tipo ng "maka-Kaliwa" si Hizon - na kampi sa neoliberal at mapanupil na gobyerno ni Aquino. Una, sabi niya, "nabigo" ang kapulisan na magpatupad ng "maximum tolerance." Napakabait na paghatol nito. Nasa highway ang protesta, pero nagtatanggol lang, hindi naggigiit ang mga magsasaka. Bawal magdala ng baril sa protesta, pero todong ginamit ito ng pulisya.

Ikalawa, sabi niya, "Ang pakikibaka para sa mas mainam na Kaliwa ay pakikibaka para sa mas mainam na gobyerno." Hindi ito opinyong maka-Kaliwa kundi opinyong liberal. May katangiang makauri ang gobyerno ngayon: hawak ng malalaking burges-komprador at panginoong maylupa na tuta ng impervalismong US. Kailangan itong ibagsak, hindi ireporma lang, para makapagtayo ng gobyernong mas mainam. Nakasalalay si Hizon sa isang susing akusasyon sa Kaliwa, sa tinawag niyang "instrumentalismo." Kung isasantabi ang mga pangkalahatang satsat niya tungkol rito, ito, aniya, ay ang pagpapasabak ng Kaliwa sa mga magsasaka sa "reaksyunaryong para karahasan" "matuto ng pampulitikang leksyon," para yakapin ang "armadong pakikibaka." Aniya, ginusto o pinahintulutan ng Kaliwa na mabaril ang mga magsasaka. Minsan nang sinagot ni E. San Juan, Jr., Marxistang intelektwal, ang akusasyong may "instrumental na pagtingin sa tao" ang mga maka-Kaliwa, partikular ang mga Marxista-Leninista. Aniya, hindi alam ng mga nag-aakusa ang mayamang

tradisyong Marxista. Mas mahalaga, instrumento ng mga anti-Komunista noong Cold War, hindi ng Kaliwa, ang konsepto ["The Struggle for Socialist Transformation in the Philippines,' 1996].

Konsepto nga naman ng mga anti-Kaliwa ang instrumentalismo. Pilit nitong inihihiwalay ang Kaliwa sa masang anakpawis na pinaglilingkuran, inoorganisa, at pinagmumulan ng lakas nito. Pinagmumukha nitong masama ang ugnayan ng Kaliwa at masa. Ibinabalik nito sa Kaliwa ang tuligsa ng huli sa kapitalismo at mga naunang sistemang makauri: na pinagsasamantalahan ang masa na parang mga instrumento.

Para kay Hizon. instrumentalismo ang dahilan kung bakit ipinagpatuloy ng mga organisador ng Kaliwa ang protesta kahit "may tsansang papaputukan ng mga pulis ang mga magsasaka" dahil "mayroon nang mga armadong pulis sa lugar bago magsimula ang marahas na dispersal." Pero agad binalewala ito nina Kidapawan Mayor Joseph Evangelista at Alex Tagum, hepe ng Philippine National Police sa probinsya at sinimulan ang

pamamaril.

Makatwiran man ang protesta ay marahas ang Estado. Dahil dito, tungkulin ng mga organisador na tiyakin ang kaligtasan ng mga nagpoprotesta. Alam ang lahat ng iyan ng Kaliwa. Sa kaso ng Kidapawan, hindi nagkulang ang mga organisador sa usaping ito; mas namayani ang pagiging mapanupil ng Estado. Ang problema kay Hizon, agad ang pagsisi niya sa Kaliwa dahil sa anti-Kaliwang konsepto niya, ang instrumentalismo.

Kung susundan pa ang lohika niya, laging dapat maghanap ang mga nagpoprotesta ng posibilidad na magkaroon ng matinding pandarahas, lalo na ng pamamaril, para iatras ang pagkilos. Ilang pulis kaya? Ilang mahabang armas? Ilang distansya mula sa hanay? Kung susundan ang baluktot na lohika ni Hizon, walang dapat maganap na pagmasaker sa nagpoprotesta, pero iyan ay dahil walang dapat maganap na militanteng protesta.

Statement on the suspected food poisoning incident at Imus Institute of Science and Technology


PASIG CITY -- Following reports of a suspected food poisoning incident involving at least 40 Junior High School students at the Imus Institute of Science and Technology-Campus. Dimasalang the Department of Education (DepEd) reiterates the strict enforcement of its policies and guidelines on healthy food and beverage choices in schools, learning centers, and DepEd offices.

An incident report from the Health Services Department of the private Cavite school states that around 23 students experienced abdominal pain and vomiting and were given first aid on July 10.

The following day, 39 students were examined in the emergency room of nearby hospitals. Ten were admitted at Our Lady of the Pillar Medical Center, three at the Medical

EVERY month of July, the country observes Nutrition Month by virtue of Presidential Decree 491, s. 1974, or better known as the Nutrition Act of the Philippines and declaring the Nutrition Month shall be held every July to create greater awareness on the importance of nutrition among Filipinos.

Now on its 45th year, the theme of this year's Nutrition Month

of healthy diets, increased physical activity, and reduced sedentary behavior through activities of daily living among individuals and families; encourage the food industry including farmers, manufacturers, distributors and food establishments to produce and make available healthier food options; and advocate for the enactment of national and local legislation/policies and policies at the workplace, school and other venues that are supportive of

(1-4 years old) to spend at least three (3) hours in a variety of types of physical activities at any intensity, spread throughout the day. The more the better.

For 1-year-old: sedentary screen time (watching TV or videos, playing computer games) is not recommended.

Children above 2 years old: sedentary screen time should be



Center Imus, and one at St. Dominic Medical Center, with the initial diagnosis of acute gastroenteritis. Two of them were already discharged as of July 12.

The same report signed by the school's Vice President for Academic Affairs noted that they are still awaiting further medical reports from the said hospitals.

While its existing orders on the operation and management of school canteens, including DepEd Order No. 8. s. 2007, cover public elementary and secondary schools, DepEd enjoins all private schools to mandate the strict enforcement of food safety standards in their cafeterias including the implementation of hygienic practices on food preparation,

no more than 1 hour - less is better. When sedentary, engaging in reading and storytelling with a caregiver is encouraged.

For good quality of sleep, 11-14 hours of sleep is recommended for children aged 1-2 years old while 10-13 hours of sleep for 3-4 years old.

Children aged 5-12 years old and adolescents to young adults (13-20 years old), it is advised to engage in at least 1 hour daily physical activities consisting of any one or a combination of the following active travel and daily tasks: walking, biking, climbing the stairs, sweeping the floor, washing the dishes, and other household and school chores.

Instead of using gadgets, parents and guardians are advised to encourage their children to engage in high impact plays at home and school such as running, skipping, and playground activities.

It is also best to encourage children to play traditional Filipino games such as: luksong tinik, patintero, tumbang preso, agawan base, piko, etc.

physical Meanwhile, activities can also be performed in the workplace. Many office workers spend up to 8 hours or more sitting. Sitting too much increases the risk of obesity, cancer, heart disease, diabetes and premature death.

It is advised to do a

cooking, display, serving, and storage. They shall also train all canteen personnel on proper and safe handling of food.

DepEd likewise reiterates the establishment of monitoring teams in the regional and division offices to ensure adherence to food safety standards and the guidelines on operations of school canteens, to avoid food poisoning and other similar incidents that pose health risks to learners.

Finally, the Department reminds all schools to make healthier food and beverage choices available to learners and personnel, as directed by DepEd Order No. 13, s. 2017 (Policy and Guidelines on Healthy Food and Beverage Choices in Schools and in DepEd Offices). (DepEd)

activities 2-minute physical (walking, stair climbing, stretching) for every hour of sitting.

For adults aged 21-45 years old, accumulation of 30 minutes to 1 hour of daily physical activities is advised. While for adults aged 46-59 years old, it is advised to accumulate at least 30 minutes of daily physical activities consisting of any one or combination of the following: ironing of clothes, cooking, mopping the floor, arranging clothes, doing the laundry, basketball and other sports, stretching, dancing, swimming, jogging.

For seniors (60 years old and above), it is advised to accumulate at least 30 minutes of daily physical activities consisting of any one combination of physical activities including mild and easy daily tasks or household chores like: climbing the stairs, walking, gardening, folding clothes, watering the plants. Seniors may require assistance for some of the activities.

Maintaining a healthy diet, engaging in regular physical activity, abstinence from smoking, avoidance of alcoholic beverages and management of stress are key strategies in the prevention of overweight, obesity and lifestylerelated non-communicable diseases such as cardiovascular diseases, diabetes, cancer and chronic respiratory diseases. celebration is "Kumain nang wasto at maging aktibo ... Push Natin 'to!" NNC-NCR

According to the National Nutrition Council (NNC), the theme encourages everyone to advocate and realize the importance of healthy diets, increased physical activity and reduced sedentary behavior. Pushing the advocacy means that each and every one can contribute to better nutrition and physical activity for better health.

Meanwhile, the Nutrition Month logo for the theme shows the balance that needs to be achieved through healthy diet as symbolized by the leaf of a vegetable and physical activity by moving figures of people.

Some IEC materials on nutrition

The objectives of the campaign aims to promote the consumption an enabling environment for healthy diets and physical activity.

The key messages of the Nutrition Month are: have one (1) hour or more of physical activity every day; reduce screen time to two (2) hours or less each day; and eat three (3) food groups every day for variety.

A physical activity is any bodily movement produced by skeletal muscles that requires the expenditure of energy and produces progressive health benefits (National Institute of Health, 1995).


The four (4) categories of physical activity include: work-related (e.g. lifting of office supplies); non-work related (e.g. household and school chores); travel-related (e.g. walking to a bus terminal); and leisure-related (e.g. going for a morning jog).

It is advised for children

Have hour or more of physical activity every day

Reduce screen time to 2 hours or less each day.

Eat the 3 food groups every day for variety.





At the end of the workshop, the participants crafted their respective countries' communication, education, and public awareness strategies in promoting and advocating biodiversity conservation through their nature parks, focusing on engaging different sectors of government and society and emphasising that conservation is a shared responsibility.

Participants visited the Tunku Abdul Rahman National Park and the Kinabalu National Park – both nature parks are known for good practices in implementing sustainability mechanisms, ecosystem-based approach, multi-stakeholder cooperation, and biodiversity information management.

The Tunku Abdul Rahman Park is a state park located in Gaya Bay, three kilometres offshore from Kota Kinabalu. Named after Malaysia's first Prime Minister, Tunku Abdul Rahman, it was gazetted in 1974 as Sabah's second national park. The park, which covers an area of 50 square kilometres comprising five islands, their surrounding reefs, and sea, has good programmes to protect fauna, flora, and marine ecosystems. Geologically, the islands are part of the Crocker Range but became isolated from the massif when sea levels rose after the last ice age. There is also a jungle trail located at Base Camp in Pulau Gaya. The trail that stretches around half a kilometre is enough to generally educate visitors on various aspects of the marsh jungle.

The names of the islands are symbolic of their history and early discoverers. The islands are Pulau Gaya ('big'), Manukan ('fish'), Mamutik('shell collection'), Sapi (the sound of a mowing buffalo), and Sulug (commemorating the ancestry of the Sulu peoples of Sabah). Initially, the park covered two islands – Gaya and Sapi. In 1979, the park's boundaries expanded to include three other islands: Manukan, Sulug, and Mamutik. The administrative centre of Tunku Abdul Rahman Park is in Manukan island, although each of the five islands has its own administrative offices.

The Kinabalu National Park, with a total area of 75,370 hectares, is an outstanding example of a diverse landscape that appeals to adventurous travelers, tourists, and researchers alike. Its headquarters and several substations along its boundaries offer easy access to the challenging Mt. Kinabalu Summit Route, various botanical gardens, nature trails, and waterfalls while researchers venture further into its deep rainforest to discover even more of the park's rich biodiversity and ecosystems. Mt. Kinabalu is one of the youngest volcanic mountains in the world and was formed within the last 10 to 35 million years. Standing at 4,095 metres, it is the focal point of the park and one of the most accessible mountains in the world. The different vegetation zones at Kinabalu National Park range from lowland dipterocarp forest to lower montane oak-chestnut forest, upper montane or cloud forest, and subalpine meadow near the summit plateau of Mt. Kinabalu. The botanical sites contain a variety of flora and fauna that ranges over four climate zones from rich lowland dipterocarp forest to alpine meadow plants, and finally the stunted bushes of the summit zone. The mountain is also known for its many carnivorous plants and orchid species, most notable the Nepenthes rajah. It is also home to a multitude of endemic animal species, including the Kinabalu Giant Red Leech and Kinabalu Giant Earthworm. The park also plays host to a variety of birds, insects, mammals, amphibians, and reptiles. (ACB)



President Duterte vows to improve country's prison infrastructure

MANILA-- President Rodrigo Roa Duterte on Friday assured the Bureau of Jail Management and Penology (BJMP) that his government will continue supporting the bureau's initiatives, particularly in building more infrastructure to address jail overcrowding.

"Always keep in mind that this administration will continue to pursue measures that will empower you in addressing the perennial problem that you face, particularly jail congestion," the President said in an address during the 28th anniversary of the BJMP at the AFP Theater, Camp Aguinaldo.

He announced during the event that the government has allotted P3 billion for the construction of 60 new jail facilities to reduce jail congestion. Prisoners, he said, are still human beings who deserve habitable prisons.

"They are human beings and

we are supposed to give them habitable prisons. Kaya lang, inuuna natin the order of priorities, sometimes they are really forgotten," President Duterte said.

The President also commended the BJMP for its crucial role in the administration's campaign against illegal drugs by working with the Philippine National Police (PNP) and the Philippine Drug Enforcement Agency (PDEA).

"I am pleased that your conduct of the almost 30,000 Greyhound Operations from January to...2019 has led to the confiscation of the illegal drugs, weapons, and almost P2 million worth of cash and other contraband from jail cells," he said.

As part of its efforts to ensure the integrity and professionalism of prison personnel, the BJMP

Año: Crime volume down by 11%, 12k barangays drug-free

QUEZON CITY-- On President Rodrigo Duterte's third year in office, the Department of the Interior and Local Government (DILG) reported that crime volume dipped by 11 percent and around 12,000 barangays are now drug-free as a result of "participatory governance" or the active collaboration between the government and the local government units (LGUs), citizens, and other stakeholders. "Malaking bahagi kayo sa naging tagumpay ng mas pinaigting na peace and order councils (POCs), anti-drug abuse councils (ADACs) at people's law enforcement board (PLEB) sa labang tuluyan nang tapusin ang mga problema ng ating lipunan," said DILG Secretary Eduardo M. Año during the Pre-SONA (State of the Nation Address) forum of the Participatory Governance Cluster (PGC) held in Cebu City. Año said that with the help and support of local based institutions like the POCs, ADACs, and PLEB, "law enforcement agencies successfully re-calibrated their anti-criminality operations" leading to a decrease in the crime volume from 488,644 for the

period of July 2017 to June 2018 to 438,496 for the same period in 2018-2019.

"Through our partnership, we have proven that the government actually walks its talk and our efforts in participatory governance bear fruit and do not fall into the void of empty words and ineffective thrusts," he said. In the campaign against illegal drugs, the DILG Chief proudly said that 12,099 barangays have already been declared drug-free with the backing and support of a vigilant citizenry. Similarly, there are now 172 drug-free jail facilities as compared to only 74 in 2018 due to the Bureau of Jail Management and Penology's intensified efforts to clear jails of illegal substances. "Nakamit natin ang tagumpay na ito dahil sa pinaigting na operasyon ng ating mga alagad ng batas at sa suporta ng mga mamamayan na siyang pinagmumulan ng mga impormasyon tungkol sa iligal na droga," he said.
