SSS taps local fund managers for P7B funds

QUEZON CTY-- State-run Social Security System (SSS) tapped nine (9) domestic fund managers to manage part of its Investment Reserve Fund (IRF) worth P7 fund's earnings from investments. SSS President and CEO Aurora C. Ignacio said the pension fund deployed P1 billion each for three Balanced Fund Mandates, three Pure Equity Fund Mandates, and one Pure Fixed Income Fund Mandate. An investment mandate

is an instruction to manage the pool of capital or funds, using a specific strategy and within certain risk parameters.

Earlier, SSS opened billion to help improve pension the bidding to hire nine local fund managers to manage the P9 billion investible funds which are divided equally to three types of mandate namely: Balanced Fund Mandate, Pure Equity Fund Mandate, and Pure Fixed Income Mandate.

Ignacio said the local



BACOOR CITY, Cavite – The construction of the LRT1 Cavite extension recently commenced after its initial groundbreaking ceremonies two years ago.

The event was attended by Congressman Strike Revilla and then-Parañaquecity mayoral candidate Edwin L. Olivarez and officers of the Department of Transportation.

The project was

Manila Corporation (LRMC) five years ago with estimated cost of P64.9-billion and is projected to be completed and



DSWD helps facilitate release of salaries of 4Ps workers in BARMM

QUEZON CITY -- The Department of Social Welfare and Development (DSWD) is working closely with the Department of Budget and Management (DBM) to help facilitate the release of salaries of Pantawid Pamilyang Pilipino Program (4Ps) implementors in the Bangsamoro Autonomous Region for Muslim Mindanao (BARMM).

This developed following a news report that was aired over a TV station in Cotabato on the unpaid salaries of more than 1,000 4Ps workers in BARMM.

The Department has, likewise, exerted efforts to assist the Ministry of Social Welfare

BARMM facilitate the request to release the funds intended to implement various programs of DSWD to include the 4Ps.

Through the letter request of DSWD dated May 30, 2019, the transfer of funds was granted to the government of BARMM last June 3, 2019 which covers the program funds to include salaries and operating expenses.

Ministry of Social Welfare BARMM to submit a revised monthly disbursement plan (MDP).

Last Friday, the Department met with the officials of BARMM to request an update on the submission of the MDP. During the meeting, the Ministry of Social Welfare BARMM

informed DSWD that it already submitted the revised MDP to DBM, but which needed further enhancement. It committed to submit the enhanced version by Monday, June 10. As soon as the enhanced MDP is received by DBM, the Notice of Cash Allocation (NCA) shall be released immediately and the Ministry of Social Welfare BARMM may start processing the payroll.

DSWD vows to assist the Ministry of Social Welfare BARMM until the matter is resolved. It also emphasizes that it will continue to adhere to the principles of good governance, transparency, and accountability in all its operations and program implementation. (DSWD)

EDITORYAL

A post-election scenario

Luis Antonio Cardinal Tagle, the opinionated, intolerant and highly politicized Archbishop of Manila, has been avoiding publicity lately, in stark contrast to the way he comported himself publicly at the height of the political campaign for the May 2019 midterm election.

Even his trusted and equally politicized and opinionated underlings, namely, Caloocan City Bishop Pablo Virgilio David and Lingayen Bishop Socrates Villegas, have not been their usual noisy selves.

The reason — their anointed candidates in the Otso Diretso ticket sponsored by the Liberal Party were clobbered at the recent polls. Adding to their collective sorrow is that almost all of the senatorial candidates endorsed by President Rodrigo Duterte won convincingly, with two of them, closely associated with the President, landing in the top five.

Since the midterm election was seen as a referendum on the President's administration, there is no doubt that the election results indicate that the Filipino people are on the side of the President.

The election to the Senate of Imee Marcos, the eldest daughter of ex-President Ferdinand Marcos, and the embarrassing defeat of reelectionist Sen. Bam Aquino, a first cousin of ex-President Benigno Aquino III, are also seen as the end of the anti-Marcos sentiment sowed by the Aquinos since 1972. It is likewise seen as a prelude to the end of Aquino politicians.

Obviously, Tagle and his friars wanted to reprise the years when Mrs. Corazon Cojuangco Aquino was president. Back then, Manila Archbishop Jaime Cardinal Sin was consulted by Mrs. Aquino on practically every major decision of her administration, and priests enjoyed power and influence in state affairs

With the defeat of Otso Diretso and the fresh mandate given by the people to President Duterte, the plans of the local Rasputins to control the government will have to be shelved.

They will have to stay in the dustbin of irrelevance for the next three years. The meddlesome friars will shut up in the meantime and avoid publicity. They are, however, expected to create political intrigue once again after briefly avoiding the political spotlight.

During the election campaign, Catholic priests were virtually endorsing the Otso Diretso candidates in their sermons and in partisan political propaganda disguised as "pastoral letters."

It will be recalled that Bishop David once went out of his way to go to Taguig City, a great distance from his parish in Caloocan, just to speak in a partisan assembly of anti-Duterte personalities. Surely, that act cannot be justified as parish work.

The reason for the zeal displayed by these friars in their campaign against President Duterte and his administration has substantially nothing to do with religion or morality, although the friars have been trying their best to make it appear that way. That's called deceit.

As if campaigning from the pulpit was not controversial enough, some prominent personalities in the Catholic educational community even used their schools to rally for the Otso Diretso ticket.

For example, the president of a prominent Catholic university based in Manila and who has close ties with President Benigno Aquino III even published an open letter in a newspaper of general circulation (not the Daily Tribune).

He said that his letter is his apology to the succeeding generation of Filipinos for his having left behind a nation that he could not be proud of. To make his letter sound credible, he cited an undisclosed, unidentified "mock election" conducted by what he vaguely refers to as "the youth." According to him, the results of that "mock election" favored all the Otso Diretso candidates, whom he enumerated one by one.

After identifying his anointed candidates, he painted a grim picture of the national political landscape and insinuated that the youth should vote for the anti-administration candidates if they want a better country.

Since the letter was published on the eve of the election, it was obviously an illegal, last-minute campaign for the Otso Diretso senatorial candidates who had been lagging behind in the voter's surveys. The desperation of the letter writer is obvious

Tato on My Mind

At hindi lang para makita ang huli, kundi para "tuklasin ang nakaraan para gawin itong magagamit muli." Kailangan ng "pangkabuuang tanaw" sa kasaysayan para ito ay "masuma at masuri. Ang gayung kasaysayan ay maaaring magsilbing gabay sa kasalukuyan at mga susunod na henerasyon sa nagpapatuloy na pakikibaka para sa pagbabago."

Hindi nagpapanggap na "obhetibo" ang kasaysayan ni Constantino, pero tumatatak at impluwensyal dahil sa husay ng pagbubuo at pag-aanalisa. Ang itinatanghal niya, higit sa lahat, ay ang pagiging kaakit-akit at kapakipakinabang ng isang makabayan at makamasang pagbasa sa buong kasaysayan ng Pilipinas.

Kaya naman noong nagkaroon ng palusot, isang proyekto sa klase, kinapanayam ni Obet at mga kagrupo si Constantino. Pinuntahan nila ang bahay nito sa 38 Panay Avenue, address ng noo'y Foundation for Nationalist Studies — lugar na lagi niyang hahanapin para silipin tuwing mapapadaan. Nilabas sila ng may-edad na historyador, nakapolo at nakaslacks, nagsisigarilyo sa pipa.

Sa loob ng ilang oras hanggang gumabi, matiyagang sinagot nito ang mga napakabatayang tanong nina Obet at mga kagrupo sa harap ng tape recorder. May isa nang aktibista sa grupo, pero hindi sa grupong pambansademokratiko, kaya matalas ang mga tanong. Ano ang kailangang pagbabago ng bansa? Pagkakaroon yata ng makabayang pamunuan ang pinasimpleng paliwanag.

Bakit makabayan siya pero sa wikang Ingles nagsusulat? Produkto rin daw siya ng kolonyal na mis-edukasyon na tinutuligsa niya. Manunuri ng kultura si Constantino, at sa isang bahagi, kinondena niya ang malaganap na komersyalismo. "Kaya ako, hindi na ako gumagamit ng toothpaste. Ang silbi lang naman niyan ay gawing kaaya-aya ang pagsesepilyo." Palihim at saglit na nagkatinginan si Obet at mga

kagrupo; pagkatapos ng panayam, nagpasya silang kalimutan ang bahaging ito.

Pagkatapos, lahat, nagpaautograph ng libro sa awtor, maliban kay Obet. Isang booklet lang tungkol sa mga korporasyong multinasyunal ang napapirmahan niya, kulay maroon. Pero alam niya na hindi lang iyun ang mahalagang babaunin niya galing sa pagtatagpong iyun, at hindi na nga niya mahanap ang kopyang may autograph ngayon.

Syempre pa, marami rin ang tumutuligsa kay Constantino. Kapag may gustong bumatikos sa makabayang tingin at tindig sa iba't ibang usapin, kasama ang mga sulatin niya sa pupuntiryahin. Partikular na kontrobersyal ang suri niya sa tatlong bantog na bayani ng bansa — Rizal, Andres Bonifacio, at Emilio Aguinaldo — gayundin sa pagsilang ng sambayang Pilipino at pagsisimula ng paglaban sa kolonyalismong Espanyol.

May mga tumutuligsa na para bang mas masama kaysa mabuti ang mga ambag niya, na para bang mas mainam bumalik sa panahon bago niya, sa panahon ng tahas na kolonyal, elitista at makitid na kasaysayan — na hindi katanggaptanggap at malinaw na hakbang paurong. Pinakamaingay sa mga ito ang anti-makabayan o anti-Kaliwa

Mayroon din namang mga tumutuligsa dahil gustong ilinaw ang katotohanan sa kasaysayan, at ang maka-Pilipinong pagtingin. Dito maihahanay kahit ang manunulat na si Nick Joaquin, na halatang dumedebate at tumataliwas sa mga pananaw ni Constantino kahit hindi ito pinangalanan sa mahusay niyang A Ouestion of Heroes (1977). Sabi ni Joaquin, nang ang ibig sabihin ay si Karl Marx, may mga sumusulat ng kasaysayan na "gustong gumawa ng botang Aleman mula sa bakyang Pinov."

Pero hindi maaalis ng mga tuligsang ito ang mahahalagang ambag ni Constantino sa pagbubuo, kahit bilang panimula, ng progresibo at makabayang kasaysayan ng Pilipinas at pagsusuri sa lipunan — na pawang nagpapaunlad sa progresibo at makabayang kontra-kamalayan, kontra-edukasyon, at kontra-kultura. Mas maunlad ang kilusan at pakikibakang makabayan dahil sa mga ambag niya.

Kakambal ng pangalan ni Constantino ang nasyunalismo. At sa isang bansang neo-kolonyal, mapanganib ang nasyunalismo. Ibig sabihin, hindi sapat na gunitain si Constantino na para bang alaala na lang siya sa nakaraan. Hamon sa mga mag-aaral niya na gawin siya, katulad ng nasyunalismo, na makabuluhan sa kasalukuyan at mapanganib sa mga naghahariharian.

>> Nitong nakaraang mga araw, naglabas ang rehimeng Duterte ng poster na nagyayabang-nananakot ng pagpatay sa mga kabataang naging kasapi ng New People's Army o NPA — mula kay Wendell Gumban hanggang kay Guiller Martin Cadano, mula kay Recca Noelle Monte hanggang kay Rendell Cagula. Ganito rin ang dinanas ng maraming bayaning pinatampok ni Constantino silang sinundan at tinularan ng mga nabanggit — sa kamay ng mga dayuhang mananakop at mga kasapakat na naghaharing uri.

Nitong nakaraang mga buwan, naglagay ang rehimen ng malaking karatula sa labas ng Kampo Aguinaldo laban sa mga laging nagpoprotesta doon at sa ibang lugar. Ang sabi: "Di ka bayad buwis, wala ka trabaho, gusto mo sunod sa 'yo gobyerno?" Sa insultong ito, lumalabas ang pag-etsapwera ng gobyernong nagpapakilalang "demokratiko" sa maraming kababayang dapat pinapakinggan nito. Ganito rin ang ipinapakita ng kasaysayan ni Constantino — at tama ang kilusang makabayan sa pagoorganisa sa mga pinapatungkulan.

Promote gender equality in sustainable conservation of marine resources

MANILA-- In celebration of this year's World Oceans Day (June 8) and Coral Triangle Day (□June 9), Senator Loren Legarda pushed for the promotion of gender equality in the sustainable conservation of our oceans and marine resources by encouraging more women participation in marine research, policy decision-making and advocacy processes,

communications, project management.

Legarda said that "Gender and the Ocean" is the focus of this year's World Oceans Day, while the message of Coral Triangle Day, a yearly celebration of the world's epicenter of marine biodiversity, which encompasses the seas of six countries in the Asia-Pacific region, including

and the Philippines, emphasizes ocean conservation under the banner of "shared waters, shared solutions." "We have polluted our waters and caused global warming, which impacting much more considerably the women than men. It is precisely because of this vulnerability that we should regard women as valuable holders of knowledge and skills to prepare for and cope with these circumstances, as a means to learn on how better to protect and promote ocean health," Legarda said.

Legarda said that, according to the United Nations, oceans absorb about 30% carbon dioxide emissions produced by humans, mitigating the impacts of global warming. However, human activities cause pollution, depleted fisheries, and loss of coastal habitats heavily affect as much as 40% of the world's oceans.

Moreover, women and children are 14 times more likely to die or get

injured in natural disasters due to unequal access to resources. Women only earn 64% of men's wage in aquaculture and have less access to decision-making positions.

"Let this year's of celebrations World Oceans Day and Coral Triangle Day place more emphasis on women participation in promoting ocean health. Let us not forget however that both women and men must take action to save our oceans and marine life and resources from further harm and degradation," concluded. Legarda (OSLL)

Pollution, a major threat to biodiversity and human survival

Day, with the theme "Beat Air Pollution," brings global attention to the impacts of deteriorating air quality to the health of the environment, and of people. This theme is very relevant to the people of ASEAN, now more than ever, given that the United Nations Environment Programme (UNEP) reported that the most dominant causes of air pollution in the region's rural areas is biomass burning; and in urban areas, vehicle and industrial emissions. The World Health Organization (WHO) estimated that indoor air pollution in the ASEAN region caused more than 376,000 premature deaths; while outdoor air pollution was estimated to cause more than 149,000 premature deaths annually.

Humans rely on the planet's rich biodiversity and ecosystems: they are the source of our air, water and food; raw materials for medicine and shelter; and natural capital for businesses and industries. But this richness is threatened by pollution, one of the major drivers of biodiversity loss and ecosystems degradation.

The UNEP has identified five major sources of air pollution: households, industries, transport, agriculture, and wastes.

Household air pollution comes from the indoor burning of fossil fuels, wood and other biomass-based fuels for cooking, heating and lighting homes.

The UNEP reported that the global transport sector accounts for almost one quarter

THIS year's World Environment of energy-related carbon dioxide Day, with the theme "Beat emissions. Transport emissions Air Pollution," brings global have been linked to nearly attention to the impacts of 400,000 premature deaths.

Agriculture has two major contributors to air pollution: livestock, which produces methane and ammonia, and the burning of agricultural waste. Around 24 percent of all greenhouse gases emitted worldwide come from agriculture, forestry and other land-use.

Open waste burning and organic waste in landfills release harmful dioxins, furans, methane, and black carbon into the atmosphere. The UNEP says that an estimated 40 percent of waste is openly burned.

According to the World Health Organization, 9 out of 10 people worldwide are exposed to levels of air pollutants that exceed safe levels. Thus, air pollution also contributes to health risks, aside from triggering global warming, biodiversity loss, and degradation of ecosystems.

The ASEAN region, endowed with a diversity of species, forests, marine areas, oceans, and wetlands, will stand to lose much of these natural richness if the quality of air continue to deteriorate, and along with this, the loss of biodiversity and ecosystems, which are key to the survival, development, wellbeing, and prosperity of some 650 million ASEAN citizens.

The ASEAN Member States – Brunei Darussalam, Cambodia, Lao PDR, Indonesia, Malaysia, Myanmar, Philippines, Singapore, Thailand and Viet Nam – supported by the ASEAN Centre for Biodiversity, have a number of programmes aimed at protecting the region's rich biodiversity and ecosystems from pollution and other drivers of biodiversity loss. A major initiative is the ASEAN Heritage (AHP) Programme, Parks which promotes protection of biodiversity-rich protected areas through effective management, including preventing all forms of pollution. Majority of these AHPs are forest areas, which play a key role in the battle against climate change, releasing oxygen into the atmosphere while storing carbon dioxide. Forests are called "green lungs" of the earth and are vital to the survival of people against air pollution. Aside from the AHP Programme, the ASEAN also has an initiative to reduce greenhouse emissions from peatland fires through the ASEAN Agreement on Transboundary Haze Pollution.

The ASEAN has also been gradually adopting the biophilic approach to greener and more sustainable cities. Scientific studies have proven that with more trees in the city, the prevalence of childhood asthma tended to drop. So as the urban areas in the region expand, more and more subnational governments are planning to build cities that are greener, biodiversity-friendly, thus less polluted.

Most causes of air pollution come from human activities. But humans can also be the solution to this global problem.

Industries can put in place technologies that will reduce the release of air pollutants from their operations. They can spearhead and mobilise their company personnel and even the public to plant native and appropriate vegetation in their surrounding areas that will help absorb carbon, and reduce airborne and respiratory problems in nearby communities. The ACB supports such biodiversity-friendly initiatives from the private sector.

On transportation, the public can be encouraged to use alternative means of transport such as bicycles, skate boards or scooters, to reach closer destinations, and to call for dedicated lanes to be set up for the purpose. The practice of reducing, reusing, and recycling of waste can also start at home. Waste segregation can reduce the volume of residual waste, and methane emission from saturated landfills.

The World Environment Day is not the only chance to demonstrate that if human activities are the cause of pollution, humans can also be the solution. Let us make each day of the year an opportunity to practice green lifestyles and behavior. Let us all promote green living by decreasing our carbon prints, environment-friendly products, clean technology, and renewable energy to help ensure an environment with healthy biodiversity and ecosystems that will contribute sustainable development, human development and human survival. 



President Duterte vows to preserve fragile Mindanao peace

DAVAO CITY -- President Rodrigo Roa Duterte made an assurance on Thursday to preserve the fragile peace in

Mindanao and vowed to protect

the Muslim community from the

clutches of violent extremism. The Chief Executive made the commitment as he joined the entire Muslim community in this year's thanksgiving celebration for the culmination of the Holy Month of Ramadan.

"Allow me to take this moment to assure you that this administration will endeavor to preserve the fragile peace that we have built in this region that I call home," the President said in a speech during the Eid'l Fitr Celebration in Davao City.

"Allow me to take this moment to assure you that through the National Commission on Muslim Filipinos, we will consistently uphold the rights and welfare of all Muslim Filipinos and, for that matter, for all Filipinos."

Underscoring the threat of Islamic extremism against the Muslim community and other tribes, he promised to shield those communities from attacks, stressing religious extremism. hatred, discrimination, and misguided beliefs will never be tolerated. Anybody who will foment discord will be dealt with with the full force of the law, he

And with the creation of the Bangsamoro Autonomous Region in Muslim Mindanao, a campaign promise that his administration delivered, he said he can work more closely with the Muslim community in the pursuit of a more harmonious and meaningful relationship among all ethnic groups in the region.

President Duterte also appealed to state auditors for leniency as his government funds elderly Muslim pilgrims travelling to Saudi Arabia. The President said he has been
