## PH withdraws from global initiative on extractives transparency

CALOOCAN The Philippines has withdrawn from the Extractive Industries Transparency Initiative (EITI) on the back of questionable metrics and procedures for assessing the compliance of implementingcountries with the international organization's transparency requirements.

addressed to EITI chairperson and former New Zealand prime minister Helen Clark, Finance Secretary Carlos Dominguez III called EITI's Validation - a quality assurance assessment process - "subjective, biased and unfair."

"We find that the manner by which the EITI In a June 20, 2022 letter Board undertakes its validation is unduly subjective, biased and unfair. The Philippines has no confidence in the ability of the EITI to undertake an impartial, transparent, and evidence-based validation process," Dominguez

## Govt officials, employees told to get COVID-19 vax

QUEZON CITY -- The Civil Service Commission (CSC) all encouraged eligible government officials and employees to get vaccinated against COVID-19.

In CSC Resolution No. 2200239 promulgated on 16 June 2022, circularized via CSC Memorandum Circular No. 7, s. 2022, the Commission expressed its support to the government's National Vaccination Deployment Plan and encouraged all government agencies to "adopt strategies and incentives to encourage

their employees to comply with the COVID-19 vaccination."

The CSC, on the other hand, stressed that no employee shall be compelled to get vaccinated, whether directly or indirectly such as "being discriminated against in terms of tenure, promotion, training, pay and other non-discretionary benefits, or being forced to take a leave of absence chargeable to leave credits."

Moreover, the CSC said that unvaccinated employees who are tasked to do onsite work shall undergo Reverse Transcription Polymerase Chain continue to page 3

At the same time, the CSC is encouraging government officials and employees to get COVID-19 vaccination.

It urged all eligible government officials employees to get vaccinated against COVID-19 as a protection against the virus.

In CSC Resolution No. 2200239 promulgated on 16 June 2022, and circularized via CSC Memorandum Circular No. 7, s. 2022, the Commission expressed its support to the government's National Vaccination Deployment Plan and encouraged government agencies to "adopt strategies and incentives to encourage their employees to comply with the COVID-19 vaccination.3

Availment of excused absence and special leave privileges for COVID-19 booster

In a separate advisory, the CSC encouraged all government officials and employees and their families to get the COVID-19 booster shot to increase their immunity and protection against the COVID-19 virus.

In the advisory, the CSC reiterated its policy allowing government officials and employees to file for excused absence for absences due to COVID-19 vaccination. Under CSC Memorandum Circular No. 16, s. 2021 or the "Interim Guidelines on Absences of Government Officials and Employees Due to COVID-19 Vaccination and/or Adverse Events Following Immunization (AEFI) of COVID-19 Vaccine"

issued on 12 November 2021, government officials and employees may avail themselves of the excused absence under the following conditions:

Absence from work during the day of inoculation of the first and second doses of COVID-19 vaccine, including future booster shots. Required documents include proof of schedule vaccination (e.g. vaccination card) and the application of leave of absence to be filed five (5) days prior to the scheduled vaccination date, if applicable; and

Absence from work due to the required treatment/ recuperation period from AEFI of the first and second doses of COVID-19 vaccine, including future booster shots.

A maximum of 15 calendar days may be allowed for cases of serious AEFIs which may include hospitalization, persistent or significant disability or incapacity, and life threatening or medically important event or reaction. In addition to the application of leave of absence and copy of vaccination card, the employee must also submit a medical certificate and/or clinical abstract indicating the diagnosis, management done, and number of days of recuperation needed, signed by the attending physician. On the other hand, a maximum of three (3) calendar days may be allowed for non-serious AEFIs, which may include:

tenderness

pain

warmth

redness

itching or swelling on the arm where one got the injection

generally feeling unwell

feeling tired (fatigue) chills or feeling feverish headache; and

joint pain or muscle

The employee must submit a medical certificate signed by an attending physician at the vaccination center or medical facility where s/he underwent observation due to AEFI.

The guidelines define AEFI as "any untoward medical occurrence which follows immunization and which does not necessarily have a causal relationship with the usage of

Absences due to AEFI of COVID-19 vaccine may be charged against the employee's sick leave credits when the period of treatment/recuperation exceeds the maximum allowable period of absences for the abovementioned conditions.

If the employee has exhausted his/her sick leave credits, Section 56 of the Omnibus Rules on Leave allows for the use of vacation leave credits in lieu of sick leave credits. In case the vacation leave credits have been exhausted, the employee may apply for sick leave of absence without pay.

Government workers who have incurred absences due to COVID-19 vaccination and/ or have undergone treatment from AEFI prior to the issuance of CSC MC No. 16, s. 2021 may request for the restoration of the

Such special leave privileges are non-cumulative and non-commutative.

Employees applying for special leave privileges shall no longer be required to present proof that they are entitled to avail of such. (PIA-NCR)

of Agrarian Reform (DAR) individual land titles to landless Secretary Bernie F. Cruz said farmers and farmworkers. there is no need to amend the Comprehensive Agrarian Reform Law (CARL).

"The agrarian reform program is not about consolidating lands. The program awards individual land titles to beneficiaries to give them the freedom of managing it themselves and to create more opportunities for them," Cruz said in a news release on Tuesday. Cruz made this reaction after of George Barcelon, president of the Philippine Chamber of Commerce and Industry (PCCI), pushed for specific amendments in the CARL that include easing the rules in land consolidation and ownership to create opportunities for better agricultural productivity by farming larger tracts of land.

Cruz said the agrarian reform program under Presidential Decree No. 27 and the Comprehensive Agrarian

'If we will consolidate lands, that would be going against the intent and essence of PD 27 and CARP. We will be destroying the legacies of the father and grandfather of President-Elect Ferdinand R. Marcos Jr. and incoming DAR Secretary Conrado Estrella, III, respectively," Cruz said.

"Under the CARP though, we have awarded collective land titles called the collective certificate of land ownership award (CCLOAs) in the past. Seeing that the farmers are not prospering in their collective lands, President Duterte directed us to split these landholdings. We are now in the process of individualizing these CCLOAs to serve the farmers better," Cruz added.

Cruz said the farmers who are bound to CCLOAs are disadvantaged in a lot of ways.

EITI prescribes standard for transparency and accountability in the mining, oil and gas industries.

Extractive companies in implementing-countries are engaged to publicly disclose data on taxes, royalties and other payments they make to the government and their hostcommunities.

In his letter, Dominguez said the country has been treated unfairly by the EITI Board by using irrelevant metrics and relying on unvalidated reports in assessing the status of civic space in the extractives sector.

The DOF repeatedly sought the details of alleged issues on civic space to enable the government to address the same.

The EITI, however, has not supplied the requested details. Dominguez called out EITI for its lack of due process and for imposing actions on the Philippines that violate the country's sovereignty.

"We refuse to be taken hostage by unverified allegations from foreigners and people who have no mandate from the electorate," he said.

The Philippines has been implementing the EITI since

In 2016, the EITI recognized the country for its impactful implementation.

EITI implementingcountries undergo validation every three years.

In 2017, the Philippines was declared the first among more than 50 countries in the world to have achieved satisfactory progress in meeting the EITI requirements.

Over the years, the country has demonstrated innovation and best practices in the areas of contract and beneficial transparency, ownership social. environmental. and employment, and gender data disclosures.

The Philippines has also sustained and broadened stakeholder engagement amid extreme situations, such as the coronavirus disease 2019 pandemic.

Despite the withdrawal from the EITI, Dominguez said the Philippines has the process, systems and manpower to ensure transparency in the extractives sector.

"The government will continue to champion better resource and revenue management, and ensure that resource utilization remains open, accountable, and responsive to the needs and aspirations of Filipinos," he added. (PIA-NCR)

#### Festival of concerts

Here's hoping the crowds that will descend to the concerts won't cause another Covid-19 surge.

It's remarkable enough that tickets to the concert of American band Lany, originally scheduled for three nights on 11, 12 and 13 November at SM Mall of Asia Arena, are sold out. But for the show to be extended one more night, on 15 November (also sold out), and then another night on 16 November, is astounding.

Ticket prices may be reasonable to the Filipino middle class, the most expensive (VIP standing) at P6,550 — but still way too high for ordinary workers' children who make up most of Lany's audience.

In any case, Pinoys who can afford it have no qualms shelling out cash to watch concerts.

The country is actually seeing a virtual festival of local and international concerts after strict health and safety protocols due to Covid-19 loosened up.

On 22 May, Ovation Productions announced Filipino band Ben&Ben will perform on 3 September at the Cultural Center of the Philippines (CCP) open grounds in Pasay.

Two days later, Ovation broke bigger news: Canadian pop superstar Justin Bieber live in concert on 29 October, also at the CCP grounds. Advance ticket sales for the Ben&Ben and Bieber shows were encouraging. But then came bad news when Bieber disclosed on 10 June that he has been diagnosed with Ramsay Hunt syndrome, in which half of his face was paralyzed and forcing him to cancel tour

In a video posted on Instagram, Bieber said the ailment has affected nerves in his ear and face. He said he couldn't blink his right eye and "can't smile on this side of my face. This nostril will not move. So, there's full paralysis on this side of my face."

The 28-year-old singer-songwriter added he's been physically unable to perform in concert, but he's been doing facial exercises and is expected to recover.



## Calamba commemorates 161st birth anniversary of Dr. Jose Rizal

CALAMBA CITY, Laguna — The provincial government of Laguna and the city government of Calamba commemorated the 161st birth anniversary of Dr. Jose P. Rizal on Sunday, June 19 in Jose Rizal Shrine, Calamba City, Laguna.

Officials from provincial government headed by Governor Ramil Hernandez, and the city government headed by Mayor-elect Roseller Rizal led the flag-raising and wreathlaying ceremony. Also present at the event is Commissioner Emmanuel Calairo of the National Historical Commission of the Philippines (NHCP).

A wreath from President Rodrigo Roa Duterte was also presented on Rizal's statue on his behalf.

Hernandez lauds the heroism shown by the frontliners during the onslaught of the COVID-19 pandemic and proclaimed that their selfless act is in itself a heroic one.

Dr. Bobis shared that there are no cases of monkeypox in the country yet based on the latest monitoring of DOH.

He acknowledged the possibility of it reaching our borders hence the very reason they are strengthening the surveillance system.

He also mentioned that according to the World Health Organization, the chance of the monkeypox becoming a widescale epidemic is slim as the transmission is through direct contact.

"In case you have the symptoms, immediately isolate and stay in a room or area in the house where there are no other individuals," Dr. Bobis stated.

Furthermore, reminded the public to call healthcare workers of their healthcare facility to ask the next steps after isolating themselves in order to limit exposure of other people and to prevent transmission. (JCR/AMB/ATV,

## Monkeypox explained: Transmission, Symptoms, Prevention, and Treatment

THE sound of another infectious virus, not even past the COVID-19 pandemic, coming up on the news may be alarming and rather distressing for most, if not for everyone.

In a virtual forum on June 17, Medical Officer IV and head of the Infectious Disease Unit of the Department of Health (DOH) Center for Health Development-Region Rheuel Bobis discussed the 2022 monkeypox virus to the Barangay Health Workers (BHW) in Ilocos Sur as well as the information officers of local government units and national government agencies.

What is Monkeypox?

Monkeypox is a viral zoonotic disease, like COVID-19, that affects both animals and humans.

The causative agent is the monkeypox virus. It is usually seen on rodents and nonhuman primates, but their natural reservoir is unknown.

Risk Factor

Close physical contact with the infected person and eating uncooked meat or other animal products of infected animals are risk factors of monkeypox.

Dr. Bobis explained young children immunocompromised individuals are more likely to have severe presentation, a notable difference from the COVID-19 virus that

shows severe symptoms on elderlies.

Transmission

There are two types of transmission according to Dr. Bobis—direct and indirect.

Direct transmission pertains to animal to human transmission. It happens when one gets in contact with blood, tissue, lesion, or excretion of infected animals through bites or scratches.

Another is human to human transmission that occurs through direct contact with lesions, secretions, respiratory droplets (usually face-to-face needed). contact or sexual contact.

Meanwhile, indirect transmission happens one gets in contact with lesion materials, for which Dr. Bobis cited, the beddings, linens, contaminated clothes, among others that were used by someone who is infected.

Dr. Bobis mentioned that the prevalence of asymptomatic transmission is currently unknown.

He said points of entry are broken skin (even if invisible), respiratory tract, and mucous membrane (eyes, nose, mouth).

"Meron din pong tinatawag na congenital monkeypox kung saan kapag ang nanay po ay may monkeypox maaari niya pong mahawaan 'yong kaniyang anak," he said.

Signs and Symptoms

Fever, headache, myalgia (muscle pain), back pain, asthenia (physical weakness/lack of energy), and lymphadenopathy (swelling of the lymph nodes) are signs and symptoms of monkeypox.

He further pointed the difference between monkeypox and chickenpox stating that the rash distribution of the former is centrifugal or more abundant on the face, hands and feet. On the other hand chickenpox's rash distribution is centripetal or more abundant on the trunk than on the face.

The signs and symptoms may be observed with the invasion/prodromal period of zero to five days, whereas the skin eruption period is one to contact tracing and testing, PIA Ilocos Sur)



## DA assists farmers with new rice milling guides

QUEZON CITY -- As more Filipinos are drawn to farming, the Department of Agriculture-Bureau of Agriculture and Fisheries Standards (DA-BAFS) released another one of its illustrative guides (IG), this time for milling rice, to encourage more participation.

The DA-BAFS has released its Illustrative Guides (IG) for the Philippine National Standards (PNS) for Postharvest Machinery - Rice Mill - Specifications (PNS/BAFS PABES 303:2020) and Methods of Test (PNS/BAFS PABES 304:2020).

The IG for Rice Mill - Specifications contains detailed illustrations of different parts of the rice mill, its methods of operation, fabrication requirements and the proper marking and labeling of the machine. It also specifies the general requirements for ensuring the safety of machine operators, and the workmanship and finish of a rice mill.

Meanwhile, the Methods of Test presents the standard procedures for sampling agricultural machinery and its components to verify the mechanism, specifications and performance of the rice mill. It also serves as a reference in identifying the effect of milling on grain quality through laboratory analysis, as well as evaluating the handling and safety procedures to ensure the safety of the machine operators.

One of members of the Technical Working Group (TWG) from the University of the Philippines Los Baños - Agricultural Machinery Testing and Evaluation Center (UPLB-AMTEC) suggested the inclusion of the IG in the training and refresher course on the rice milling test being conducted by AMTEC.

The Bureau is hopeful that this initiative will encourage manufacturers and fabricators, including rice mill fabricators, test engineers and farmer organizations, in adopting modern, appropriate, cost-effective and environmentally safe rice machinery and equipment while ensuring the safety of the farmers.

A rice milling system appropriate for Philippines' widely planted rice varieties is contributory in producing whole rice kernels that are sufficiently milled, free of impurities, and contain a minimum number of broken kernels. # 18M Filipinos suffering from, at risk of fatty liver disease

QUEZON CITY -- At least 18 million Filipinos are either suffering from or at risk of fatty liver disease, a sickness considered a "silent epidemic."

This is one of the alarming pieces of information presented at the recent online press conference titled "Fatty Liver Facts: What You Need to Know About This Silent Epidemic," organized by the Hepatology Society of the Philippines (HSP).

The "silent epidemic" is called fatty liver disease, which affects millions around the world. It has no symptoms at the early stages, which is why many people are unaware that they have it until it's too late.

"Fatty liver disease is a little-known, potentially fatal condition affecting many people. The public can learn about it by listening to experts," said Dr. Allan Policarpio, president of the Philippine Society of Gastroenterology.

There are two types of non-alcoholic fatty liver disease (NAFLD) -- non-alcoholic fatty liver (NAFL) and its more advanced type, the non-alcoholic steatohepatitis (NASH).

The main characteristic of both is too much fat stored in liver cells. Having small amounts of fat in the liver is normal, but it becomes a problem if more than 5 percent to 10 percent of the liver's weight is fat.

Dr. Edhel S. Tripon of HSP stated that fatty liver is the fastest rising cause of liver cancer and cirrhosis worldwide. "People who are overweight, diabetic, or hypertensive are prone to developing fatty liver," he said.

The Philippines has over 18 million obese and overweight people. They are all susceptible to NAFLD, said Dr. Diana Alcantara-Payawal, president of the Philippine College of Physicians. "Some of them may already have fatty liver disease but are unaware of it," she



## No discrimination for non-vaxxed in govt -CSC

QUEZON CITY -- The Civil Service Commission (CSC) has emphasized that no government employee shall be discriminated based on his/her COVID-19

"No employee shall be compelled to get vaccinated, whether directly or indirectly such as being discriminated against in terms of tenure, promotion, training, pay and other nondiscretionary benefits, or being forced to take a leave of absence chargeable to leave credits," the CSC said.

The CSC, however, said that unvaccinated employees who are tasked to do onsite work shall undergo Reverse Transcription Polymerase Chain Reaction (RT-PCR) testing and present

a negative result thereof, at a frequency to be determined by the head of agency, but "which should be at least once every two weeks" in accordance with IATF Resolution No. 149, s. 2021 issued on 18 November 2021.

The CSC added that Rapid Antigen Tests may be used when RT-PCR testing capacity is insufficient or not immediately

The COVID-19 testing unvaccinated employees performing onsite work shall be on the employee's own account, unless the government agency decides to cover the cost/s, subject to availability of funds and the usual accounting rules and regulations.

Government agencies may also opt to place unvaccinated continue to page 2

As mandated by the BFP undergoes a ten-Act, modernization program,

includes acquiring modern fire equipment, hiring personnel, additional providing specialized training for firefighters, among others.
