SSS shifts to checkless benefit payout SSS President and released through checks, are no mandatorily released thru bank

QUEZON CITY -- The state-run Social Security System (SSS) on Friday said it will no longer disburse benefit payouts to its members thru checks. SSS President and Chief Executive Officer Aurora C. Ignacio said lump sum disability, death and retirement benefits, including Employees' Compensation (EC) disability benefit, which were previously

released through checks, are now mandatorily released thru banks. "This improvement allows the SSS to efficiently and safely administer the payment of benefits to its members and their rightful beneficiaries," Ignacio said.

The public is also advised to heed announcements from health officials on the safety of consuming fish gathered from the fish kill.

stretch of LPPWP's Long Island, and about half-ton spread out over Freedom Island.

Personnel from the EMB-NCR, BFAR, Philippine National Police-Maritime Group and the Las Piñas and Paranaque agriculture and environment offices immediately conducted an on-site inspection, identifying at least 33 marine species, including tilapia, talakitok, sapsap, lapulapu, eel, malakapas, crabs and shrimp.

In 2013, the LPPWP, formerly known as the Las Piñas-Paranaque Critical Habitat and Ecotourism Area, was recognized as a Wetland of International Importance by the Ramsar Convention because of the critical role it plays in the survival of various migratory bird species.

LPPWP is one of only two protected areas in the highly urbanized Metro Manila, the other being the Ninoy Aquino Parks and Wildlife Center in Quezon City. (PIA-NCR/DENR)

Army sends delegates to Seoul ADEX 2019 The highlight

FORT BONIFACIO, Taguig City-- The Philippine Army sent a delegation to attend the 2019 Seoul International Aerospace and Defense Exhibition (ADEX) in Korea that runs from October 14 to 20.

ADEX is a biannual event where the latest aerospace and defense innovation and technology is being showcased by about 400 exhibitors from at least 30 countries. The delegation is led by the Army Commanding General Lt. Gen. Macairog S. Alberto.

The Army is set to acquire more air assets in the future after the upgrade of its Army Aviation Battalion into the Army Aviation Regiment early this month. It aims to equip the regiment with attack helicopters, reconnaissance helicopters, and multi-purpose medium lift helicopters. Its engagement in ADEX and similar events is a step towards strengthening its aviation and air defense capabilities.

highlights The of the show are the indoor and outdoor exhibitions. Part of the indoor exhibitions are aircrafts, unmanned aerial vehicles, space material, weapon systems mockup and full scale, simulator, weapon systems equipment, ground and naval weapons and equipment, and others related to airport facilities. While the outdoor exhibitions include new fighter, military transport aircraft, cargo aircraft, helicopter and civil aircraft, ground equipment such as self-propelled/mobile artillery, armoured fighting vehicle and unarmored vehicle.

Like other exhibitions in the defense industries, the ADEX also holds seminars, conferences, and symposiums aligned with the event.

"The Philippine Army is geared towards enhancing its aviation and air defense capability to address the fast evolving threats faced by the country as well as to put an end to insurgency," Alberto said.

words of Sanskrit origin fill the country's lexicon. "And the Indian influence persists in our arts and, perhaps, even in our world view."

President Kovind, who arrived in the country Thursday, agreed. Responding to President Duterte, the Indian leader said he believes that there exists a rich tapestry of shared heritage between the Philippines and India waiting to be researched and documented.

"The discovery of the statue of Tara in Agusan and the commonality in our languages and art speak of vibrant cultural exchanges in the ancient past," said the visiting Indian president.

"And much to our delight, our contemporary cultural attributes—be it music or dance, karaoke, our Kathak—continue to bring our two peoples together."

President Kovind's five-day state visit to the Philippines, from October 17 to 21, 2019, marks an important milestone in Philippine-India bilateral relations as both countries commemorate this year the 70th anniversary of the establishment of their diplomatic relations.

The Philippines established diplomatic ties with India 70 years ago in November 1949. In the early days of their bilateral relationship, the two nations worked further to strengthen friendly relations.

On July 11, 1952, they signed the Treaty of Friendship in Manila. Soon after, the Philippine Legation in New Delhi was established and eventually elevating it to an Embassy. The Philippines' first ambassador to India was Narciso G. Ramos.

The Philippines and India continue to renew and reaffirm excellent bilateral relations in many aspects, across different fields of cooperation by working together in advancing mutual interests based on a firm commitment to inclusive and sustainable development for both Filipinos and Indians.

President Kovind is the third Indian president to undertake a state visit to the Philippines since the establishment of formal diplomatic relations. The last state visit of an Indian president to the Philippines was by A.P.J. Abdul Kalam on February 3 to 6, 2006.

In terms of trade, the relationship between the Philippines and India is vibrant. In 2018, India was the Philippines' 15th trading partner, 16th export market, and 14th import supplier. Total trade with India has increased in the last four years, reaching \$2.28 billion last year.

India is also the country's investment promotion agencies (IPA)-approved investor. Investments and cooperation the information and communications technology (ICT) and business process outsourcing (BPO) sectors remain strong.

India is also home to many Filipinos. As of December 2018, there were an estimated 1,167 Filipinos in India, based on the Philippine embassy database in New Delhi. Of that number, around 80 percent are housewives married to Indian nationals while the rest are overseas Filipino workers (OFWs) mostly skilled workers. (PND)

Under the program, lump sum benefit payments are remitted by the SSS to the member or claimant's account in their preferred SSS-accredited bank.

As of writing, there are 67 SSS-accredited paying banks such as: Asia United Bank Corporation, Bank of the Philippine Islands, China Banking Corporation, Development Bank of the Philippines, EastWest Bank, Land Bank of the Philippines, Metropolitan Bank and Trust Company, Philippine National Bank, Philippine Veterans Bank, RCBC Savings Bank, Security Bank and Trust Company, and Union Bank of the Philippines.

A qualified member or claimant for any of the said benefit programs will now be required to present to the SSS a bank document with his/her name.

Bank documents that may be presented are any of the following: a single savings account passbook, ATM card with name and account number, validated

initial deposit slip or copy of bank certificate/statement, if the name of member or claimant and/ or savings account number is not indicated in the ATM card or an accomplished Visa cash card enrolment form.

The bank certificate or statement shall be duly signed by the bank's authorized signatory and shall contain the complete name of the member or claimant, savings account number, and the bank's branch name and complete address.

"Members or claimants may also use their Unified Multi-purpose Identification (UMID) card if it is enrolled as an ATM. These are UMID cards issued with EMV chips," Ignacio said.

For members or claimants that have no existing single savings account, the SSS will issue them a letter of introduction for them to present to their chosen SSS-accredited bank.

On the other hand, some cases are exempted from the mandatory release of the said lump sum benefits thru banks. These include cases when the address of the member or claimant is beyond 30 kilometers to the nearest SSS-accredited bank or in a high-risk area where peace and order is unstable due to the presence of armed conflict.

Also, when the amount of benefit is P1,000 and below, or when the member or claimant is confined in an applicable institution such as penitentiary, correctional institution or rehabilitation center, the member is not qualified of the check-less transaction.

Similarly, when the member or claimant is physically incapable of transacting business with the bank, and when there are multiple legal heirs as claimants, he/she will be exempted.

"The program has been really effective since its implementation. It is more convenient for our members since they do not have to wait for or get their checks and personally encash it on the assigned bank. They'll just have to wait for their benefits to be credited to their respective accounts and withdraw it whenever they need it," Ignacio said. (SSS)

Road rackets at Paco, Katipunan

SOMEBODY should wake up Danny Lim, the inept chairman of the inutile Metropolitan Manila Development Authority (MMDA). He does not seem to be aware of the latest rackets on the streets of the metropolis.

There is an ongoing construction project at the Paco, Manila segment of Quirino Avenue across Plaza Dilao.

On many occasions, the westbound lane of Quirino Avenue in that area is so clogged with many vehicles, large trucks in particular, that other truck drivers on that lane often make a left detour at the corner of Quirino Avenue and Plaza Dilao and head towards the United Nations Avenue area. There are no visible traffic signs in the area prohibiting left turns there.

By the time they exit Plaza Dilao, however, MMDA traffic personnel hiding at the bend after the Philippine Columbian Association clubhouse appear from hiding and accost the surprised truck driver for allegedly making an illegal left turn. Sometimes, as many as four trucks are accosted and stopped simultaneously.

Whatever transaction subsequently takes place between the traffic enforcers and the truck driver is left to one's imagination. What becomes easily noticed is that the halted trucks occupy road space and slows down the pace of traffic in that part of Plaza Dilao. That needless delay adds to the traffic mess in the metropolis.

Two questions arise. If making a left turn in that area is prohibited, then why aren't there any traffic regulatory signs there to warn truck drivers and motorists? Next, why are the traffic enforcers hiding?

Under the law, all motorists, truck drivers included, have to obey traffic signs and instructions from road cops or traffic enforcers. A violation results in the issuance of a traffic violation ticket and a fine which the disobedient motorist must pay.

To be required to pay a fine is a punitive measure. Being so, a motorist accosted by a traffic enforcer is entitled to due process, which means that there should be a traffic sign prohibiting a particular act or omission, and that the sign must be conspicuous enough to be seen by motorists.

In other words, if there is no such traffic regulatory sign in plain view of the motorists, a traffic enforcer has no business stopping vehicles and imposing sanctions on the driver concerned. After all, if a motorist is required to obey a traffic sign, that sign must be visible to the motorist. A contrary conclusion is a violation of due process, which is a constitutional right.

If an MMDA traffic enforcer insists on stopping a motorist without first ascertaining if there is a traffic regulatory sign in plain sight of the motorist, that traffic enforcer can be held administratively and criminally liable.

The MMDA traffic enforcers who hide before preying on a motorist are also liable administratively. On account of the very nature of his job, a traffic enforcer should make himself visible to motorists. His presence is a visual deterrent against a breach of traffic rules. Because the sight of a traffic enforcer compels motorists to obey traffic rules, the presence of the traffic enforcer is law enforcement incarnate. Moreover, a visible traffic enforcer also discourages road rage incidents.

Another ongoing roadway racket takes place at almost every midnight, this time at the southbound half of Katipunan Avenue at Loyola Heights in Quezon City, near the corner of Katipunan Avenue and C.P. Garcia Avenue, the diversion road leading to the University of the Philippines campus in Diliman. A team of about six men in orange uniform block a part of that segment of Katipunan Avenue with orange road barriers, the kind used by the MMDA to channelize vehicular movement along EDSA and other major roadways. Using flashlights, these men flag down trucks and quiz the driver.

There are no signs to indicate their presence or their authority to block the roadway.

Worse, that area is dark and the orange road blocks are not reflectorized, which makes them traffic hazards. Motorists who are not familiar with that area tend to notice the road blocks only at the last minute. Accidents there are bound to happen.

Instead of stopping these road rackets, Danny Lim is occupied with the coming metro film festival.

Prospek ng Occupy sa Pilipinas

MARAMI sa mga progresibo ang katulad ngayon ni Prop. Leonor Magtolis-Briones ng Unibersidad ng Pilipinas: nagmumuni tungkol sa posibilidad ng pagputok ng protestang Occupy sa bansa. Halata ang simpatya niya sa pagkakaroon ng lokal na kaakibat – higit pa sa lokal na bersyon – ng ganitong protesta sa mundo. Sa isang banda, nakilala siya bilang isa sa mga lider-estudyante na nagsalaksak ng trak ng bumbero sa tarangkahan ng Malakanyang noong Sigwa ng Unang Kwarto. Anu't anuman, heto ang ilang ambag ko sa mga umiinog na talakayan hinggil sa prospek ng protestang Occupy sa ating bansa:

(1) Mainam ang kalagayan. Hindi na siguro kailangang isa-isahin pa ang mga isyung nagpapatunay na tumitindi at titindi pa ang kahirapan at kagutuman ng mga mamamayan. Sa pangkalahatan, ang mga interes malalaking kapitalistang dayuhan at lokal, ng mga dayuhang bangko, ng malalaking panginoong maylupa, at ng mga tiwaling pulitiko ang nananaig sa bansa. Ang gobyernong Aquino, bukod sa pagpanig sa mga nabanggit na grupo, ay nagpapatupad ng di-idinedeklarang programa ng pagtitipid o austerity para sa mga mamamayan, habang pinapatindi rin ang paghuthot sa huli. Minana rin nito ang napakaraming komitment na neoliberal ng mga naunang rehimen.

(2) Ang mga aktibistang pambansa-demokratiko ang nasa pinakamainam na katayuan na pamunuan ito. Bukod sa sila ang pinakamarami, sila rin ang pinakalubog sa masa. Sila rin ang tuluy-tuloy na naglalantad at lumalaban sa pagpapatindi ng kahirapan at kagutuman. Hindi maaasahan ang mga grupong

nagpapakilalang "Kaliwa" pero todong nagpalamon sa gobyernong Aquino. Takot na takot silang magalit ang kanilang alyado dahil sa kung anong protesta; takot na takot silang matanggalan ng posisyon at sweldo sa gobyerno. Hindi nila iniisip ang magandang kalagayan para magmulat at magorganisa dahil wala naman silang tinatanaw na rebolusyon sa saklaw ng kanilang buhay.

(3) Nakatuntong ito sa lawak at lakas ng mga naunang protesta ng mga mamamayan. Sa propaganda, may naipundar nang puhunan hinggil sa iba't ibang isyu; ang hamon ay kung paano ikakawing at itataas ang mga ito - sa isang paraan na madaling maunawaan ng marami. Sa lunsaran ng protesta, may mga nahawan nang sentro ng protesta; ang hamon ay kung paano eengganyuhin ang mga mamamayan sa paligid nito na lumahok. Sa mahalagang suporta ng mga nasa panggitnang uri, sila mismo ay nakakaramdam ng krisis at sila ang mas inaabot, sa pamamagitan ng Facebook at iba pang social networking sites, ng impormasyon at ahitasyon hinggil sa protestang Occupy sa US.

(4) Ang isang susi ay ang pagtukoy sa puntirya ng protesta batay sa iba't ibang isyu. Sa US, "corporate greed" ang tampok na target ng protesta. Sa Pilipinas, isang panukala ang "Kapitalistang Kasabwat Gahaman, Pamahalaan." Sa US, panahong binabalik-tanawan ay ang "gera kontra-terorismo" simula 2001 at tampok ang pagsambulat ng matinding krisis noong 2008. Sa Pilipinas, maaari ring simula 2001, sa bungad ng pagrereyna ni Gloria Macapagal-Arroyo. O mas maaga, sa 1992, bungad ng rehimen ni Fidel Ramos. Kung ang huli ang

pipiliin, kailangan at ibubunga ng protesta ang pagbuo sa kamalayan ng mga mamamayan ng epekto ng neoliberalismo sa bansa.

(5) Mahirap kung ilulunsad ang protestang Occupy sa Makati na, tulad ng Wall Street, ay sentro ng pampinansyang aktibidad sa bansa. Malayo kasi ito sa malawak na mamamayan na maaasahang lalahok. Maaari ang Maynila para malapit sa mga sentro ng kapangyarihan at tradisyunal na pinagraralihan, tulad ng Mendiola at US Embassy. Pero ang mahalaga ay kung saan ito makakaakit ng malawak na paglahok at suporta ng mga mamamayan. Pwede ang Morayta, Welcome Rotonda, o Quezon City Memorial Circle. Ayon sa isang balita, nakaasa ang mga nagpoprotesta sa Wall Street sa kabaitan ng Burger King sa pagpapagamit ng kubeta. Ganito kaya ang mangyayari sa bansa?

(6) Ilan pang punto: Mas mainam kung hindi magtatagal ang protesta nang walang taning. Mas magiging rurok ito ng protesta, na maaaring tumagal nang ilang araw, pero hindi pipiliting isustine nang matagal. Ang mas mahalaga pa rin ay ang pag-abot, paghikayat at pagpapakilos sa paparaming mamamayan sa kanilang konsentrasyon. Tiyak na magiging mahalaga ang papel rito ng mga kabataan at estudyante, silang kayang tumao sa paglulunsaran ng protesta. Sigurado, may musika rito, na pwedeng pana-panahon o gabi-gabing rumurok sa mga konsyerto. Babalik-aralan at tutugtugin ang maraming awit at himig ng protesta, at maging mga awit at himig ng pagrerebelde.

With the theme, "Data Innovation: Key to a Better Nation," the NSM 2019 Opening Ceremony enjoined national government agencies and provincial and local government units at Hotel Marciano, Brgy. Real, Calamba City WAM Statistics. last October 7.

PSA 4A Statistical Specialist Silver Quiatchon who served as Master of Ceremony "Relevant explained, disaggregated information can serve as guide in advocacy work geared towards women's welfare and advancement in the various sectors of society."

He also emphasized that information on women related to areas of violence, migration, peace and human rights which have not been given focus in various statistical publications are now being made available through the

Senior Statistical Specialist Charity O. Bautista presented the WAM Statistics result of Calabarzon in relation to Population, Labor and Employment, Agriculture, Education, Vital Health and Family Planning, Violence Against Women, Public Life, Overseas Filipinos, Public Order, Safety and Justice, Social Welfare, and Sustainable Development Goals

While, National Economic and Development Authority Region 4A (NEDA 4A) Regional Director Luis Banua stressed the importance of the WAM statistics in relation to

the fifth SDG, which is to "Achieve gender equality and empower all women and girls."

He even shared about the initiatives of the Calabarzon Regional Development Council (RDC) on promoting Gender and Development (GAD) including recognizing Best Regional GAD Implementers, developing and conducting GAD trainings, strengthening partnerships and linkages among stakeholders, and continuous advocacy on the use of sex-disaggregated data on planning and policy.

PSA 4A Statistical Operations and Coordination Division Chief Benigno F. Perido stressed that the goal of the annual celebration is to promote the importance and value of Statistics in governance, policy formulation, planning, decision-making and

even Research and Development. Also, he pointed out

that without data and good quality policy-makers and development planners would be like walking in the dark.

"Statistics will show us whether our policies and programs are technically working and what still needs to be done to achieve sectoral goals under Ambisyon 2040 as well as the SDG 2030," he

As to the WAM Statistics in Calabarzon, the Chief promised to continue to update its content every year.

"More innovation will be done especially after our Census of Population and Housing in 2020 next year which will give more granular sex-specific demographic statistics so that all gender-issues shall be addressed properly." (Joy Gabrido/PIA4A)

"In May 2017, when the Maute group terrorized Marawi City in the Southern Mindanao, the ADF formed Operation Augury-Philippines in partnership with the AFP. The ADF deployed P-3 Orion aircraft for intelligence surveillance reconnaissance in support of the AFP groundforces and operations in Marawi. Some two years after the Marawi seige, the ADF still works with the AFP on urban operations and counter terrorism-focused military training. This helps [us] deal with common threats that we face today and enhances the sheer understanding of terrorist threats in our region," he said.

The distinctive fraternal ties that link Australia and the Philippines shared by Ambassador Robinson made the event doubly special. The two countries draw their strength from their roots of kinship, history, common affiliation, joint destiny, and shared interests.

"Because Australia knows we are stronger when we work with trusted friends and while the nature of the challenges we face in the years to come will always continue to change, the necessity of cooperating closely in our response never will change. Looking ahead, I am confident that Australia's relationship with the Philippines will remain grounded in the values embodied by mateship bayanihan--friendship, solidarity, and cooperation,' Robinson concluded his story. Mateship and Bayanihan, a tale of alliance between Australia and PH

THERE is a "word" in the Australian language, which is very close to the meaning of the Filipino term--bayanihan.

The term bayanihan (pronounced as buy-uh-neehan), a core essense of Filipino culture, is a custom derived from a Filipino word 'bayan', which translates to nation, town, or community. Bayanihan may mean being part of a bayan, which refers to the spirit of communal unity, work and cooperation to achieve a certain goal.

Now it has been etched in the annals of Philippine history that in the time of the Second World War, Australians gallantly fought and died in the country from the time the United States' surrendered during the fall of Bataan in 1942, until the Philippines' final liberation in

As a lasting tribute to Australia's contribution to the war efforts, a memorial has been dedicated at Palo, Leyte, which honors the 92 Australians who gave their lives during the Philippines Liberation in WWII. The monument stands close to the site where General Douglas MacArthur first stepped ashore after leading the advance from Australia.

Aside from this, the Royal Australian Naval forces also played an important role in what is known as the world's big-gun naval battles at Leyte Gulf, at the Surigao Strait, and in the Battle of Lingayen Gulf, in addition to the foreign Navy's role in providing crucial support to nine amphibious landings during the campaigns that helped assure victory for the Allied

Side by side, Australian and Filipino soldiers died in battle to achieve a common

goal and this was highlighted by Australian Ambassador Steven J. Robinson during the opening of the "Mateship and Bayanihan: The Story of Philippines-Australia Defense Ties" exhibition at the QCX Museum at the Quezon Memorial Circle.

"Seventy-five years ago today, the first of the Australian Naval forces taking part in what was called 'Operation King 2', crossed the Philippine waters, heading to the Leyte Gulf, and to the Suriago Strait. In the battles that followed, over 4,000 Australian servicemen were among the Allied Forces who played a small but significant part in the Allied victory in and across the Pacific," Robinson began his story.

"The great battle in the Pacific taught us what holds true 'til today, but the success of coalitions and alliances rests heavily on the spirit of cooperation and common values," he added.

Australia's contribution and sacrices throughout the war has been put on display in the exhibition where materials were sourced from the Australian War Memorial, National Archives of Australia, the Australian Defence Force imagery, Malacañan Presidential Museum and Library, Armed Forces of the Philippines Museum, and and the University of Santo Tomas archives. The Mateship and Bayanihan exhibition is open to the public until October 30. The QCX Museum is open Monday to Friday from 9:00am to 4:00pm. Entrance is free.

"In a few days, on the 23rd of October," Robinson continued, "we will mark the second anniversary of the Battle of Marawi. This recent threat shows once again that the spirit of cooperation between our two countries, which was forged in World War II, is still present today. These times

are at the heart of the very close relationship Australia shares with the Republic of the Philippines. As I understand it, the Filipino ideal of 'bayanihan' conveys the spirit of communal unity, work and cooperation to achieve a goal. Bayanihan is keen to the Australian concept of 'mateship' which includes notions of friendship, solidarity, and pulling together."

"These values have really shaped who we are, and what we stand for. And they've been tested through the most gruelling periods of our history. So this exhibition is about what binds us together--Mateship and Bayanihan today. That spirit binds at the heart of the relationship between Australia Defence Force and the Armed Forces of the Philippines," he

Moving further with his story, there was a sense of honor and distinction exhibited by the Ambassador in the manner he related how proud he is of the life-saving work the Australian and Filipino forces extended in all their peacebuilding and humanitarian efforts in the



PH, India agree to intensify defense, security cooperation

MANILA-- The Philippines and India agreed to work together on defense and security, particularly with the rise of violent extremism and the fast-changing geopolitical landscape in the Asia Pacific region.

In a joint press statement with visiting Indian President Ram Nath Kovind Friday, President Rodrigo Roa Duterte welcomed the role of India in the country's defense capability upgrade program against the backdrop of their growing security cooperation.

President Ram Nath Kovind arrived in the country on October 16 for a five-day state visit

"As countries strategically located in the Pacific and Indian Oceans, we affirmed our shared interest to protect our maritime commons and advance the rule of law in our maritime domains," the President said.

"We agreed also to continue working together to fight terrorism and violent extremism and other transboundary threats."

The President also voiced his commitment to further build a more dynamic and forward-looking relationship between the Philippines and India, noting their ties allow the Philippines to seize tremendous opportunities vital for its development.

This close cooperation, he said, also enables the two countries to face challenges to their hard-won progress – jointly and effectively.

As the two countries commemorate 70 years of diplomatic relations this year, he said, "These past seven decades are more than just the passage of time. They signify the stability of true friendship availing itself and between two major Asian democracies."

"They represent the steady maturing of ties that has helped transform our nations into the fast-growing economies of what they are today. More importantly, our celebrations in

DENR working to ensure fish kill won't affect Manila Bay rehab-Cimatu

QUEZON CITY--The Department of Environment and Natural Resources (DENR) has assured that appropriate measures will be undertaken to make sure the recent fish kill in the Las Piñas-Paranaque Wetland Park (LPPWP) will not affect the ongoing rehabilitation efforts in Manila Bay.

In a statement, DENR Secretary Roy Cimatu said the agency is "looking deeply" into the cause of the fish kill in the protected wetland area situated within the Manila Bay region.

"The DENR is now gathering more information on the extent and the cause of the fish kill in LPPWP," the environment chief said.

Cimatu said the Environmental Management Bureau-National Capital Region (EMB-NCR) had already conducted tests in LPPWP for several key water quality indicators.

He said the results are being fast tracked "to enable us to determine what measures to undertake to mitigate adverse impacts over other marine life in the area."

"We are also doing this because we want to make sure that the fish kill incident will not

cause any delay to the ongoing Manila Bay rehabilitation efforts," Cimatu added.

DENR-NCR Regional Executive Director Jacqueline Caancan said the water test results will be out "in the next few days."

The results, she said, would complement studies being done by experts from the Bureau of Fisheries and Aquatic Resources of the Department of Agriculture and the city governments of Las Piñas and Paranaque.

"While agriculturists initially assessed that the state of some of the fishes indicate dynamite fishing, our parameter tests on the water quality in the area could pinpoint other factors that may have contributed to the fish kill." Caancan said.

The DENR-EMB tested the LPPWP waters for dissolved oxygen, pH level, nitrates, phosphates, fecal coliform and cyanide. The results could show whether the fish died through toxic means, or through oxygen saturation that is determined by the level of dissolved oxygen in the water, which is essential to sustain aquatic life.
