PBBM freezes land amortization and interest payments maximizing their capacity

QUEZON CITY -- On September 13, during President Ferdinand R. Marcos Jr.'s 65th birthday marks the fulfillment of another commitment he made during his first State of the Nation Address (SONA), that of emancipating the agrarian reform beneficiaries (ARBs) from their debts.

Marcos, Jr. signed the Executive Order imposing a year-long moratorium on payments on the annual amortization and interest payments of ARBs for agricultural lands distributed under the Comprehensive Agrarian Reform Program (CARP).

The President said that the one-year moratorium on land amortization and interest payments would help unburden the ARBs from their debts, enabling them to use the money instead in developing their farms,

maximizing their capacity to produce and propel the growth of the economy.

DAR Secretary Conrado Estrella III said the executive order on moratorium is in preparation for another fulfillment of the commitment of the President, which is for Congress to pass a law that will condone the loans of ARBs with unpaid amortization and interests.

"We always think about the farmers' welfare. The one-year continue to page 3

DOLE releases revised IRR of the telecommuting law

QUEZON CITY--The labor department called on employers and workers to mutually adopt telecommuting programs to help sustain the country's economic recovery.

This after Labor Secretary Bienvenido Laguesma signed Department Order 237, on Friday, September 16, that contained the revised implementing rules and regulations of the telecommuting law, or Republic Act 11165.

In a statement, the labor department said the revised rule was the result of almost two months of consultations with concerned sectors. It also passed scrutiny and had inputs from members of the National

Tripartite Industrial Peace Council – a consultative body presided by the labor secretary and composed of labor and employer representatives.

"These revised rules clarify and adequately address issues and concerns of the telecommuting sector," Laguesma said.

Emphasizing the voluntary nature of the alternative work arrangement, the labor chief echoed the call for employers and employees to "jointly adopt and implement telecommuting programs that are based on voluntariness and mutual consent."

"This aims to sustain our efforts for economic recovery," he said.

Army reservists join Manila coastal cleanup drive

who concurrently serves as Chairperson of the GPPB, described procurement as "an essential part of any government institution and can even be the deciding factor in the delivery of the agency's service to the public."

The DBM Secretary, addition, underscored three characteristics of sound procurement." "First, it ensures the efficient implementation of government programs. Second, proper procurement can generate savings for an institutionsomething very important considering our limited fiscal space due to the pandemic . . . Third, proper and transparent procurement also contributes to trust in government institutions and the administration."

To exemplify the advantages of proper procurement, Sec. Pangandaman

cited the procurement during the tenure of former DBM Secretary Benjamin E. Diokno. "If I may toot my own horn, under the capable leadership of then DBM secretary Diokno, we reported procurement savings of Php18.3 billion in 2018, which we were able to compute by comparing actual award costs with the approved budget of the contract or project cost estimates for foreign-assisted projects."

Section 26 of the Republic Act 6657, requires the ARBs who were awarded lands to pay to the Land Bank of the Philippines in 30 annual amortizations at six percent

interest per annum.

Marcos said that under the proposed law, the loans of ARBs with unpaid amortization and interest shall be condoned and erase the outstanding debts of the farmers who are beneficiaries of agrarian reform.

"ARBs who are still to receive their awarded lands under the CARP shall receive it without obligation to pay any amortization," Marcos said. (DAR)

Rollback, not increase

Consumers have been paying excess charges for so long and deserve a reimbursement rather than the 'temporary' price increases that SMC had sought with the ERC.

Instead of increases in the contracted price in its power supply agreements due to "change in circumstances," San Miguel Corp. may have to reimburse consumers as a result of a 2019 Supreme Court ruling.

In the review of PSAs amid the claim of the corporate empire's energy arm SMC Global Power of massive losses, the consumer alliance Power for People found 120 existing contracts that did not comply with the High Court ruling that essentially required the competitive selection process on all deals.

At least 33 of the biggest of the 120 deficient PSAs are owned by SMC.

Several PSAs are now under scrutiny for violating the SC decision in the Alyansa para sa Bagong Pilipinas Inc. vs Energy Regulatory Commission case.

The tribunal cited these PSAs did not follow procedures under the CSP requirements.

The relevant portion of the High Court's ruling stated "all Power Supply Agreement applications submitted by Distribution Utilities to the Energy Regulatory Commission on or after 30 June 2015 shall comply with the Competitive Selection Process" in accordance with Department of Energy Circular DC 2018-02-0003 (2018 DoE Circular) and its Annex A.

Moreover, the SC required that electricity rates be adjusted once the proper process is observed.

"Upon compliance with the Competitive Selection Process, the power purchase cost resulting from such compliance shall retroact to the date of effectivity of the complying Power Supply Agreement, but in no case earlier than 30 June 2015, for purposes of passing on the power purchase cost to consumers," the SC ruled.

In a recent meeting with ERC officials, P4P identified among the invalid PSAs that remain active the one between Zamboanga City Electric Cooperative and San Miguel Consolidated Power Corp., which contributes to 62.7 percent of Zamboanga City's

In that particular deal, SMC Global Power charged P10.57/ kilowatt-hour in August, which is way above the average billing

Most of the PSAs that the SC ruling cited were found to be uncompetitive and expensive.

Distribution utilities are still purchasing electricity from generation companies under at least 28 PSAs that were ordered to comply with the CSP requirement under the SC decision, which according to consumer groups has greatly contributed to the astronomical prices of electricity outside Metro Manila.

What the SC ruling boils down to is that the consumers have been paying excess charges for so long and deserve a reimbursement rather than the "temporary" price increases that SMC had sought with the ERC.



PBBM bent on transforming economy, making food affordable to avert future crises

MANILA -- President Ferdinand 2022," he told Gonzaga. "Bongbong" Marcos Jr. on Tuesday, September 13, said his administration is geared towards economic transformation to shield the country from future crises in the aftermath of the coronavirus pandemic.

Social protection, human capital dev't top priorities in PDP

QUEZON CITY --Social protection and human capital development will be among top priorities in the short to medium term under the upcoming Philippine Development Plan (PDP) 2023-2028, according to the National Economic and Development Authority (NEDA). In his keynote speech at the kickoff ceremony of the 8th Annual Public Policy Conference (APPC) Tuesday, NEDA Secretary Arsenio Balisacan recognized that inadequate policies for social protection and human capital development remained a challenge that contributed to the worsening of poverty in the past two years under the COVID-19 pandemic.

"The unprecedented scale of the health and economic crisis, coupled with policy response challenges, caused such an increase in our poverty incidence. Socioeconomic scarring in health and educationmade worse by the poor's limited access to adequate healthcare as well as tools for remote learningis expected to linger if it is not remedied. This is compounded by the poor's vulnerability to environmental shocks and the lack of social protection that can cushion the impact of such shocks," said Balisacan.

Balisacan said the upcoming PDP 2023-2028 to be crafted by NEDA will holistically identify strategies that seek to address these inadequacies.

He added the PDP, which will flesh out the Marcos administration's 8-point Socioeconomic Agenda, aims to reinvigorate poverty reduction and job creation by guiding the economy toward a high-growth path and develop a resilient, inclusive and prosperous society.

To achieve this, Balisacan said the PDP's near-term goals will focus on improving areas related to social protection and human capital development, such as raising the purchasing power of Filipino families and reducing the harmful effects of COVID-19 on vulnerable segments of the population.

"In the near term, we must protect the purchasing power of families, mitigate the socioeconomic scarring caused by the Covid-19 pandemic, and reduce the vulnerability of the poor and marginalized sectors, all while ensuring sound macroeconomic fundamentals through efficient government processes," he said.

Balisacan addressing the socioeconomic inequities and improving access

The meeting pooled together the 15 members of the board to set out the guidelines and parameters within which the body will operate towards regulating procurement by all government agencies.
